

WASHINGTON (UPI)-Everybody talks about traffic safety — even the President. But it is mostly up to the states to do something about it. President Kennedy, who has

The states are giving the subject increasing attention. For example, figures supplied by the National Highway Users Conference show 25 states enacted legislation in 1961 strengthening standards for motor car equipment.

Seven states - Georgia, Kansas, Montana, Nevada, Oregon. Utah and Washington - tightened licensing laws to require that driver applicants submit their driving records in their last state or residence.

Though no states enacted new vehicle inspection laws, five took it under study.

Oklahoma and New Hampshire set up departments specifically concerned with safety.

Eight states put laws on their books relating to driver education and restricted licenses for drivers under 18. The trend in almost every instance was toward requiring completion of a driver educa tion course before licensing. Three states made it tougher on drivers who drink by enacting chemical test laws. Five others strengthened their existing laws. Five states upped the minimum insurance coverage its drivers



In that hearing, without a jury, Judge Ledbetter, in effect, actually made no ruling, in that he denied Lea-County Co-op their injunction and denied the City of Plains their request of a summary judgement forcing Lea County Co-op to suspend operations within the municipal limits of Plains.






