Cooper Reports Budding School As Big Success

The annual Eastland County pecan budding school was a good success at Cisco Junior College last Tuesday, County Agent J. M. Cooper reported. A total of 83 persons from 14 counties registered and participated in the all-day program.

The program opened at 9 a. m. with Mr. Cooper lecturing on when, where and how to bud pecan trees, types of budwood, forcing the buds, the difference between budding and grafting and other features.

After eating lunch in the school cafeteria, the group went to the Kent Word farm on the Leon River south of Cisco where practice budding was carried out. A supply of cold storage pecan budwood was on hand for distribution to the visitors.

Mr. Cooper said the number of orchard men in attendance was the largest ever to attend one of the county schools. This was the third held in Cisco, and it was sponsored jointly by the county agent's office and the Chamber of Commerce.

A. Z. Myrick, chairman of the CofC agriculture committee, extended a welcome to the visitors.

Coastal Bermuda Is Being Machine-Sprigged Near By

Coastal bermuda appears to be steadily spreading its stolons westward.

From all indications it will become a major crop here in the peanut country within a very short period.

For example some 70 to 80 acres was planted on six farms in the Flatwood community south of Eastland this past

week.

Probably over 300 acres will be planted in the Eastland—Gorman, Desdemona area this

Coastal bermuda is a robust, tall growing, hybrid variety of bermudy grass which was developed in Georgia several

years ago.

It has larger stems, stolons, rhizomes and longer internod-

es than common bermuda. It is much leafier and somewhat more resistant to cold than common varieties of ber-

muda.

Like purebred livestock,

Coastal has the ability for
high production when given

good care.

It is a remarkable plant for responding to high fertility

levels.

Heavy fertilization seems to be the key to successful Coastal culture.

Most growers in this general area find they need about 100 lbs. of a balanced fertilizer applied when the grass is ed and then 200 to 300 lbs. of 30-0-0 applies as top dressing each growing season.

The history of Coastal goes back to 1929 when a robust tall growing bermuda plant was discovered in a Georgia field.

This plant was increased by the Georgia Coastal Plains Experiment Station at Tifton, Ga., and given the name of Tift Bermuda.

In following years, as Tift became popular in Georgia and Florida, it was crossed with several varities of common bermuda and with a bermuda variety brought from

world's largest tin smelting and processing plant.

Africa.

From these crossings over plants were grown and observed.

Of these plants, 147 selections were made for further testing.

The blue ribbon winner of these 147 strains was named Coastal Bermuda.

From a three acre planting made in 1943 which was released to the public in 1944 Coastal has spread throughout the South.

It has been at least partially responsible for the revolution in agriculture which has occured through out the cotton

The pasturage of well bred cattle on this high bred grass has made a remarkably profitable cash crop to replace King Cotton.

To encourage further trails of Coastal Bermuda within Eastland County the County A. C. P. Committee has included Coastal planting as a cost sharing practice for 1962.

To furnish further assistance in this effort the Upper Leon Soil Conservation District purchased an automatic bermuda sprigging machine for co-operators use in this area.

In addition, several contractors from adjoining counties are doing custom sprigging.

While only time will tell Coastal Bermuda seems to be well on its way to replace peanuts in this area just as it is replacing cotton in so many places of the Deep South.

In 1824 the Huaco Indians made a treaty with Stephen F. Austin. But in 1837 the Comanche Indians drove the Huacos out.

A city then grew up near the site of the Indian village and took the name Waco. Now Waco is one of the leading cities in Central Texas.

Site of the Indian village also was the site of the first crossing of the Brozos River. In 1917 the Daughters of the American Revolution reclaimed the Indian Spring at the village site and memorialized it. This spring still flows, near the west end of the old and renowned Suspension Bridge over the Brazos River. in Waco.

the "Helena Duel. Duelists' left hands, were bound together. Then the two combatants were left to settle their differences with knives held in their free hands. Hardly a game for cowards

or weaklings, this fuel! Yet it became the most popular sporting event for local enter-

Audiences and betting reached such large proportions that the recurrent winners were looked upon as local celebri-

One of the stone buildings of the early town still standsthe old two story courthouse. It is referred to as "the place where they talked things over before they lynched a man.
