Plains Volleyball Girls Upset Three-Time State Champions

The Plains Cowgirls captured the Class AA State Volleyball title in Austin Saturday by surprising the three-time defending state champion, East Bernard, 6-15, 15-11 and 15-11.

The Cowgirls met Leon-Jewett (32-0) in semi-final action and handed the Cougars their first loss of the season. Down one game, the Cowgirls rallied to win two straight 10-15, 15-6, 15-9 to advance to the championship match.

In one of the most exciting games of the entire tournament, the Cowgirls, coached by Charles Cain, and assisted by Joyce Pierce and Saundra Foster, rotated through good serves of all six players before making the final point in the last game of the championship match. Julie Culwell served what was to become the match winning serve. The ball went back and forth several times before Traci Nance spiked the ball for the last time. East Bernard

dove for the ball, but could not return it. The Cowgirls were then declared State Champions.

Finishing their season with a record of 28 wins and 10 losses, the Cowgirls had accomplished what no other Cowgirl volleyball team could in the past 14 years.

Six players from each class were named to the All-Tournament Teams. Receiving honors for Class AA were Traci Nance, Ruth Diaz and Julie Culwell.

Following the presentation of individual medals, Plains' own Superintendent Dean Andrews presented the Cowgirls with the championship trophy. Andrews is a committee member of the University Interscholastic League.


David Kight Gives Program On Beef Nutrition

The Lions Club members discussed the possibility of purchasing eye wear for junior high school students in need of glasses.



Reports were given on Holiday Gift Idea Workshop, Festive Foods Programs, and history books.


It was voted to participate in a

PLAINS I.S.D. ANNUAL PERFORMANCE REPORT

FINANCIAL CONDITION

Our school district is in excellent financial condition. Our tax rate of \$0.36 per \$100 value is considered one of the lowest in the state.

Our per pupil revenue in this district is \$8,104.86 per student. Fifty-four percent of the budget is for instruction.

IMPACT OF 1984 REFORM LEGISLATION

House Bill 72 has brought about the same changes in our school as in other districts across Texas. Our school board policies have been changed to include the new requirements.

A plan for discipline management is being developed and absence policies and extra-curricular policies are in place.

The administration felt that this year was most difficult because of inconsistent interpretations by the Texas Education Agency. We were given directives by Deputy Commissioners at area meetings only to have them repudiated by the Commissioner after the T.E.A. requirements were in place. Perfect examples of inconsistency by the Texas Education Agency were in the areas of career ladder, early dismissal, lesson planning, senior days and extra-curricular activities. These areas as mentioned have had a very negative effect on our staff.



FmHA Issues Loan Assistance

The Farmers Home Administration (FmHA) has issued new regulations which spell out, in detail, the various loan servicing alternatives which may be available to farmers who are having economic difficulty, according to Texas FmHA state director J. Lynn Futch.

The servicing alternatives available to eligible borrowers include a deferral of a portion of payments for five years, reamortizing payments over a longer period of time, restructuring the debt, or subordinating FmHA's lien position on security to another lender.

The regulations spell out how FmHA determines eligibility for various loan servicing alternatives and under what circumstances FmHA would propose to take steps to resolve delinquency or other problems.

Borrower's appeal rights are detailed as well as FmHA's agreement to continue the release of sales proceeds until final loan servicing has been determined.

The new procedures were developed to give FmHA borrowers with delinquent and problem loans clear, consistent and predictable guidelines on how their accounts will be serviced by the agency," Futch said.




