Spears and his brother, Don, started out together in 1960 in the pump business in Tahoka. A year later, Jack sold his interest to his brother and purchased his first drilling rig. As a souvenir of his beginning, he still has a copy of the note he made Jan. 3, 1961 at Wilson State Bank.
Spears' first well in Yoakum County was a six inch irrigation well on a half section he purchased in 1966. Moving to Plains, he began farming and drilling water wells.

His first experience came during summers and holidays while he was attending school at Wilson High School. He worked with Dave Flowers, driller from Tahoka. He credits Flowers with teaching him a lot about the business and says it, was then he began thinking of drilling as a career.
"About 23 years ago, I had twisted off in the hole and lost the rear end out of my truck, all in one day" he recalls. "Very upset, a farmer by the name of Hy Turner came by. He told me to just get away from the problem for awhile, so I could calm down and he reminded me to never let circumstances upset me that badly. I learned a lesson from that man,' says Jack. Now, when things are upsetting, he gets away for a time and things seem to always work out.
Spears and his wife, Maggie, are parents of four children. Tessa is married to Doran Smith and lives in Sedan, Ks. She is the mother of their only grandchild, two-year-old Kessa. Terrie, Billy and Johnny are Plains High School students.
The Spears children have always helped with farm work and the boys began helping their father in the drilling business as soon as they were old enough. Both enjoy the work.

ITALIAN CREAM CAKE
2 c sugar
1 stk softened oleo
$1 / 2$ c Crisco
2 c flour
1 c buttermilk
1 t soda
2 c coconut
1 c pecans
5 eggs, separated
1 t vanilla
Cream sugar and egg yolks and add oleo. Add other ingredients. Fold in beaten egg whites. Bake in 3 layers at $350^{\circ} 30-35$ mins. Allow cake to cool and ice with Italian Cream Icing.
ITALIAN CREAM ICING
8 oz pkg cream cheese
$1 / 2$ stk oleo
1 box or 2 c powdered sugar
1 t vanilla
Spread icing between layers and on top and sides of cake to keep moist.

Rub roast with salt and pepper, then liquid smoke. Wrap in foil and refrigerate overnight. 1 t cinnamon

1 c pecans
Melt oleo and pour over dates. Add other ingredients and mix well. Pour into a floured loaf pan. Bake at $350^{\circ}$ for 50 mins. or until done.

1 c sugar
$1 / 2$ c shortening
2 eggs
1 square melted chocolate
$1 / 4$ c milk
$1 / 2$ c flour
$1 / 2 \mathrm{t}$ salt
1 t vanilla
Cream shortening and sugar until fluffy. Add eggs and beat well. Add melted chocolate. Add dry ingredients and milk alternately. Add vanilla and nuts, if desired. Cook in a square pan at $350^{\circ}$ for $20-30$ mins.

## Company Formed To Aid Farmers

A new company, Intelligent Decisions Incorporated, has been formed to help farmers both make business decisions and negotiate operating loans.

Intelligent Decisions Inc. has been designated by IBM as a Value Added Dealer to sell IBM personal computers along with the specialized software and training that the company has developed for improved record keeping and decisions analysis. According to Mr. Cox, "The current tight financial times faced by farming in general are actually favorable times for farmers to invest in the IDI system. Salary adjustments were approved for Lorraine Walker, Scott Nichols and Dan Beck.
The court also set the extra hire maximum rate for 1986 at $\$ 7.75$ per hour, clerical; $\$ 6.75$, road hands; and 20 and a half cents per mile for out-of-county travel. A three percent raise for all regular full time employees and officials was allowed, providing any adjustment necessary to restructure fringe benefits to be in compliance with the new Federal regulations.

## Free Counseling

## Is Available

Effective year-round management of spending and credit use can keep consumers from being overloaded with debt. Yet some people find themselves in financial trouble from uncontrolled credit spending over the holidays. If you're facing a financial crisis from credit spending, there are services which can help you work out a plan for getting out of debt, says family economics expert Dr. Marjorie Smith. As part of these services, a counselor studies your financial situation and makes suggestions for more effective money management, explains the Texas A\&M University Agricultural Extension Service home economist. For example, the consumer Credit Counseling Service is a non-profit agency which does not charge clients for their services, notes Smith. They have offices in some Texas cities and suburbs which can be located by looking in the phone book. Other types of credit counseling may be available through churches and volunteer groups, banks and savings and loan associations in your local area. If you belong to a credit union, it may offer some counseling services as well, she adds.

1. Texas School Districts offer a $\$ 5,000$ residence homestead exemption off of appraised value, and additional exemptions to persons who are over 65 or disabled.
2. Yoakum County offers a $\$ 3,000$ homestead exemption off of appraised value on the Farm to Market and Lateral Road Fund, and a $\$ 25,000$ exemption off of appraised value to persons who are over 65.
3. The City of Plains and City of Denver City both offer exemptions to persons who are over 65. 4. All taxing units offer an exemption for certain service connected disabled veterans on one designated property. Surviving unmarried spouses are also entitled to these exemptions of a deceased veteran or a surviving minor child.
4. A mobile home owner must now provide a copy of a title issued by the Texas Department of Labor and Standards together with the residence homestead exemption in order to qualify for a residence homestead exemption.
5. If you received a residence homestead or diabled veterans exemption on your present property in 1985, it will not be necessary to make a new application for 1986 unless you receive a written request in the mail from the appraisal office. If you were at least 65 years of age or disabled on January 1, 1986 and have not previously filed for the over 65 or disability homestead exemption, you will need to make application by April 1, 1986. Or, if you have never received a residence homestead exemption on your present homestead, an original application must be filed with the appraisal office on or before April 1, 1986.

All exemptions not previously granted, must be filed on or before April 1, 1986.

## LAND PRODUCTIVITY VALUATION:

If your acreage was appraised based on productivity for 1985, it will not be necessary to file a new application for 1986 unless you receive written request in the mail from this office.

RENDITIONS:
Business Personal Property renditions are mandatory according to State Law. Real Property renditions are an option available to owners of real property.

## Plan Now For 1986 Fertilizer Needs

Farmers should not wait until next spring to begin planning their crop fertilization programs.
By collecting soil samples now and having them tested, crop producers can jump.on next year's production, says David Kight, county agent with the Texas Agricultural Extension Service.
Testing soils this fall offers several advantages: (1)Samples can be collected after harvest when seasonal work loads decrease and production problem areas in fields can be identified more easily for specific sampling. (2)Farmers can avoid the typical spring rush in the Soil Testing Laboratory. (3)Test results will be back in time to purchase needed fertilizer when costs are at a low point instead of waiting
until spring when prices will likely be somewhat higher.
During these economically stressed times, it is a natural tendency to want to reduce production costs by reducing or eliminating fertilizer usage, says Kight. However, it is not wise to make such a major decision without the benefit of a soil test. If a soil test indicates that fertilizer is needed to attain a desired yield goal, its use is strongly recommended.
To help the crop producer monitor carry-over nitrogen levels in the soil, the Texas Agricultural Extension Service Soil Testing Laboratories at College Station and Lubbock are routinely analyzing soils for nitrate nitrogen. This analysis determines the amount of available nitrogen present in the soil
which is then subtracted from the amount of nitrogen required to reach a desired yield goal. This reduced nitrogen recommendation results in a direct savings to the producer without sacrificing yield.
A soil test will also determine which nutrients other than nitrogen are deficient in the soil for a particular crop so the producer can fertilize to supplement the soil supply. Kight emphasizes that it's only profitable to supply nutrients required
and in sufficient quantities for a specific crop.
There is no substitute for knowing what your soil bank nutrient balance is as you start planning next year's cropping programs.

Soil testing can provide an economical means of determining your soil's nutrient status and can help you make those major economic decisions with greater confidence. For Soil Test guidelines and collection bags, come by the County Extension Office.
