## Payment Limitations

## Directive To Be Issued

S.M. True, president of the Texas Farm Bureau, said he had been assured by USDA officials that a new directive on payment limitation would give relief to farm operators.
Under the 1985 farm bill, there is a $\$ 50,000$ payment limit per farm. Stricter interpretations this year by USDA had jeopardized some farmers who have certain business ties with close relatives.
True and Vernie Glasson, TFB director of public affairs, met Wednesday, March 25, in Washington with USDA officials to request that the interpretations be softened to give relief.
'Farm Bureau is not seeking relief for those who may be purposely subverting the intent of the law," True told the officials. "However, USDA's attempt to clamp down on abuses is causing serious concern for many legitimate farmers."
The Farm Bureau leaders cited several actual examples that have been in question. In each case, the USDA officials assured them that the payment eligibility would not be affected, True said.
These examples are: "(1) Cases where health problems resulted in disability of a father during a crop year. The father and son operate with their own financing, separate equipment, on separate farms. Due to the father's health problems (such as a heart attack), the son has to finish the crop.
"(2) Cases where father and son have separate operations and because of weather problems one of their farms dries up earlier and both operators plant the crop on that farm and then move over to the other farm to plant that crop.
"(3) Cases where two brothers have separate bulk fuel tanks and one brother uses his truck's fuel tank to transfer his brother's fuel to his brother's tractor."


The TFB president also cited a personal example in which he and his brother had helped one another for over 30 years in putting in crops or harvesting crops as family members helping family members, yet having separate farm operations, separate financing and a minimal sharing of equipment.

The USDA officials assured True that both he and his brother will continue to be eligible for separate payment limitations.

The problems with interpretations surfaced in early March during the state ASCS committee meeting in San Antonio. Many producers have contacted the TFB on the matter

## From The Superintendent's Desk

This past week I had the opportunity to attend the National School Board Convention in San Francisco, California, with board members Jack Palmer, Melvin Lowrey, Eddie Earnest, Edwin Livengood, Ty Earl Powell and Jack Spears.

The underlying theme of the conference was the attitude that public education in the United States must survive irregardless of the cost. It was pointed out by Secretary of Education William Bennett that many other countries were so divided in their education efforts that they would never develop into a world power with which we would have to contend for survival.

What I see from the meeting is an overall picture that public education where all people learn to live with each other, respect others' rights and work for a common goal, is the lifeline of this country. If the cost of public education should become so high that private education became the way of life then you would see schools only for blacks, schools only for whites and schools only for brown, with special emphasis on each cultural interest which would divide and split the interest of the American people.

My final thoughts on this matter are that public education in America is the best bargain and insurance that can be bought. We in Plains are very fortunate for the many good teachers working every day with the students of our school. Hard Luck Plagues Cowboys In Monahans Sandhill Relays

Plains Cowboys brought home the runner-up trophy last week in the Sandhill Relays in Monahans, finishing with 92 points back of Buena Vista's 94. A bit of hard luck made the difference.
Posting the second fastest time in the prelims in the 400 meter relay, the Cowboys missed a hand-off and did not finish the event. Jeff Ashburn fell in the finals of the 300 hurdles.

Bryan Baldwin ran his best times in both hurdles and turned in a great leg on the 1600 meter relay as did Mike Diaz who also captured the 400 meter dash. Henry Gonzales had his finest day as a Cowboy runner.
Diaz won the 400 dash with a 54.8 performance. Gonzales took the 1600 meter win with $4: 59$ clocked. He was fourth in the 800 with 2:12.7.

Joe Rivera came in second in the 1600 with 5:01.8 and third in the 3200 with 11:33.4. Roger Rivas came in fifth in the 1600 and 3200 with $5: 10.6$ and $11: 42.5$, respectively.

In the 200 meter dash, Alex Barrientes finished third with 24.5 and a tie with Martin Barrientes for third in pole vault with 10'. Baldwin was third in the 110 and 300 hurdles with 15.6 and 42.6 , respectively. He was also third in high jump with $5^{\prime} 6^{\prime \prime}$. Shawn Booth came in sixth in the 400 meter dash with 57.6 ; Don Booth was fifth in the 800 with $2: 16.7$. Chad Guetersloh was fourth in the 3200 with 11:39.4. Billy Spears finished sixth in discus with 118'6'.

The 1600 meter relay team placed fourth with a combined 3:45.8. Runners and their times were Diaz, 54.8; S. Booth, 57.7; Rivera, 57.6 and Baldwin, 53.9.

Other teams competing in the meet were McCamey, third with 79 points; Grand Falls, 76; Sanderson, 64; Wink, 36; Marathon, 32; Monahans JV, 24; Van Horn, 17; Marfa, 6; Valentine, 5 and West Texas Children's Home, 0.
