## Speed Zones Established, **Violators Will Be Fined**

Motorists are cautioned to take note of recent action by the City Council designating maximum rate of speed for motor vehicles, allowing speed zones and providing penalty for persons violating those limits.

Council members studied a survey made from Feb. 18 to March 9 by the State Department of Highways and Public Transportation before determining the new speed zones on U.S. 380 and 82 through the city.

Speed zone signs will be erected in the near future by the State. Violations of the speed limits could result in fines of not less than ten nor more than two hundred dollars.

The speed zones established include all of that portion of U.S. 82, 10th Street, within the city of Plains with limitations set at:

bound traffic shall be 35 MPH for a distance of 0.516 miles to the point of intersection with Avenue J; thence 40 MPH for a distance of 0.407 miles to the east City Limit, this point being approximately 13 feet east of the centerline of S.H. 214.



On this 10th day of May, 1988, at a regular meeting of the City Council of the City of PLAINS, Texas, among other things, there was considered by the Council a survey of speed of motor vehicles made by the State Department of Highways and Public Transportation of the State of Texas on or about the period between February 18, 1988 and March 9, 1988, inclusive, within the City of PLAINS, Texas, and which was presented to the Council for discussion, along with maps, charts and figures of such survey and together with recommendations and proposals as to the adoption of speed zones on U.S. 82 and U.S. 380 in and through said City; and

WHEREAS, the City Council of the City of PLAINS, Texas, by appropriate actions has adopted such speed zone plan of regulating the speed of motor vehicles on the highways in the City of PLAINS, as presented and outlined in such survey, with certain modifications, and has on this date made and passed an ordinance regulating the same;



If a cord or plug gets warm, it's overloaded.

#### Here's what you need to do:

- Discard damaged extension cords (even slightly damaged ones).
- · Use only extension cords designed for outdoor use for electrical needs outside. Don't overload circuits.
- Keep appliances and motors clean and in good working order.
- Don't leave appliances such as clothes dryers running when you're away from home.
- All appliances and extension cords should carry the mark of a recognized testing facility, such as Underwriters Laboratories.

#### From The Superintendent's Desk Dean Andrews

During the past several weeks I have written many articles for this column addressing my thoughts and concerns on the Edgewood vs Kirby law suit.

The facts remain the same in that Judge Harley Clark has ruled that the funding of Texas Public Schools is unconstitutional in its present form. This suit was brought against the State of Texas by the Edgewood Independent School District and sixty-seven plaintiff intervenors. Judge Clark has stated that every child in Texas must have absolute equity in regards to taxable wealth.

This case has now been heard by the state appellate court in Austin, Texas. A decision will be handed down on June 6th, or shortly thereafter. I feel that if the appellate court upholds the lower level court, then the defendants (State of Texas) will appeal to the Texas Supreme Court.

Time and time again in speeches across the state, Judge Clark has given three solutions to this issue and none are good for Plains I.S.D. The three possible solutions are: Place a cap on all school district expenditures per student across the state (\$3,600.00); Consolidate districts so that each district in Texas is the same size and same wealth; Approve a constitutional amendment so that the language in the constitution would eliminate the interpretation that education is a fundamental right as set forth in the State Constitution.

As an individual looking at the problem with as much compassion as I can generate, it seems that some common sense should come into focus. Expert witnesses have testified before the courts that Texas has one of the more equitable systems in the nation. The plan has just been underfunded since H.B. 72 was passed in 1985.

In conclusion, I predict that the appellate court will override the lower court decision and determine that equitable access to funds for all schools should refer to substantial funds and that the upper five percent (wealthy) and lower five percent (poor) of schools should be removed from consideration and handled on an individual basis. This in itself will constitute a change in funding for Texas Public Schools and would definitely be the best solution to the problem for Plains I.S.D. I do ask that you remember that the above is my opinion only and if I had all the answers to our state's education problems, they would want me in Austin immediately.






#### SHAWNA BOX Second Grader Wins Color Contest




Yoakum County Commissioners' Court convened in special session Monday with all members present. Report of taxes collected for

**ORDINANCE 87** 

AN ORDINANCE FIXING THE MAXIMUM RATE OF SPEED FOR MOTOR VEHICLES; ALLOWING FOR SPEED ZONES; PRO-VIDING FOR PENALTY; AND DECLARING AN EMERGENCY.

WHEREAS, the City Council of the City of PLAINS, Texas, upon the basis of engineering and traffic investigation, find it necessary to establish maximum speed limits, and create speed zones in certain areas all within the Corporate Limits of the City of PLAINS, Texas.

WHEREAS, the City Council of the City of PLAINS, Texas, also finds it is necessary to immediate preservation of the public health and safety to provide for the immediate enactment of such measures, constituting an emergency;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PLAINS, TEXAS;

SECTION I. Subsection (A). Speed restrictions. It shall hereafter be unlawful for any person to drive or operate a motor vehicle upon any street, roadway or highway in the City Limits of the City of PLAINS, Texas, at a speed greater than is reasonable and prudent under the conditions then existing, having regard to the actual and potential hazards when approaching and crossing an intersection or a railway grade crossing, when approaching and going around a curve, when approaching a hill crest, when traveling upon any narrow or winding roadway, or when special hazard exists with respect to pedestrians or other traffice or by reason of weather or highway conditions; and in every event, speed shall be so controlled as may be necessary to avoid colliding with any person, vehicle or other conveyance on or entering the highway in compliance with legal requirements and the duty of all persons to use due care.

Subsection (B). Where no special hazard exists that requires lower speed for compliance with Subsection I (A) of this Section, the speed of any vehicle not in excess of the limits specified in this Subsection or established as hereinafter authorized shall be unlawful, but any speed in excess of the limits specified in this Subsection or established as hereinafter authorized shall be prima facie evidence that the speed is not reasonable or prudent and that it is unlawful:

The speed zones established by this Ordinance shall include all of that portion of U.S. 82, 10th Street, within the City of PLAINS, Texas; the maximum legal speed shall be as follows:

Beginning at the west right of way line of Avenue A, at the West City Limit, the maximum legal speed for eastbound and westbound traffic shall be 45 MPH for a distance of 0.154 mile to the intersection with U.S. 380.

And all Ordinances and parts of Ordinances in conflict herewith are hereby repealed.

The speed zones established by this Ordinance shall include all of that portion of U.S. 82-380 within the City of Plains, Texas; the maximum legal speed shall be as follows:

Beginning 0.154 mile east of the west right of way line of Avenue A at the West City Limit, the maximum legal speed for eastbound and west bound traffice shall be 35 MPH for a distance of 0.516 mile to the point of intersection with Avenue J; thence 40 MPH for a distance of 0.407 mile to the East City Limit, this point being approximately 13 feet east of the centerline of S.H. 214.

And all Ordinances and parts of Ordinances in conflict herewith are hereby repealed.

The speed zones established by this Ordinance shall include all of the portion of U.S. 380 within the City of PLAINS, Texas, the maximum legal speed shall be as follows:

Beginning at the west right of way line of Avenue A, at the West City Limit, the maximum legal speed for eastbound and westbound traffic shall be 45 MPH for a distance of 0.168 mile to the point of intersection with U.S. 82.

And all Ordinances and parts of Ordinances in conflict herewith are hereby repealed.

SECTION II. Any person violating any of the provisions of this Ordinance shall, upon conviction thereof, be fined in any sum not less than Ten (\$10.00) nor more than Two Hundred (\$200.00) Dollars.

SECTION III. That the hazards and dangers to public health and safety create a necessity requiring all rules providing that no Ordinance shall be finally passed on the day of its introduction be suspended; and this Ordinance is declared to be an emergency measure, to take effect from and after the date of its first publication.

AND SO IT IS ORDERED.
