Oklahoma Traffic Accident Claims Glenn Morehouse

Services for Glenn Morehouse, 81, were held at 2 p.m. Friday in the First Baptist Church of Brownfield with the Rev. E.K. Shepherd Sr., adult minister of First Baptist Church of Brownfield, and the Rev. Ken Horn, minister of First Baptist Church of Plains, officiating.

Also officiating was the Rev. Kenneth Peterson, minister of the First Methodist Church of Plains.

Masonic graveside rites were held in Terry County Memorial cemetery under the direction of Brownfield Funeral Home.

Morehouse died Sunday on Interstate 44 in Oklahoma City, Okla. after being hit by a tractor-trailer.

According to published reports, Morehouse and Timothy T. Warpula of Stillwater were standing outside their cars discussing a previous accident when the truck hit an ice patch and left 93 feet of skid marks before striking Morehouse's car.

The truck then hit Morehouse and knocked him into the right rear bumper of Warpula's car. The truck then hit Warpula's car and dragged Morehouse 69 feet.

His wife, Ottie, was injured in the accident and was taken to Baptist Medical Center in Oklahoma City. As of Monday, she was listed in stable condition with three broken

He was born Dec. 18, 1907, in Bristol, S.D. He became a rodeo cowboy, competing in the U.S., Canada and Mexico for 14 years. In 1934, he participated in a championship rodeo tour "command performance" before the Queen of England. He was cattle foreman for Gene Autry on the championship rodeo tour for a number of years.

In 1941, he entered the Army Air Force and served with the 314th bomber wing in the South Pacific Theater. He was discharged on Thanksgiving Day in 1945.

He came from Spokane, Wash., to Plains for a visit and decided to make it his home. Morehouse helped to organize the Yoakum County Livestock Association and the Yoakum County Roping Club, and served as secretary for both organizations.

He worked as a butcher and school bus driver for several years. He was the first farm bureau agent in the county. In 1952, he and Rust McGinty opened Tri-County Feed, the first feed store in Yoakum

He was working as an inspector for FHA in Dumas when he married Ottie Price McCutcheon on July 6, 1965, and moved back to Plains in 1966. He then worked as a butcher for the Ford Hawkins Food Market until becoming the Yoakum Veterans Services Officer in 1978. he retired in 1983.
