Plains fans had the greatest distance to travel and the largest cheering section at any game, including the match against the host. All of the girls appreciate all the love and support they received.

The Junior League's first game was Friday, May 19 at 2:15 p.m. Plains defeated Crowell in the first round 47-10. High point girl was Robin Squyres with 21; Tessa St. Romain scored 10; and Kyley Bearden, 6. The game was played in 100 degree temperature in a gym that had no air-conditioning.

The Major League drew a bye and did not play until 7:15 p.m. Friday night. Plains was defeated by their host Chillicothe, 31-23. Bellen Coronado scored 8 points and Amber Bryan scored 4 in their losing game.

The Junior League met Chillicothe in the second round at 8 a.m. Saturday. Plains thumped their host 48-17. Robin Squyres and Kyley Bearden each scored 15 points to lead the team to victory. Shyloh Winn added 8 points and Tessa St. Romain, 6.

The Major League played Whiteface in a 9:15 a.m. game Saturday. For the second time in a week, Plains defeated Whiteface, 23-9. Amber Bryan scored 9 points to tie the opponents effort; Bellen Coronado and Stacey Jones both added 6. The Majors met Highland Park in the afternoon game. At the end of a hard-fought game, Plains came out on the short end, 24-19. Misty Willet led the scoring with 10; Jennifer Earnest scored 6. Plains Major League All-Stars finished in third place. Chillicothe went on to defeat Highland Park in the finals for first place.

In the Championship game, Plains Junior League faced some familiar faces, but the outcome was the same. Plains pulled out all the stops as they defeated the Whiteface All-Stars 50-14. Robin Squyres led her team with 28 points; Kyley Bearden scored 10 and Tessa St. Romain and Bridget Bernal each added 6.

Tony Winn, Rickey Bearden and Joel Lowe all agreed that this was the most "coachable" team they had worked with.

He was recognized for his outstanding achievement at Tech's Amarillo campus in Student Awards Day ceremonies.



From The Superintendent's Desk

Dean Andrews



Our Board of Trustees adopted a Drug-Free Schools and Communities Plan last month. Public Law 100-297 mandated that all schools in the United States would adopt such a plan.

In support of the law, Plains I.S.D. has joined with fifty-eight other school districts to form a Drug-Free Schools and Communities Cooperative sponsored by the Education Service Center, Region XVII. As a member of the cooperative, services which might otherwise have been too costly, can now be provided. These services include media support, inservice programs, curriculum materials, consultants, coordination of support services, and technical assistance to individual school districts.

Representatives from such fields as law enforcement and community and other groups with expertise in the field of drug abuse education and prevention are selected to provide coordination and to avoid duplication of efforts. Our representatives to the Regional Council are L.J. Sanders and Arlon Alexander.

Drug prevention emphasis is included in our school curriculum throughout the entire year with major emphasis, including projects and activities, during the first week of October.

As an indication of the effectiveness of the programs implemented in our schools, our objective is to reduce the number of drug-related incidences occurring in our schools, on our campuses, during any school related activity on or off campus, and in our community. Our goal is to have no student use of illicit drugs. Until this goal is realized, drug prevention programs will continue to be implemented. After the first year of implementation, the decision to continue the program or to investigate other approaches will depend upon the documentation collected by the administrators and/or the recommendation of the total staff.

1963 Plains Grad Ron Stockstill Dies In Pharr

Ron Stockstill, a 1963 graduate of Plains High School, died at his home in Pharr May 18 after a lengthy illness.

NOTICE AFFORDING THE OPPORTUNITY FOR A PUBLIC HEARING

The State Department of Highways and Public Transportation is presently planning the extension of FM 2196 in northeast Yoakum County, westward over an existing County pavement from the intersection of FM 1780 to the intersection of SH

The proposed project is approximately 12 miles long and consists of reconstructing the present 18 feet of County pavement into 30 feet of asphalt surface with 24 feet of travel lane and 3 feet of paved shoulders. Presently Yoakum County has 80 feet of right of way and an additional 20 feet of right of way will be required along the south side only.

Although additional right of way will be required, no houses or businesses will be displaced. Information concerning benefits and services which may be available to afrected property owners as well as information about the tentative schedule for right of way acquisition and construction can be obtained from the State Department of Highways and Public Transportation office in Brownfield.

Maps and other drawings showing the proposed location and design, environmental studies and any other information about the proposed project are on file and available for inspection at the office of the resident engineer at 800 West Webb Street in Brownfield, Texas, and with the office of the Yoakum County Judge in Plains.

Any interested citizen may request that a public hearing be held covering the social, economic and environmental effects of the proposed location and design for the highway project by delivering a written request to the resident engineer's office at 800 West Webb, in Brownfield on or before June 12,

In the event such a request is received, a public hearing will be scheduled and adequate notice will be published about the date and location of the hearing. Verbal or written comments may be presented either at the hearing or submitted within 10 days afte the hearing to the resident engineer's office, P.O. Box 1147, Brownfield, Texas 79316-1147.



Plains High School seniors were honored by their parents with a hamburger cookout at the home of Sarah and David Guetersloh Friday, May 19 at 7 p.m.


Mrs. Raymond Asebedo Jr. baked a giant cake in school colors which was served along with homemade ice cream, soft drinks and chips.


