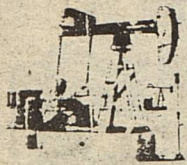

Collection Of Indian Artifacts Now On Display At Library

An extensive collection of Indian artifacts has been on display at Yoakum County Library this month. The collection was shared by Bobby Barker.

"I...like so many people...had in a drawer somewhere or in a frame on a wall, a few old arrowheads or 'something Indian'. Don't most of us claim to have an ancestor that makes us part Indian?" Barker states.

After checking his family tree, Barker says, "I found there is not enough Indian in my ancestry by Federal Law to even keep any old eagle feathers in my collection."

Barker was amazed to discover, after studying a number of library books, that the Indian arrowheads

of his collection are not Kiowa or Comanche, as he had believed, but were here thousands of years before those later tribes.

Explaining, Barker says, "In the midst of a long and forgotten past, thousands of years ago, tiny groups of hunters roamed most of North America. It has been my privilege to collect a few of the items these prehistoric Indians made and used. I also have a number of later artifacts belonging to the Apache and Zuni Indians."

"I wish to thank the staff of Yoakum County Library for their help and encouragement," adds Barker. "I thank them for allowing me to display my small collection for the fine people of this community."

Ashlee won first in the 15-17 year old division in tumbling with Ladd and Shyloh grabbing the top wins in the 13-14 and 9-10 divisions.

All three also competed in the Jr. Elite competition. Only the four top competitors in the state advance to Jr. Elite Nationals to be held July 8-9 in Santa Ana, Ca. Ashlee and Ladd both qualified to compete. Jr.

Elite has no age breakdown and competitors ages range from 8 to 18.
