

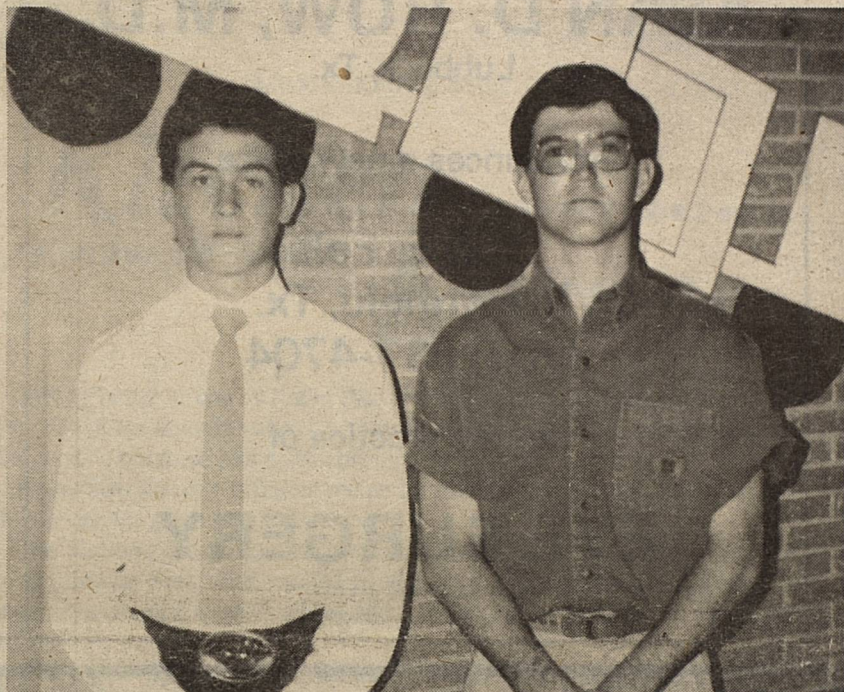

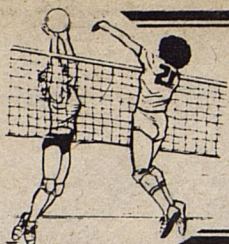

# Kitchen Korner

Baking breads is one of Kathy (Mrs. Mike) Holster's favorite pastimes. She shares one of her favorite recipes, a yeast dough made with potatoes that can be baked as rolls or turned into delectable cinnamon rolls.

Kathy also shares a different recipe for preparing vegetables into one tasty dish plus one for green chili enchiladas.

The Holsters are parents of two small sons, Scott, seven years old, is a second grader; Sean, five, started to school as a kindergartner. The family attends First Baptist Church where Mike is serving as minister of youth and music.

Kathy grew up in New Mexico and attended West Texas State University after graduating from Robertson High School. She taught junior high math three years in Tulia. Teaching children is one of her most satisfying endeavors.

At Plains, Kathy works with the pre-school filmtime program at Yoakum County Library. She also babysits in her home.

Kathy's favorite leisure-time pleasure is cross stitch embroidery. She also enjoys gardening and loves family camping.

## POTATO ROLLS

1 c water  
1 medium potato, peeled and grated  
1 c milk, scalded  
1/4 c honey  
1/3 c oil  
1 T salt  
1/4 c warm water  
1 pkg dry yeast  
5 to 6 c flour or 3 c whole wheat flour  
remainder white flour

Cook potato in 1 c of water until soft. Stir in scalded milk, honey, oil and salt. Cool to lukewarm. Sprinkle yeast into 1/4 c warm water and stir until dissolved. In large bowl, combine lukewarm milk mixture and yeast. Add 3 c flour. Beat until smooth. Stir in yeast. Add 3 c flour. Beat until smooth. Stir in enough additional flour to make a slightly stiff dough. On floured or oiled board, knead until dough is smooth and elastic. Place in greased bowl, turning to grease top. Cover; let rise in warm place until doubled in bulk. Punch dough down. Form into smooth balls. Place in greased pans. Cover, let rise in warm place until doubled in bulk. Bake at 375 degrees Fahrenheit about 15 minutes. Butter tops of rolls and bake an additional five minutes or until golden brown.

## CINNAMON ROLLS

Syrup for bottom of pan:  
1 c brown sugar  
1/4 c butter  
2 T corn syrup  
1/4 c water

Cook until sugar dissolves. Pour into greased 9x13 cake pan. Cool. Spread chopped nuts on top.

Using half of the above bread dough, roll dough in a rectangle 1-inch thick. Brush with melted butter. Sprinkle with 1 c brown sugar and 1 T cinnamon that has been well mixed. Roll from long side as for jelly roll. Seal edge. Cut into 1-inch thick slices. Place on cooled syrup in cake pan. Cover; let rise until doubled in bulk.

Bake at 375 degrees Fahrenheit for about 25 minutes or until brown. Invert rolls onto waxed paper to cool.

## VEGETABLE MEDLEY

In oblong baking dish layer sliced potatoes, sliced squash, onion slices and whole okra. Repeat layers finishing with okra for top layer. On each layer sprinkle thyme, salt, pepper, parsley and oregano. Pour 1 can Ro-Tel tomatoes over the vegetables and bake at 400 degrees Fahrenheit for 40-45 minutes.

## GREEN CHILI ENCHILADAS

1 dozen corn tortillas  
grated cheese  
1 chopped onion

1/2 lb ground meat, browned with onion

1 can cream of mushroom soup  
1 can stewed tomatoes

1 can green chiles, chopped  
1 1/2 c milk

Heat soup, tomatoes, green chiles and milk until warm. In 9x13 inch baking dish place tortillas stuffed with meat, onion, and cheese side by side. Pour liquid mixture over tortillas and bake at 350 degrees Fahrenheit for approximately 45 minutes.

### From The Superintendent's Desk

This is the third in a series of eight articles based on research entitled "What Works at Home" which I feel will be most beneficial to students if given the opportunity to participate in an organized home learning environment.

Children improve their reading ability by reading a lot. Reading achievement is directly related to the amount of reading children do in school and outside.

Independent reading increases both vocabulary and reading fluency. Unlike using workbooks and performing computer drills, reading books gives children practice in the "whole act" of reading, that is, both in discovering the meanings of individual words and in grasping the meaning of an entire story. But American children do not spend much time reading independently at school or at home. In the average elementary school, for example, children spend just 7 to 8 minutes a day reading silently. At home, half of all fifth graders spend only 4 minutes a day reading. These same children spend an average of 130 minutes a day watching television.

Research shows that the amount of leisure time spent reading is directly related to children's reading comprehension, the size of vocabularies, and the gains in their reading ability. Clearly, reading at home can be powerful supplement to classwork. Parents can encourage leisure reading by making books an important part of the home, by giving books or magazines as presents, and by encouraging visits to the local library.

Another key to promoting independent reading is making books easily available to children through classroom libraries. Children in classrooms that have libraries read more, have better attitudes about reading and make greater gains in reading comprehension than children in classrooms without libraries.

#### Exercises:

- 1) Keep showing your children how important reading is in everyday life. Let them see you use written directions for cooking, using and fixing appliances, or reading maps.
- 2) Get children interested in newspapers and magazines early. Help them find different sections that might interest them: comics, sports, movie ads. Don't overlook the classifieds for sales on items that interest them (cars, bikes, musical instruments) and for funny messages in the "Personals" column. When you look at the newspaper, sometimes let small children sit on your lap and point out letters and words.
- 3) Remember that there are lots of ways to acquire books and magazines inexpensively. Libraries are best, but don't forget garage sales, free pamphlets in stores. Watch for sales at used book stores and buy books and magazines for special treats.
- 4) Once in a while let reading, and then telling you about what was read, be a way of earning a privilege: a small treat, an excuse from doing a disliked chore, a way of avoiding punishment for doing something wrong.
- 5) Put older children in charge of getting needed information for the family. They could read about movies to help select one for a family outing, could read about locations for a family vacation, could read a magazine like Consumer Reports to find out about a radio (or some other product) the family is thinking of purchasing. They could read ads for garage sales to look for a special family need.

## Cowboys Win 42-20

The Cowboys traveled to Abernathy to take on the Memphis Cyclones in a non-district game.

Monte Pierce opened the scoring on a one-yard quarterback sneak in the first quarter. Rodney Garland's extra point kick was good.

Still in the first quarter, Mario Medina found paydirt on a 13 yard run. Garland's kick was good. First quarter score was Plains 14, Memphis 0.

Shane Lowrey scored the next Cowboy TD on a 53 yard pass from Pierce. Garland's kick was good.

Medina scored before halftime on a 17 yard run. Garland's kick was good. Halftime score stood Plains 28, Memphis 0.

Pierce found Shawn Booth open for a 42 yard scoring pass in the third quarter. Garland's kick was good and the score was Plains 35, Memphis 0.

Memphis finally got their game in gear starting the fourth quarter. Jay Runnels scored on a two yard run. The two point conversion try failed.

The Cyclones then scored on a nine yard run by Runnels. The two point conversion pass from Allan McCutchen to Finis Barker was good. The score was then Plains 35, Memphis 14.

Pierce scored the final Cowboy touchdown on a 61 yard quarterback keeper through the Cyclone defense. Garland's kick was good.

Memphis grabbed its last score on a 54 yard run by McCutchen. The two point conversion failed. The final score was Plains 42, Memphis 20.

Medina carried 14 times for 63 yards; Henry Gonzales four for 10; Pierce four for 57; Wade Redman six for 23; Tony Yeager three for 13 and Garrick Engle one for four. Total rushing yards for the Cowboys was 159.

Pierce threw 26 passes with 14 completions for 241 yards. He had one

interception. Dain Guetersloh threw five with two completions for 116 yards and one interception.

Lowrey had seven receptions for 123 yards; Booth had four for 90; Guetersloh three for 23; Brett Booth one for 16; and Medina one for 13. Total passing yardage was 257.

Leading tackles were Medina, Guetersloh and Garland. Memphis fumble recoveries were made by Medina, Lowrey and Brett Booth.

Miller, City Secretary Ruth Murphree, City Councilmen Jim Warren and Kevin Guetersloh, all of Plains.

The Court convened Monday in regular session. Line transfers in the budget were approved as was the treasurer's quarterly report.

Extra hire and disbursements on file were read and approved including hospital bills in the amount of \$76,982.72 and transfer to the hospital fund of \$75,000.

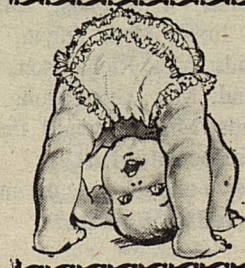

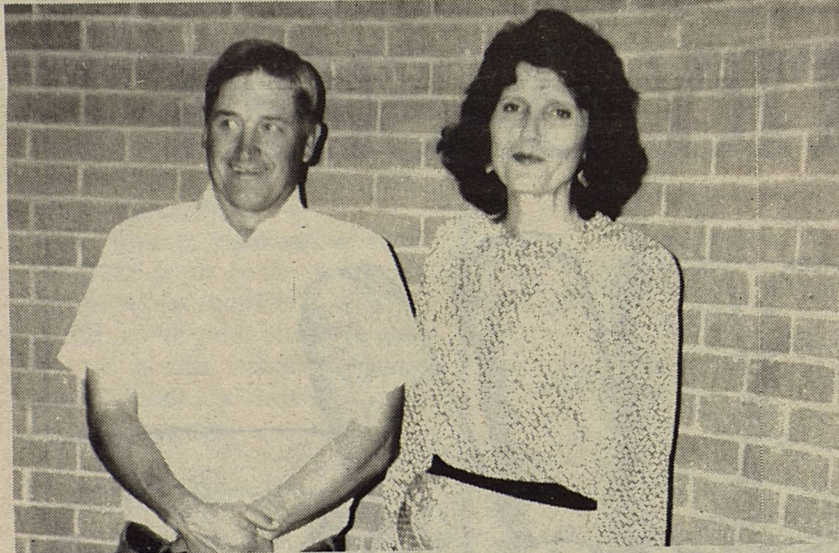

### YOUR AIR CONDITIONER AND HEAT PUMP NEED ATTENTION

Your air conditioner and heat pump, like your automobile, require maintenance to perform well without costly breakdowns. Some maintenance has to be done by a qualified serviceman, but there are certain things you can do:

1. Always cut off power at the fuse or breaker box before you start to work.
2. Filters: Keep filters clean. Clogged filters reduce airflow, causing reduced efficiency and increased energy bills. Some filters may be washed, others must be replaced. You should change or clean the filters every six weeks, more often during heavy cooling season.
3. Fan motors: If fan motors are accessible and don't have permanently oiled bearings, you should oil them periodically. Oil strictly according to the manufacturer's or serviceman's instructions. A good 10 to 20 weight oil should be carefully applied.
4. Fan belts: If the fan belts are accessible, you should inspect them at regular intervals. If a belt is frayed, worn, or seems too loose, call your serviceman.
5. Outdoor units: Certain precautions should be taken to prevent damage to the outdoor unit.
  - a. Air passage through the outdoor unit should not be obstructed in any way. If the fan cannot pull air through the coils freely, the compressor could need service.
  - b. Cut all weeds and tall grass around the unit, and don't blow grass clippings toward the unit.
  - c. Don't plant shrubs close to the air intake and outlet.
  - d. Don't allow sticks or other objects to be poked into the fan or coil housing.

We also recommend that a serviceman inspect and service your units at least once a year. By doing so, he can make all the necessary routine adjustments and service the entire system. Often he can spot minor troubles which could lead to major repair and high electric bills if left uncorrected.
