

ORDINANCE NO. 102

AN ORDINANCE MAKING IT UNLAWFUL TO MAKE A LEFT TURN OFF TENTH STREET, A ONE-WAY STREET, ONTO U.S. HIGHWAY 82-380 IN THE CITY OF PLAINS, TEXAS, AT ALL TIMES; PROVIDING FOR A FINE NOT TO EXCEED TWO HUNDRED DOLLARS (\$200.00) FOR VIOLATION; PROVIDING FOR A SEVERABILITY CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PLAINS, TEXAS:

SECTION I

That in accordance with Chapter 9, Section 2.D of the Code of Ordinances of the City of Plains, Texas authorizing the installation of traffic control devices, the following action is hereby taken:

That it shall hereafter be unlawful to make a left turn off Tenth Street, a one-way street, onto U.S. Highway 82-380 in the City of Plains, Texas at all times.

SECTION II

That all ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.

SECTION III

That it is hereby declared to be the intention of the city council that the sections, paragraphs, sentences, clauses, and phrases of this ordinance are severable and, if any phrase, clause, sentence, paragraph, or section of this ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs, and sections of this ordinance, since the same would have been enacted by the city council without the incorporation in this ordinance of any such unconstitutional phrase, clause, sentence, paragraph, or section.

What The Experts Say... Children, The Victims of Divorce?

To speak of divorce these days almost seems to be considered by many as old news, especially since the divorce rate has declined since its all time high in 1981. Even though the rate has declined, the total number increased 2% from 1987 to 1988 to almost 1.2 million. Many of these divorces involve children of all ages. It is truly mind boggling when one thinks that 50% of all children born today will spend at least part of their young life in a single parent home. Many of these children will be the victims of divorce, says Mary D. Williams, County Extension Agent, Home Economics.

Just recently, Dr. Judith Wallerstein published her second book about the 60 divorced couples and their children ten years after the divorce. Many of the children who were old enough to remember often described the events of the divorce as vividly as if it had just happened the day before.

Even though divorce is devastating for the couple, it can be overwhelming and almost unbeamable for children. The very foundation of their world - the family - is completely changed.

Regardless of the age of the child or children, divorce is a time where children tend to: 1) worry about themselves and their parents; 2) are angry and feel guilty; 3) are afraid; 4) yearn for the non custodial parent; 5) are sad, mournful and lonely; 6) feel rejected and/or abandoned; and 7) feel conflicting loyalties.

Activities among children nine to 12 years of age often increase, and for a child of a recent divorce these activities often serve to distract one's attention away from the pain and hurt. In addition, friends who become increasingly important at this age many often become a resource for comfort and an emotional outlet. This age is also a time when values begin to lock into a belief system. Children of this age were more apt to judge their parents' actions and reactions during the divorce. Anger was a dominant response

that often resulted in aggressive behavior towards other children, teachers and parents. Physical illness, such as headaches or stomachaches often developed at this time.

Adolescence, which is a time of changes and challenges, can be very stressful even for a child of an intact family, but for a child of divorce it can turbulent and complicated. Teenagers worry about who they are, what they will do in their life and will/can they establish relationships with the opposite sex that will be longlasting. The challenge of their own sexuality and dating often collides head on with that of their parents. The home that was once a station for regrouping and retooling for the next phase of development, now may provide few resources to cope with life.

If parents or society in general expect children to adjust to divorce like a cut on the hand we are sadly mistaken even ten or fifteen years after the divorce. Divorce has long lasting effects on children. The children in Wallerstein's study saw: 1) half, either their mother or father, get a second divorce; 2) half grew up in families where parents stayed angry with each other; 3) one in four experienced a serious drop in their standard of living; 4) three in five felt rejected by at least one parent; 5) very few were helped financially with college educations, even though visitation occurred.

Many of the children did well after the divorce because they had supportive relationships with either one or both parents, grandparents, step-parents, siblings or some significant other. The lack of parenting that follows the initial period after the divorce often continues because of the separation of one parent and the increased demands on the other parent.

About half of these young men and women entered adulthood with low self esteem and were underachievers. Some dropped out of high school. Some began college but many did not graduate even though they had come from families where educational achievement was highly valued.
