

# **Dependent Care Credit Requires New IRS Form**

Beginning with the 1989 returns filed next year, taxpayers claiming child or dependent care credit must identify the care provider. Form 2441 (and Schedule 1 for those filing the short form) will have space for the care provider's name, address, and identification number. If a tax-exempt organization, such as a church or charity, provides the care, you need not include an identification number. You must provide, in any case, the care provider's name and address.

Taxpayers not including this information on their returns will not be allowed to claim the dependent care credit. If you cannot provide the required information, you must show you made every effort in attempting to obtain it.

The IRS developed Form W-10 for use in obtaining dependent care provider information. You will have met your responsibility once you have obtained the form, properly completed and signed, from your care provider. There are other ways to show that you have made every effort; Form W-10 is, however, the simplest.

Taxpayers would be wise to obtain their completed Form W-10s as soon as possible. That way you protect your insurability for the dependent care credit even if your care provider moves to another location between now and the time you file your 1989 return. If your care provider does not have copies of Form W-10, your local H&R Block office, located at 314 West Main Street in Brownfield can provide them for you and answer any questions you may have about the child care credit. #### "IT'S THE PRINCIPAL OF THE THING"

In January, 1987, the State Board of Education handed down a decision making it compulsory that keyboarding be offered at the elementary level. Prior to this time, computer use by the younger students in our system was scheduled, but with no particular curriculum in place. A well defined curriculum has been developed and is being followed starting this school year.

Sixth graders will spend one semester learning keyboarding in our computer lab. Our goal is for all students to be able to type twenty words per minute. This should prepare them for computer literacy which will be taught for a full year to seventh graders in our junior high lab which is equipped with twenty Apple computers and printers.

During the year, students will learn the history of computers and the role they play in our lives. They will be introduced to basic programming, word processing, filing, spread sheets, and learn basic commands and operations.

Computer technology and applications is offered as an elective for eighth graders. This course is a continuation of computer literacy. Application of software such as word processing, data base management, spread sheet operations, and a more in depth study of basic computer language will be studied. Pascal programming language will be introduced. After completing this course, the student should be ready to perform well in any of the business related courses taught in high school.

The basic knowledge taught in the sixth and seventh grades should prepare the students to function very well in our computer oriented society today.
