Yoakum County officials Judge Dallas Brewer and Commissioners Jim Barron and John Fitzgerald shared the spotlight with some big political names as they attended the Judges' and Commissioners' Convention held March 21-23 at the Embassy Suites Hotel in Abilene. Over 600 members and guests attended the 61st Annual Convention where they also had the opportunity to listen to Ann Richards, Democratic Candidate for Governor, and Clayton Williams, Republican candidate for Governor.

Both Richards and Williams gave a rousing talk to those present in the cinema of the UA Theaters at the Mall of Abilene Friday morning. The convention turnout was so large, the forum had to be moved from the Embassy Suites across to the Mall Cinemas. It was apparent that both candidates for the office of Governor of Texas were anxious to solicit the endorsement of the majority of the county judges and commissioners in the room. Those present represented a majority of county level government in West Texas. Neither candidate directly addressed the other in remarks and the two did not meet face to face during the event. Ann Richards spoke to the group first and was gone by the time Clayton Williams arrived.

Instead of passing bills that have to be funded at the county level, lawmakers need to come up with the funding at the state level to go along with the bills they enact. Both Richards and Williams stated that they would veto such bills in the future.

Ext. Workshops To Explain Marketing Plans & Strategies

Narrow margins of earnings and wide swings in prices and income are causing farmers and lenders to take a new look at the payoff for developing marketing plans and implementing well managed marketing strategies, says an economist with the Texas Agricultural Extension Service.

To help area farmers learn more about marketing plans and strategies, the Extension Service will hold two half-day workshops April 11 in Plains and Seminole. The Extension Service economist is Dr. Jackie Smith from Lubbock.

The first meeting will be from 9 a.m. until noon in the old courthouse at Plains. The program at Seminole will be from 2 to 5 p.m. in the civic building. Speakers at both will be Dr. Carl Anderson, Extension Service cotton marketing specialist from College Station, and Smith.

If your marketing plan needs updating for the 1990 crop year, or if you've never developed a plan and want to learn more about the benefits of a more organized approach to marketing, make plans to attend one of these meetings.

Pre-registration isn't required and there is no fee for the workshops. County Extension Agents Kirk Lewis in Yoakum and David Kight in Gaines, says the programs are open to anyone

Yoakum County Extension Service is sponsoring a Chemigation/Center Pivot Technology Clinic Thursday, April 12 at 1:30 p.m. in Plains clubroom.

Extension irrigation engineer Leon New and Dr. Jim Leser, entomologist, will discuss pros and cons and legal/ environmental implications of using center pivot irrigation systems to apply pesticides.

Kirk Lewis, Yoakum County Extension Agent-Ag, invites all who plan to chemigate to attend. "Ground water contamination is currently in the minds of most citizens," says Lewis, "so we must be more cautious than ever in protecting our water supply and our privilege of using this cost-saving application technique."



Each session will begin with updates on marketing club activities by Lewis in Yoakum and Kight in Gaines counties. Smith will then discuss the use of computer spreadsheets in budgeting and breakeven analysis for dryland and irrigated cotton. These Lotus budgets will be made available to participants at the meetings.

Anderson will highlight the cotton market outlook, with special emphasis on the March '91 futures contract. He will look at historical data for March contract highs and lows and address typical problems with this contract. He will briefly discuss the technicals and review strategies for pricing 1990 cotton.



Preparing Schools For AIDS Epidemic

Texas Council of Administrators of Special Education (TCASE) is sponsoring a needs assessment conference to help school boards and school officials prepare to face an AIDS crisis when it occurs in their district. April 9 and 11 and May 4, conference attendees will have the opportunity to focus and identify the information and training needs of school staff and constituency.

"What most school districts have learned about AIDS thus far is how to panic. Many school administrators are realizing that it is not just a special education problem; they must prepare for the future," said Mike Murrow, education consultant. "All Texas school districts are urged to be represented at one of these conferences," he added.

The facilitators of this conference are Dr. Nancy Bray and Dr. Allan Bird of the University of Texas Southwestern Medical Center, Dallas, and Dr. Donna Tynan and Nancy Young of Texas Woman's University, Denton.

Bray said, in regard to the reason for such a conference, "Schools that do not become involved in planning for this epidemic either do not understand the gravity of the situation or are denying the problem."

Larry Ascough, special assistant to the Dallas Independent School District superintendent, will present a session on crisis communications. Update and guidelines will be given by staff members of the Texas Department of Health and by Carolyn Klein of the Texas Education Agency. Thomas George, Austin attorney and legal advisor to the Office of Health Communications for the University of Texas, will present a session on the laws and litigation regarding situations involving AIDS victims.

"HIV infection and AIDS are already having an impact on Texas children and school personnel. The only weapons we have at our disposal are prevention efforts through education and counseling until a cure is found,"

Tynan said, "As the incidence of pediatric AIDS increases, public institutions including our public schools will be force to come to terms with the dynamic needs which this population will present."

The conference will be held in Dallas at The Harvey Hotel at the Dallas-Fort Worth Airport on Monday, April 9; at the Marriott Greenspoint in Houston on Wednesday, April 11; and at the Marriott Riverwalk in San Antonio on May 4. For more information, contact the TCASE office at (512)


The 72-hour "Texas Day" is especially attractive this year inasmuch as it coincides with the U.S. Chamber of Commerce's annual meeting.



Voters Reminded To Get Out & Vote

Texas recorded its highest primary election turnout ever in a non-presidential year on Tuesday, March 13 when 2.3 million people cast ballots in the Democratic and Republican party primaries, Secretary of State George Bayoud said.

The turnout is believed to be the second highest total for any primary election in Texas history. The highest primary election turnout ever was in March 1988 when nearly 2.8 million Texans voted in the Democratic and Republican party presidential primaries.

This year's primary marked only the third time in Texas history that a primary election turnout exceeded 2 million voters. The turnout on March 13 represented 28 percent of the state's 8.3 million registered voters. The turnout rate is the highest for a gubernatorial primary election since 1978.

In 1986 - the last gubernatorial election year in Texas - 21 percent of the state's eligible voters turned out in the primary election, while in the 1982 gubernatorial primary a 26 percent turnout rate was recorded.

Bayoud, the state's chief elections officer, credited county election officials, the primary candidates and their political parties, and Texas businesses and civic organizations with helping to promote voter participation. He encouraged Texans to return to the polls on April 10 for the runoff elections.
