Officiating was Robert Rusher, Church of Christ minister. Funeral arrangements were by Brownfield Funeral Home.

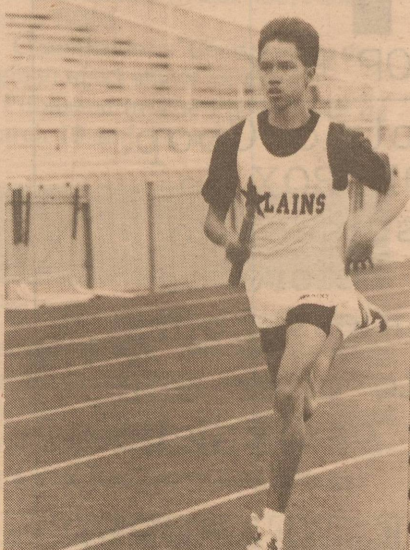
Mr. Sink died Tuesday in Brownfield Regional Medical Center after a lengthy illness.

Cowboys Capture Own Relays, Cowgirls Finish In 3rd Place

Cowboy tracksters put together a real team effort last weekend to claim the championship trophy of their own track meet. The P.H.S. Cowboys scored 149 points while winning three of four relay titles and setting a new meet and school record in the 3200 relay.

Michael Sainz turned in an outstanding performance with a 2:03.8 win in the 800 run. He also ran legs on the 3200 and 1600 relays.

Jason Smith ran three good legs on the 400, 800, and 1600 relays.

Shane Lowry was second in 100 meter dash and ran legs on the 400 and 800 relays.

Armando Ramirez won the 1600 run, placed third in the 3200 and ran a leg on the winning 3200 relay.

Jr. Lira won the 300 hurdles and finished fourth in the highs.
