**ELECTRICITY — Handle With Care**



Faulty wiring or malfunctioning electrical appliances are major causes of residential fires. About 35 percent of electrically caused fires are related to cooking equipment; 30 percent to components of the electrical distribution system including lighting equipment and cords; and about 20 percent to appliances such as clothes dryers, TVs and electric blankets. The remainder are associated with heating equipment.

**TO PREVENT ACCIDENTS**

1. Read the instructions or use and care manual before operating any electrical product and follow the recommendations.
2. Check the electrical cords and extension cords regularly for signs of damage. Repair and replace any cord which is pinched, cracked, frayed, or worn. Cords should not be run under rugs.
3. Check the fuse or circuit breaker boxes to be certain that the fuses or circuit breakers are the proper size for the house wiring.
4. Watch for trouble signs such as flickering lights, sparks from appliances, switches, or wall outlets, circuits that do not work, and switch plates and wall outlets that are warm to the touch. If any of these conditions are found, have them repaired immediately.
5. Do not use any appliance that is defective.
6. Do not leave appliances such as laundry equipment or dishwashers running when you are away from home. They could malfunction and cause a fire.
7. Overloading extension cords can cause fires. Most extension cords are not able to carry as much current as the normal house circuit without overheating so know the rating of an extension cord before you use it.

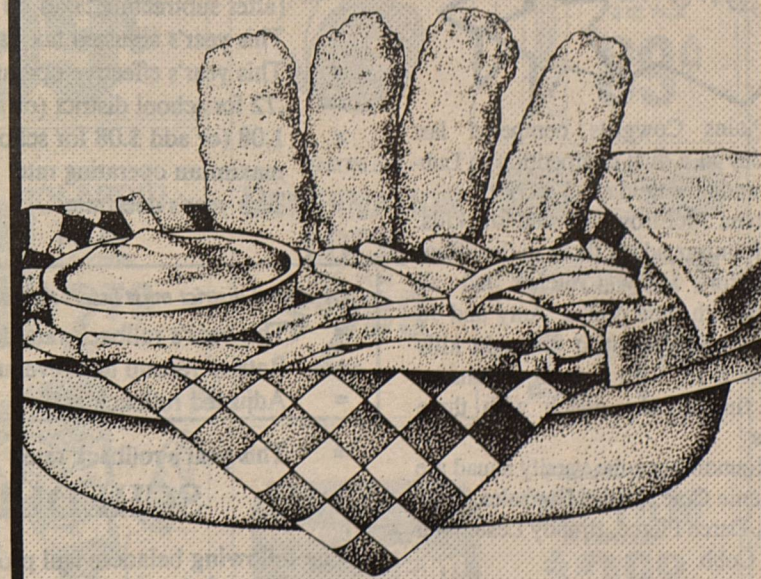

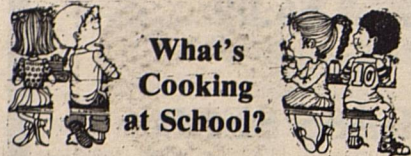

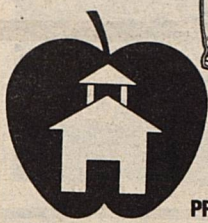

## County MH Center Offers Services

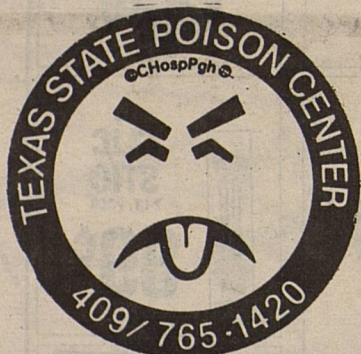
Yoakum County Mental Health Center was established in March to provide residents of the county with mental health services. The clinic provides services to help individuals with emotional conflicts and assists chronic mentally ill individuals in maintaining a functional life within the community without the need for inpatient treatment in Big Spring State Hospital.

Services include counseling, medication therapy, case management, family support, community support programs, state hospital admissions screening, education and crisis intervention. Presently there are approximately 40 active clients being served each month.

Counseling is offered adults, adolescents, children, marital, family and group situations to resolve emotional conflicts.

Fee for services are based on a sliding scale of gross annual income and family size. Private insurance, Medicare and Medicaid are accepted. Medications are 42 per prescription for an additional handling charge. No one will be refused services based on inability to pay.

Office hours are Mondays through Fridays from 8 a.m. to 12 noon and 1 to 5 p.m. After hour appointments are available upon request of client. After hour emergencies are handled through Yoakum County Sheriff's Department, Denver City Police Department or Crisis Hot Line 1-800-375-4357.

## Scholarships Available For Engineering Students

Helping to meet tomorrow's need for skilled engineers today: That's the goal of a special program that will provide \$700,000 in scholarship support this year for talented young people eager to pursue careers in engineering and science.

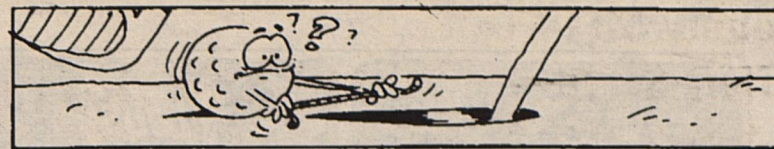
Educators say that the demand for engineers in the '90s and beyond will be overwhelming. By nurturing the next generation of scientists, researchers and engineers, the Promise Fund of New York's Polytechnic University, the second oldest technological university in the nation, makes an absolutely vital investment in the future of this nation.

Most of the Fund's awards go to women, minorities and students from low-income families, all traditionally under-represented in the engineering and science fields. Promise Fund Scholarships are distributed on the basis of financial need and academic achievement.

In addition to scholarships, the Fund provides operating money for Polytechnic's Center for Youth in Engineering and Science (YES) outreach programs. The Center was founded in 1985 to encourage high school students in New York City and Long Island to pursue an education in science or engineering. The program began as a pilot project between Polytechnic and Brooklyn Technical High School. Today, over 100 high schools and several hundred students participate in the four outreach programs: Summer Research Program, College Preview Program, Computer Outreach Program and Saturday Seminar Series.

"The Promise Fund helps ensure that young people who wish to become scientists, engineers or profes-

sionals in other technological fields are able to make those dreams come true," says Dr. George Bugliarello, president of Polytechnic.

### NOTICE TO LIVESTOCK OWNERS

ALL BRANDS AND MARKS ON TEXAS LIVESTOCK MUST BE RERECORDED WITH COUNTY CLERKS WITHIN SIX MONTHS OF AUGUST 30, 1991 ACCORDING TO ARTICLE 6899j, VERNON'S TEXAS CIVIL STATUTES. (September 2, 1991 thru February 28, 1992)

The owner shall have the right during this six-month period to file the brand and marks now recorded in his name. After this time any unrecorded brand will be available for use on a "first-come" basis.

It should be noted that it is illegal to brand livestock without first properly recording the brand with the County Clerk in the county in which the livestock are held.

When the brand or brands are recorded, the location on the animal on which the brand is to be applied must be designated. If the brand is to be applied to more than one location on the animal, it must be recorded and each additional location for the brand on the animal shall constitute a separate recording of that brand.

There is no limit to the number of brands and/or marks which may be recorded in a county by a person as long as requirements of this law governing the recording and rerecording of livestock brands are met. Minors may have marks or brands separate from that of the father or guardian, which must be recorded or rerecorded as provided by the law.

The fee for each separate recording of brand is \$5.00.
