## Cowboys Cross Country Team Wins Regional Championship

David Corrales became the first Cowboy ever to win the Regional Cross Country Meet, as an individual, Saturday, Nov. 9 at Lubbock. David - set a new school record for the regional course, breaking Armando Ramirez' 1990 record of 17:20.

David was not the only Cowboy finishing strong in the Lubbock Meet. Michael Sainz was third and Joe Valdez placed sixth, breaking the 1990 record also.

Since the top ten runners qualify for State, David, Michael and Joe al qualified for State individually and then as a team qualified to run in Georgetown at the State Meet to be held Nov. 16. The strong showing by Lenny Morrow and Jason Smith gave
the Cowboys their runaway championship. There were 116 runners that
finished the race.

Results are as follows: first place, David Corrales, 16:27; third place, Michael Sainz, 16:43; sixth, Joe Valdez, 17:07; 13th, Lenny Morrow, 17:39; 14th, Jason Smith, 17:43; and 54th, Joey Guerra, 19:31.

Regional Champion Schools were Plains, first with 33 points; second place, Texline, 80 points; and third place, Roscoe scoring 88 points.

HOT SPICED CIDER
2 qts apple cider
$1 / 3$ c sugar
$11 / 2$ t cinnamon
$1 / 2$ t cloves
Combine sugar and spices; stir into hot cider. Simmer a few minutes to blend flavors.

## RED HOT CIDER

48 oz bottle apple juice
$1 / 2 \mathrm{pkg}$ red hot candies
1 sm can frozen lemonade, undiluted
Heat juice and candies together, stirring until candy is dissolved. Add lemonade and reheat. Serve.

APRICOT SPICED PUNCH
3 c apricot nectar
3 c apple cider
1 c water
3 T sugar
3 T lemon juice
8 whole cloves
7 sticks (4") cinnamon
Combine first 6 ingredients in 3 qt saucepan; bring to boil, stirring until sugar is dissolved. Remove from heat; let stand about 2 hours. (Flavor is improved if mixture stands). Reheat and serve with cinnamon sticks. Yields: 7 cups.

## ASSAIL

1 gal apple cider, divided
1 t each clover, all spice, nutmeg and cinnamon
1 sm can frozen lemonade, undiluted
$1 / 2$ c firmly packed brown sugar

Combine 2 c apple cider and spices in large Dutch oven; bring to boil. Reduce heat and simmer 10 min utes. Add remaining cider, juices and brown sugar. Heat until very hot but do not boil. Yield: $41 / 2$ qts.

STRAWBERRY TEA
2 c boiling water
4 reg size tea bags
6 sticks cinnamon
1 t whole cloves
146 oz can pineapple juice
16 oz can frozen orange juice concentrate, undiluted
16 oz can frozen lemonade, undiluted 13 oz pkg strawberry Jell-O 2 c water

Pour 2 c boiling water over tea bags; cover. Let stand 12 minutes. Remove tea bags. Combine spices in cheesecloth bag or tea ball. Combine tea, spices and remaining ingredients in Dutch oven. Bring to boil. Cover and reduce heat, simmering 45 min utes. Remove spices and serve. Yield: 10 cups.

## HOT SPICED APRICOT TEA

10 whole cloves
2 stks whole cinnamon
3 c water
2 reg. sz tea bags
112 oz cans apricot nectar
$1 / 2$ to $3 / 4 \mathrm{c}$ sugar
$1 / 4$ to $1 / 3$ lemon juice
Combine cloves and cinnamon sticks in cheesecloth bag; set aside. Bring water to a boil in large saucepan; add tea bags. Remove from heat; comer and steep 5 minutes. Remove tea bags. Add spice mixture and remaining ingredients; bring to boil. Remove spices; serve hot. Yield: about 6 cups.

## MULLED GRAPE JUICE

1 qt grape juice
1 lemon, sliced
1 orange, sliced
2 stks cinnamon
dash ground allspice

Bendigo, Victoria, Australia was the site of the 1991 Pan Pacific Games, an invitational world tumbling and trampoline meet held Oct. 1-4.

Shyloh Winn of Plains, Cloud Tidwell of Seagraves and Sundi Pointer of Amherst along with Coach Sherry Arnwine Mulkey left for competition on Aug. 25 and returned Oct. 6 with a success story.

All three South Plains Acrospirits made finals in tumbling with Shyloh placing fifth; Cloud second; and Sundi first in their respective age groups. They also competed in trampoline and synchronized trampoline events. Each athlete was chosen to represent the American Trampoline and Tumbling Association based on national ranking and previous accomplishments. There
was a total of 38 competitors from all over the United States which made up the traveling team. The USA team dominated the tumbling by winning the Mens and Womens team trophies.

The group took tours of the surrounding cities including Melbourne which is about 150 KM from the competition site. Highlights were the Melbourne Zoo, the Botanical Gardens, a River Cruise, and Sovereign Hill.
