



Conservation District Director to serve in Zone Four (4) on the Yoakum Soil and Water Conservation District is scheduled for Oct. 7 at Johnnie's Restaurant in Plains, announced L.J. Sanders, Chairman of the Board. The election will be held at 8:00 a.m.

State law decrees that to be eligible to vote in a soil and water conservation district director election, a perthe district (county) where the election are considered owners. The person Cowboys lead by seven. must also live within the county and be 18 years of age.

Legal qualifications state that a candidate for the office of a soil and water conservation district director must own land in the zone he/she represents, be 18 years of age and be actively engaged in farming or ranching. He/she must also live in a county, all or part of which is in the district. Soil and water conservation district directors serve four-year terms of office.

Zone Four (4) of the district includes all of the northeast 1/4 of Yoakum County excluding a square six miles by six miles on the Southwest corner.

All senior students are eligible to enter the essay contest. The contest winner from each school will receive a \$1000 scholarship to the college of their choice.

The topic of the essay should relate to an elevation of the water situation in our area at the present time and contain proposals for future conservation of that water. The criteria for the contest is 1) a minimum of 1000 words; 2) typed and double spaced with footnotes or endnotes; 3) references must accompany paper in the form of a bibliography page; reference material may be acquired from the Sandy Land U.W.C.D. office located in Plains; 4) cover sheet containing: student's name, essay title, local high school and date; and 5) essays are due no later than April 12, 1993.

Information On Texas Penal Code Given By Criminal District Attorney

During the last session of the legislature, the entire Texas Penal Code was repealed effective Sept. 1, 1994. In the meantime, a 25-member group called the Texas Punishment Standards Commission has been appointed to redraft the penal laws of our state. NONE of the 25 members is a sitting prosecutor. You can expect new categories of felonies and many other farreaching changes in our criminal justice system.

One reason for this overhaul is the problem of prison overcrowding in Texas. There are currently 17,000 state prisoners being housed in county jails while awaiting transfer to the penitentiary. You might wonder how this has affected us in Yoakum County. The answer will almost certainly frustrate you as it has frustrated me. As part of the legislative overhaul in criminal frustrate you as it has frustrated me. As part of the legislative overhaul in criminal justice, the name of the prison system was changed to Texas Department of Criminal Justice of the prison system was changed to Texas Department of Criminal Justice (Institutional Division). Those folks sent Sheriff Rice a letter in late October of '91 which described a new "Allocation Formula" and "Inmate Reception Calendar". Yoakum County is allocated 12 prisoners per year. In 1991, we sent 25 prisoners to the penitentiary. This simply means that some other county did not send its calling the penitentiary about a new inmate we propose to send. Then we are given dates when the inmate can be transported and received by TDCJ (I.D.). Therefore, if our day for calling is Aug. 17 and a defendant is sentenced on Aug. 18, we will have to house the defendant in our county jail until the day rolls around for calling in September!

The Punishment Standards Commission will also be looking at our pattern of sentencing in Texas, with an eye toward "truth in sentencing". In the current situation, a jury cannot be told that a defendant never serves the number of years actually sentenced. For instance, on a 99-year sentence for aggravated sexual assault, a defendant must serve only 15 years before being eligible for parole. On a shorter sentence, such as five years, the defendants are occasionally paroled out of the county jail without ever going to the pen.

The legislature has blamed prosecutors and judges for overcrowding the prisons! Their theory is that we send too many defendants down for less than serious offenses. Because of this thinking, pressure is being placed on us to use alternatives to incarceration whenever possible. Therefore, you have probably seen that many defendants are being placed on probation. If there is a drug or alcohol problem, the defendant can go to the Court Residential Treatment Center in Brownfield as a condition of his/her proba-

tion. It is far less expensive to treat a defendant at CRTC than to send him/her to Huntsville. Also, probation has at least one advantage. A defendant rarely ever stays very long at the prison and is quickly released on parole. It has been my experience that defendants are more closely supervised on probation. This comment is not intended to be critical of the parole system. The difference may be primarily attributable to case load. We are also very fortunate to have a very conscientious staff at our Yoakum County Adult Probation Department, now known as Community Supervision and Corrections Department.

This information is provided to let you know why probation is being used in more and more cases. Until we have additional prison beds or treatment beds, fewer inmates will receive prison sentences. If you have comments on any of this information, you are urged to contact my office or our legislative representatives.

Plains 4-H Club began a new year Sept. 8. Blaine McWhirter, president presided.


Pledge of Allegiance was led by Kirk Parrish. Kelly McGinty led the 4-H motto and pledge.

Loans Available For Producers

Low interest emergency loans are available to eligible farmers and ranchers in eight West Texas Counties that were declared federal disaster areas due to excessive rain, hail, wind and cold temperatures, which occurred between May 22 and July 7, Agriculture Commissioner Rick Perry said.

In making the declaration, U.S. Secretary of Agriculture Edward Madigan named Terry County a primary disaster area.

In addition, Cochran, Dawson, Gaines, Hockley, Lubbock, Lynn and Yoakum Counties were declared contiguous disaster areas.

These declarations allow familysize farm operators in both the primary and contiguous areas to apply for emergency assistance from the Farmers Home Administration.

To be designated as a primary disaster area, the Farmers Home Administration determines whether a sufficient number of farmers in each county suffered losses of 30 percent or more. The counties designated as contiguous disaster areas were declared as such because they were adjacent to the primary disaster area but suffered fewer losses.

Each loan application will be considered on its own merits, taking into account the extent of losses, security available, repayment ability and other requirements.
