

A member of the Masonic Lodge and Order of the Eastern Star, he managed the abstract office in Plains until his retirement.





# WHAT HAVE THEY DONE TO US NOW? THE LATEST ACTIONS IN THE STATE CAPITAL

On Thursday of last week the State House of Representatives passed a Constitutional amendment. By the time you read this article, it will have been acted on and probably passed by the Senate. If the amendment is passed by the Senate and signed by the Governor, it will be put to the voters on May 1st. The amendment represents a compromise position on the school finance issue. To try to help increase your understanding of this complex issue, I would like to try to explain a little about this perplexing problem facing the citizens of Texas and some of the possible solutions.

#### Historical perspective:

Since 1949, Texas schools have been financed by a combination of state and local tax dollars. State revenues came from mineral production on state school lands set aside by our forefathers and a combination of general revenue from taxes on such items as gasoline, liquor, tobacco and general sales. Local revenues came from a tax levied on real and personal property. Originally, the share was divided with about 80% of the school support coming from the state. The percentage of state and local contribution was in direct correlation to a district's property wealth. If a district (such as Plains) had a great deal of property wealth, the district would be "budget balanced" and receive virtually no money from the state. In a situation where the district did not receive state funding, it enjoyed a freedom from many state controls. Also because of the high property wealth, the district (Plains included) was able to afford many advantages that a poorer district could not enjoy. A penny of tax levied on local property for enrichment in Plains will net almost \$70,000 dollars; while a penny of tax in a very property-poor district in the state might net less than a \$1,000. For years, many Texans thought this was grossly unfair. Many of them claimed that the money available to a child for his education should not be determined by the "accident" of where he happened to be born. It was allowed to continue because of a state Constitutional prohibition against state property tax or sharing of tax dollars between taxing entities. The state has limited powers of access to the wealth existing in property taxes. Therefore for many years, districts with property wealth enjoyed a distinct advantage in "enrichment areas" due to the ability to raise much more money at a much lower tax rate. This problem became more pronounced when Texas' economy slowed and state funds became more scarce and demand for state services increased in other areas. The percentage of state funding for schools decreased and the reliance on local property taxes increased. Today, only 38% of school funding comes from state sources. As the funding responsibility shifted to local tax bases, the vast difference in property wealth within different districts became a larger and more important issue. The first challenge to the "system" came in 1974 in a federal court case. The Federal courts denied jurisdiction in the matter stating that local tax issues and education were state responsibilities. In 1984, Edgewood v. Kirby was filed in state district court in Travis County. There have been three State Supreme Court decisions handed down in the long-running lawsuit. Edgewood I in 1990, Edgewood II in 1991, and Edgewood III in 1992. The court's decision each time insisted that since education was a state responsibility that "every child should have access to essentially the same amount of money for education at similar tax rates."

The Legislature tried to consolidate tax bases to achieve this equity of access by establishing a county education district to try to equalize wealth. When the wealth could not be equalized within a single county, multi-district and multi-county districts were formed. This was the case for the Plains district as we found ourselves in County Education District #6 with 25 other districts in a seven county region including Lubbock. Plains and other wealthy districts sued claiming that a tax rate set by the Legislature was unconstitutional based on the Constitutional ban on a statewide property tax. The plaintiff districts prevailed in the lawsuit and the Legislature was told to devise another plan by June 1, 1993. If a plan was not in place by that time, the judge has declared that he will stop all state funding to school districts, essentially shutting them down. Plains could continue to operate on reserve funds for about three months unless the judge was able to succeed in also stopping the expenditure of local funds.

#### Constitutional Amendment under Consideration

The Plains district has joined other similar districts in an organization called the Small Rural Schools Finance Coalition. We have retained counsel to represent our interests in Austin. Our ultimate goal has been to try to maintain our fine school as best we can from those who would want us to level down our system to meet the poorest of systems. Our goal has been to fight the "recapture" of our taxes and to maintain current levels of funding for our school. To that end we have joined other education groups in forming the School Finance Working Group. The Working Group had much to do with killing the Governor's Fair Share Plan in the Special Session in November and with the passing of the current amendment under consideration.

It has become apparent that we will not be able to avoid some form of recapture or equalizing of access to tax bases. The Supreme Court has made it very clear that this must occur. However, the court has not said that all schools must be completely equal in its funding and that there could be some forms of local enrichment.

The constitutional amendment passed this week will allow the state to "recapture" some of our taxes but will put a strict limit on the amount. I believe that this is the best deal we are going to get. The revenues and tax rates in the future should be close to what they are at the present. If we are very prudent and begin to seek more efficiency in our operations, we could continue to have a fine school under those conditions without unfair hardship on our taxpayers.

The only alternatives that we have discovered at this time to passing such an amendment would be mass consolidation (perhaps with the current CED, including Lubbock) or a massive state-wide tax increase in order to provide the poor districts without enough revenue to meet the court's definition of efficiency.

The legislature will continue to work on legislation to implement the Constitutional amendment should it pass in the May elections. If the amendment fails, I fear the worst for our school. We will continue to work with the legislature to find a solution that is best for Texas and especially our students.

#### FILING STUDENT INSURANCE CLAIMS

To The Parents of Students at Plains I.S.D.

School insurance coverage provides benefits for MEDICAL EXPENSES ONLY which are the result of ACCIDENTS incurred during regularly scheduled and supervised school-time and extra-curricular activities.

IF A STUDENT IS COVERED UNDER A PARENTS HEALTH INSUR-ANCE, the claim must be filed with the parents insurance first. The student insurance then will pay any amount not paid by the parents insurance. These amounts will be given on the EXPLANATION OF BENEFITS from the parents insurance company. A copy of these forms can then be filed with the student insurance provider along with the CLAIM FORM.

IF A STUDENT IS NOT COVERED UNDER A PARENTS HEALTH INSURANCE THEN A LETTER FROM EACH WORKING PARENTS EMPLOYER MUST BE INCLUDED WITH THE CLAIM STATING THIS. The parent should mail the claim form; completed by the coach or teacher, the parent, and the doctor; with the letter(s) to THE BAKER AGENCY at the address indicated on the claim form. If the claim form exceeds ONE THOUSAND DOLLARS the school insurance provider will request a NOTARIZED LETTER stating again that the student is not covered by another health insurance plan.

It is important to read the detailed instructions provided on the claim form to ensure that the correct information is provided. This will ensure that all parties are paid in a timely fashion.
