## **Texas ALLTEL Customers** to benefit from rate reduction

Commission of Texas' Docket No. 11456, customers will begin to see various rate reductions on their July telephone bills. These reductions will effect various services.

Those most visible to the customer will include the elimination of the monthly Touch Calling Service (touchtone) charges, the elimination of basic local exchange service mileage charges, and the reduction of some basic local exchange service rates.





# Junior olympic track meet set for June 26 at SPC

The South Plains College Track Officials Association will host a qualifiers meet for Region 12 of the West Texas Association of USA Track and Field on June 26 at South Plains College.

The meet, hosted by the South Plains College Track Officials Association, is open to all youths age 18 and younger.

Competitors will be divided into six divisions for boys and six divisions for girls, with the participant's year of birth determining which division the athlete will compete in. No athlete may compete in younger or older divisions.

Divisions include Primary, Bantam (1983 or later), Midget (1981-1982), Youth (1979-1980), Intermediate (1977-1978) and Young Men's/Young Women's (1975-1976). A competitor in the Primary, Bantam and Midget divisions may enter a maximum of three events, while competitors in the Youth, Intermediate and Young men's/Young Women's divisions may enter a maximum of four events. These limitations include relays.

Sanctioned by the West Texas Association of USA Track and Field, the meet is open to any athlete currently registered withe USA Track and Field for 1993. However, registration cards will be available at the meet.

Early registration by mail is preferred. Late registration will be held on June 25 from 7 p.m., and on the day of the meet from 6:30 a.m. at Texan Dome.

The entry fee is \$2 per athlete for each event, plus a \$1 participation fee. A fee of \$2 per athlete will be charged for relay teams as well.

No entry will be accepted without the enclosed fee. Checks should be made payable to the SPC Track Officials Association, and entries can be mailed to the SPC Track Officials Association, South Plains College, 1401 College Avenue, Levelland Texas, 79336.




