

## Plains ISD calls special election

The trustees of Plains ISD have 1993. The election was authorized by the recent passage of SB7, the school finance bill.

SB7 requires all "wealthy" districts in the state to reduce their property wealth to \$280,000 per weighted pupil. This could be done by consolidation, de-annexing part of the district, educating students in other districts,

consolidating tax bases (CED), or sending money to the state to educate other children elsewhere.

The Plains board has determined called a special election for July 31, that due to the instability of SB7 and the likelihood that it will be declared unconstitutional, the least damaging option open to our school would be to simply send money to the state. All other options would either give up our property which we would possibly not get back or cause us to have legal responsibilities outside our district by choosing other students to educate. SB7 requires the approval of the voters of the district to enact this option.

A town hall meeting is scheduled for Tuesday night, July 20, 1993 at

7:30 p.m. in the school auditorium. Trustees will explain the options open to our district and will answer questions or concerns about the election.

According to Superintendent Pete Simmons, "This could be one of the most important decisions that the voters of Plains ISD will ever be asked to make. It is vitally important that voters be informed to the options in this complex issue. I hope all interested voters and patrons of the school will be present on the 20th to join in the discus-

# School funding dilema not solved

On May 31, Gov. Richards signed into law Senate Bill 7, which requires Texas' 109 wealthiest school districts to choose one of five methods to reduce their taxable property wealth to \$280,000 per pupil and share the excess with low-wealth districts.

On June 1, State District Judge Scott McCown accepted the new law as constitutional and gave any opponents of SB 7 until July 15 to file challenges; lawyers for poor school districts have indicated that they will contest the law.

In discussing Texas' ongoing school funding dilemma, the cover article of the May/June issue of ATPE News (the official publication of the Association of Texas Professional Educators) asks the question, "Why are we playing games with our students?"

SB 7, the latest attempt to solve the state's 25-year-old public school finance crises, "is not a long-term solution," says ATPE State President Beth Graham in the cover article, which also emphasizes that SB 7 perpetrates the state's antiquated property tax system, potentially levels down at least 109 school districts, and places the entire funding equalization problem on the backs of those same 109 districts and not on the state.

At the annual ATPE state convention in March, the association's House of Delegates voted to support a dedicated income tax that would allow Texas to spend at least the national av-

erage per student and provide for a reduction in local property taxes and the

TAMALE PIE

1 1/2 c corn meal

1 1/2 t salt

4 1/2 c boiling water

2 T butter

1 c grated cheddar cheese

1 lb. ground beef

2 Toil

3/4 c chopped onion

1 clove garlic, minced

1 1/2 thinly sliced celery

1 lg can tomatoes

2 c drained whole kernel corn

1 T salt

1 T chili powder

1 t Worcestershire sauce

1/2 c corn meal

small can pitted ripe olives

Slowly stir the corn meal into the boiling water, add salt. Cover, cook over very low heat about 30 minutes. Remove from heat. Stir in butter and 3/4 of the grated cheese. Meanwhile, cook beef in oil until color disappears. Stir in the next eight ingredients. Slowly stir in the 1/2 c corn meal. Cover. Cook slowly for 10 minutes. Add olives. Line bottom of three quart casserole (oiled) with 3/4 c of the corn meal mixture. Pour in the meat filling. Top with remaining corn meal. Sprinkle with cheese. Bake for 1 hour at 350 degrees.

Boil four boned and skinned chicken breasts. Add salt to taste, bay leaf, and 1/4 t poultry seasoning to water. When chicken is done, remove from broth.

In the broth, cook Broccoli fresh or frozen. Remove from broth and drain. In casserole, place the broccoli then layer the chicken breast.

Cover with sauce: 1 can cream of chicken soup, 1/2 c mayonnaise, 1 T lemon juice, 1/2 t curry powder (more if desired). Sprinkle with grated sharp cheddar cheese. Bake at 325 degrees until bubbly. "Real good with wild and brown rice."

### **CHRISTMAS COOKIES**

1 c butter or oleo

1 1/2 c sugar

3 c flour

1/2 t nutmeg

1/2 t cinnamon

1 t soda

2 T hot water

2 POUNDS pecans (do not skimp on the pecans!)

3/4 lbs candied pineapple

3/4 lbs candied red & green cherries 3 eggs

Cream butter and sugar, add eggs. Add soda to water to dissolve. Then add spices to flour. Mix well. Chop fruit and nuts. Toss in flour mixture to coat fruit well. Then add to egg mixture. Mix altogether real well. Dough will be stiff. Drop onto greased cookie sheet and bake at 275 degrees for about 25 minutes. Cookies will be very lightly browned and soft to touch. Do not overbake. "Stores nicely and can be mixed up and kept in the fridge a week before baking.'



DISCUSSION ON SCHOOL FINANCE WITH EMPHASIS ON JULY 31ST SPECIAL ELECTION

The Legislature has mandated that our district reduce its property wealth by two-thirds. We have five options to do this:

- 1. Consolidation with enough poor districts (permanent).
- 2. Detach property to be annexed by enough poor districts (permanent).
- 3. Buy attendance credits from the state.
- 4. Educate enough specific students in poor districts.
- 5. Tax Base Consolidation (CED concept).

The issue is not whether we want to do one of the above. WE MUST DO ONE OF THE ABOVE. Our board has determined that the best option for the future of our district is NO. 3, BUY ATTENDANCE CREDITS FROM THE STATE. We must have approval of voters of the district to enact this option.
