## Fort Worth Man Low Bidder For **Rising Star Job**

Ernest Lloyd of Fort Worth was the low bidder on the re-construction of Highway 36 from Pioneer to the intersection of Highway 185 in Rising Star, according to a report here.

report here. Mr. Lloyd bid \$290,833.40 for the 5.8 miles of new highway and will have 200 working days in which to complete the project. The new road will eliminate the curve just want of Rising Star. Bight-of-way has been widened and a 40 foot slab of pavement will be laid from the western city limits to the intersection with city limits to the intersection with

Highway 183. No additional ight-of-way has been taken but solid slab of new pavement will be laid curb to curb. The city will bear the expense of the curbing, it was reported.



## **Farmers** Exempt For New Trailer **Title Regulation**

Farmers do not have to comply with a new state law requiring title certification on trailers of 4,000 pounds gross weight or 4,000 pounds gross weight or more, when the trailers are used for hauling their ows produce to market

This reminder was given loop farmers this week by Glean Jup tice, president of the Bastland County Farm Burean, who and many formers are not aware that

the new law exempts carriers of farm products or produce. The law, which was passed by the 56th Legislature during its regular session this year, requires matting the set of the on all trailers certificate of title on all trailers having an unloaded weight in excess of 4,000 pounds. The Texas Farm Bureau was successful in getting an amendment to the law exempting vehicles used by their owners for transporting their own farm produce to market, Mr. Jus-tice explained. He said the exemption does not apply when such products are being transported for hire.

The county Farm Bureau president said that the organization has information on the new law, and others passed by the 56th Legislature, in its file copies of the Austin news letter, a weekly publication issued by the Texas Farm Bureau legislative department while the legislature was in session, and also in a Legislative Report prepared by the Texas



# COUNTY IS ASKED TO ASSIST IN FIGHTING PREDATORY ANIMALS

The Eastland County Trappers Association and about 20 area ranchers appeared before the County Commissioners Court Monday to request aid in fight-ing predatory animals, according to a report here.

The Commissioners Court, which has previously been paying \$135 a month on the salary of one trapper in the county, voted to pay an additional \$100 a month on the salary of a second trapper. They also voted to pay \$500 on the back debt, incurred since August when the second trapper was hired by the Association.

The ranchers testified before the court that there is more wildlife in the county now than there has been in the past 10 years. Losses in sheep, goats and cattle have been "tremendous," ranchers stated.

Ranchers estimated that wool and mohair business in Eastland County brings in from half to three-quarters of a million dollars annually. If kids could be raised without great losses from wolves and bobcats, the figure could be doubled, they reasoned.

Homer Boyd, who ranches north of Cisco, told of losing 85 kids this year and 160 last year. He also lost 75 lambs and 50 goats and estimated that his loss totaled several thousand dollars.

Oscar Schaefer said that there is no way to judge how many wolves and bobcats inhabit the county, but about 60 bobcats have been killed on his land in the

past five years.

Since August the two count rappers have killed 36 wolve and a number of bobasis and ranchers have killed several the animals also. The county d cided to continue to pay a bounty of \$5 a head for wolves and \$3 a head for bobcats to anyone killing the animals. The county trappers are ineligible to receive the bounty.

The county will continue to pay the \$235 to the Trappers Association for the services of the two trappers until the Association holds another meeting June 1.
