City Taxes To Be Up 20%

Winters City Council Monday approved a change in the tax formula for the City of Winters which will, when adopted by ordinance, increase city taxes by 20 percent across the board. The tax rate formula was approved by voice vote Monday night at a regular meeting, but will not become official until adoption of a rate ordinance in May.

This is the first tax increase for the

City of Winters since 1961, city officials said.

• Under the new formula, property valuation would be increased to 75 percent of actual value, from the present 50 percent, and the tax rate lowered from \$1.50 per hundred valuation to \$1.20 per hundred. Use of this formula would cause an increase of 20 percent overall, it was pointed out. The new rate would be effective for 1975 taxes.

Baldwin said the City has contracted with Reece Albert, Inc., of San Angelo, for the paving, with about 15,00 square yards scheduled. Cost of the paving was to be \$1.13 per square yard, with a reduction to \$1.03 if 15,000 square yards was reached.

Winters City Council Monday night approved employment of Wesley McGallion as a patrolman on the City Police force




