Georgia's Prohibition Law.

At midnight Tuesday the legal sale or manufacture of intoxicating beverages in Georgia ceased.

It will be illegal to manufacture them in any shape or form. It will be illegal to sell or barthe doorway. That is the man-" ter for valuable consideration,

> It will be illegal to keep or furnish at any place of business any alcoholic, spirituous, malt or intoxicating liquors.

> It will be illegal to do any of these things with intoxicating bitters or other drinks which, if drunk to excess. will produce intoxication.

> The law is interpreted to mean that not an ounce of intoxicants can be kept in an office, store or any place of business-it matters not whether it is for sale, personal use or to give away. Under a strict interpretation it will be an infraction of the law to do so. Liquor may be kept in the

home in any quantity.
