### to Leave Brownwood, if Released from Jail,

Sheriff Emison yesterday concluded negotiation with the parties who have at various times been indicted in this city and county for violations of the local option laws, and by the terms of the agreement entered into, the sixteen parties signing their names are to leave Brownwood and are to not come back for a period of ten years, except for a visit not to exceed five days.

The matter was carefully considered by the officers, and many prominent citizens who have always shown interest in the enforcement of the local option laws, were consulted. The officers made the agreement very binding on the violators as will be seen by reading the terms of the contract. This exodus of sixteen men who have for the past few years been responsible for the majority of the local option violations will leave Brownwood free from bootleggers and the officers will keep a diligent watch for new ones.

The present Sheriff and Attorney were elected on promises that they would rid the county of this undesirable gang of outlaws.

One of the first lessons that the new officers learned was that they would have to catch the men in the very act.

Then began the real warfare Attorney McGaugh would direct the sheriff to search a certain place suspected of being a club and armed with the necessary papers the sheriff would enter the place, confiscate the contents and store the spoils in the old jail buildings. At first this proceedure was a source of amusement to the club men. Then it was repeated. This time it was not so funny. Several hundred dollars worth of liquors and property was involved.

The club men grew more wary. They had their Uno, Ino; etc., shipped in at night and unload-

day saw a new recruit in the ranks of the jail occupants. Some took fright and fled. Bonds were jumped and bondsmen were notified that bonds would be forfeited. One day last week one of the bootleggers who was uuder indictment in six cases came to the attorney's office and offered terms of peace. The officers treated him civilly but informed him that there could be no peace in a war like this. He went away and came back again. This time he told the officers that the gang would leave Brownwood forever if prosecution in the cases would be stayed.

The officers called a meeting of the citizens most interested and discussed the matter. A

binding agreement was drawn up providing for the absolute banishment of the entire gang. No penalty already assessed was to be revoked. The contract was a bitter pill to the bootleggers but there was no alternative except to stay and face the prosecutions which time and experience had taught them would prove disastrous to them.
