The question as to who really bought the Miles-Paint Rock road is just as far from solution to-day as it was yesterday. R. A. Love, the vice-president and general manager of the road, is in the city, but he has nothing to say as to who the purchasers are. Railroad men are like sphinxes when they don't care to talk.
