



The following notes are clipped from the various exchanges over the state and shows that all Texas had her eye on Runnels county Runnels went dry last week by a good safe majority, for the first time in her history. For many years past they have been holding Ideal option elections down there and each time the anti majority was greatly reduced until last week when the pros carried the county by several hundred, making it safely a dry county for the future. 




