# FARMER FALLS IN WELL AND BREAKS HIS NECK

J. W. Spence, one of the success ful and prominent citizens of the Pumphrey-Wilmeth country, was instantly killed about one o'clock Friday afternoon by falling in a well and breaking his neck, the tragedy casting a gloom over the northwest part of the county where Mr. Spence had been living for many years.

According to reports brought to Ballinger a few hours after the accident, Mr. Spence fell a distance of thirty feet and was dead when his body was recovered from the well. With other parties the man had been digging a well. Mr. Spence had just gone down in the well for the purpose of placing a blast, and was being drawn from the well when for some cause he released his hold and left while the officer went Croughen was being detained in The awful horror was more than would have been badly mutilated.


