OFFICERS MAKE RAID FOR BOOZE

Officers Search Lunch Stand and Confiscate Seventeen Quarts Hard Cider and Arrest Proprietor.

Acting upon a search warrant sworn out Friday morning, the officers made a raid on the little lunch stand located between the City Meat Market and Higginbotham-Currie-Williams Co., store Friday evening. They found seventeen quarts of what was called cider and took charge of the wet goods and also arrested the proprietor of the place, Mr. Hooper, on a charge of selling intoxicant. Hooper made bond and we understand will be given an examining trial early next week.

The action of the officers was brought about by the finding of a drunk man in the lumber yard of Higginbotham, Currie, Williams Co. The man came to town from the Benoit country, and he claimed that he bought a drink of cider at the lunch stand and that it soon put him down. He identified the wet goods seized by the officers as being the same that he was given to drink, and that his drink came out of the same kind of bottles.

This is the first case of this kind that has been brought to light since the attorney general has called the officers attention to the cider drinks that are being sold over Texas in prohibition territory and notified them to look out for such violations.

BROCK PAYS DEATH PENALTY AT AUSTIN

Austin, May 30.—Henry Brock was hanged at 3:27. He was pronounced dead about three minutes later.

The crime for which Brock will suffer the death penalty is the murder of Mollie King, which occurred in the southwest section of the city on April 24, 1912. Brock had been living with Mollie King for some time, but trouble had arisen between the two. There were no eye-witnesses to the crime. Brock pleaded accidental killing. His record had formerly been a trifle shady. He had been a saloonkeeper in the restricted district and two people had been killed in his saloon in a brawl some time before the death of Mollie King.

OBJECT TO MOVING DEAD FROM CEMETERY

San Angelo, May 31.—As a result of the notice given by Jack Miles Wednesday when he publicly declared his intention of making a home place out of the old cemetery and requested every one to move the bodies of their relatives, an injunction suit was brought against him Wednesday evening in which the court is petitioned to restrain him from carrying out his intentions.

The suit was brought by Mrs. Clarissa Frary and Mrs. H. B. Opp. They ask the court to forbid Miles from having the bodies of their relatives moved and also that the court order him to remove his house from the cemetery.

Miles alleges that the cemetery property was never deeded to the city or to any organization, but that people merely began to bury their dead around the grave of his mother. He says that not a single person has a shadow of a title to the graves in which they lie.

The outcome of the suit will be watched with considerable interest as there are many people buried there, the place having been used for a cemetery for over twenty years.

SHOOTING SCRAPE IN ABILENE TOWN

Abilene, May 30.—Two complaints were filed against Joe Williams, one charging him with unlawfully carrying a pistol, and the other alleging an aggravated assault. A complaint was also filed in the same court against Dick Hefferman for aggravated assault.

The complaint mentioned above followed an altercation which occurred between Williams and Hefferman near the corner of Tenth and Willow streets about seven o'clock Wednesday afternoon. Williams fired one shot with a Colts pistol, but the bullet did not take effect. According to the statement made to the officers by the parties engaged in the trouble Williams and Hefferman were engaged in a heated dispute. It is alleged that Hefferman called Williams an unprintable name, and that he (Williams) then proceeded to pull his pistol. Hefferman, with a slingshot—a heavy iron nut attached to a cord—knocked Williams down. Hefferman beat a hasty retreat and after recovering sufficiently to handle his pistol, Williams fired one shot at the fleeing man.

Williams was arrested soon after the incident by Police Officers Peevey and Eubank, and the arrest of Hefferman followed later. Both parties made bond this morning to await trial in county court.

A hail storm destroyed from four to five thousand bales of cotton that was standing in the fields waiting for pickers.
