

BLUE SKY BILL AND LIQUOR BILLS SIGNED BY COLQUITT


Austin, Aug. 21.-Eight more bills, comprising some of the more important acts of the recent legis lature, were approved and filed by Governor Colquitt this morning. These include the 9:30 evil closing bill, Allison bill relating to shipments of liquor, blue sky bill regulating building and loan associations, creating a special distriet court for the fifth judicial district, creating the county of Duval county, amending the law relating to drainage acts and pro viding for public warehouses.


