Brooksmith halted a second half rally by Carbon to win a six-man football game here Thursday night, 28 to 20.

The Ponies scored all their points in the first half for a 28-6 lead at the intermission.

Bobby Ramsey ran 12 yards for the first Pory touchdown, then plunged five yards for the second one, both in the first quarter. Martin Stacy converted after the second marker.

## County Land Owners Are Busy Planting Winter Cover Crops

Cover crop planting season is upon us. Many drills are already running. Winter cover crops are one of our most profitable conservation practices in this area. The soil, in order to produce an economical return, must be protected from the elements and have a continuous supply of organic material for maintaining soil tilth. Winter cover crops fulfill these two needs.

On the sandy land rye is primarily used for protection from wind erosion. Vetch is used in combination with rye to add nitrogen and provide a higher quality of organic material for returning to the land. Vetch and rye has been a great help in maintaining peanut yields in the area since vetch was introduced here on a large scale some twelve to fourteen years ago.

While Vetch has been most popular on sandy land it does give good results on the heavier soils when it is used primarily as a soil improving and grazing crop. Where land is used for harvesting of small grains, vetch interferes with combining and must be separated from the grain after harvest.

Results similar to use of vetch can be obtained through proper use of fertilizer on small grain land.

In recent years commercial nitrogen fertilizer has become so cheap and so easy to apply that it may possibly be cheaper to apply nitrogen than to use a legume like vetch with small grain.

Relatively heavy use of nitrogen fertilizer on small grain for growing a heavy stubble and the use of commercial nitrogen for degrading small grain residue can do much for raising the organic content of small grain land.

With continued good weather for drilling cover crops, fields should be a beautiful green within a few weeks.

Many excellent stock ponds are now being built. Land owners who have constructed ponds on their range land in the past weeks are Gordon Woods, west of Cisco; Earl Conner, south of Eastland; E. B. Patterson, near Olden; Jessie Ainsworth, near Chaney; and, L. D. Wyatt, W. E. Walker, and W. E. Pittman, near Carbon.

## Training Officer Exams Are Slated By Civil Service

Training Officers in the military sciences are needed at the U. S. Naval Training Device Center, Port Washington, New York, the U. S. Civil Service Commission announced. The entrance salaries are \$7,030 and \$8,330 a year.

The duties of these positions involve the participation in programs for the development, production and utilization of military training devices and in the training of technical personnel to maintain and operate these devices.

In addition, they must have had appropriate specialized experience in training programs concerned with technical equipment.

## Sale Of Savings Bonds Over 103% In This County

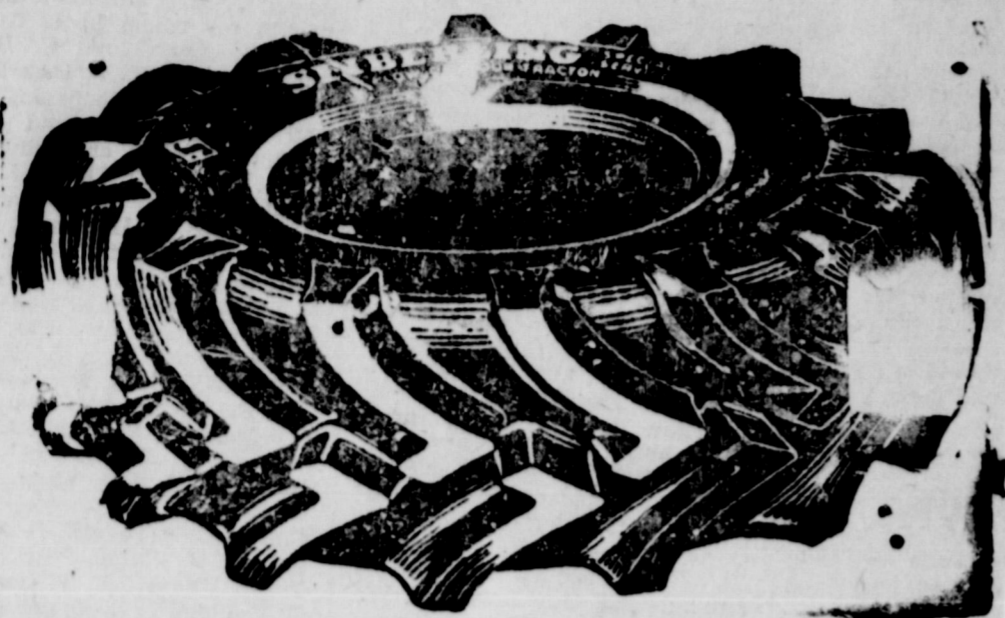

## Increase In Number Of Rural Improvement Loans Reported

Local banks and other private lenders are increasing their stake in the Farmers Home Administration's program of long term loans to qualified farmers to buy or improve family-type farms or establish good soil and water conservation practices. H. P. Cole, Farmers Home Administration county supervisor, pointed out this week.

His agency is authorized to insure farm real estate loans that are made from funds advanced by banks, insurance companies, or other institutions having money to invest. Since the recent change in the money market, activity by investors has greatly increased.

During the past six months, the national monthly volume of new insured loan business has risen from approximately \$1,250,000 to \$5,000,000 a month.

For either a direct or indirect loan the farmer pays 4 1/2 percent interest. If the loan is insured, the lender of investor gets a clear 3 1/2 percent and the Government guarantees payment of both the principal and interest.

The full guarantee and the money market change have put many local banks in position to contribute to a stronger local agriculture by helping farmers

otherwise unable to buy or improve their farms.

After a 5-year period the private lender may sell the insured note to the Government for the amount of principal and interest due, may arrange for later sale, or may hold until the note is fully repaid. In case of default, the Government stands ready to take the note over with no loss to the investor. The Farmers Home Administration takes care of all collection and servicing details.
