### PLANS TO PREVENT STRIKING

WASHINGTON, Aug. 25.—Plans to prevent strikes in all plants making munitions and war supplies have been completed. The government and heads of the American federation of labor have agreed upon plans for keeping down strikes or any kind of labor disturbances during the war. All labor organizations affiliated with the American Federation of Labor have pledged loyalty to the administration.

Becomes governor of Texas during the hearing of impeachment charges against Ferguson. Mr. Hobby is succeeded as lieutenant governor by Senator Henderson, temporary chairman of the senate.

### Change Takes Place In Governor's Office

AUSTIN, Tex., Aug. 25.—W. P. Hobby is governor of Texas for a few days at least. Mr. Hobby began the transaction of official business of the governor's office shortly before noon today. When Mr. Hobby appeared at the governor's office Mr. Ferguson greeted him most cordially and turned the office over to Mr. Hobby.

The house voted on the last article of impeachment at nine o'clock last night and the committee's report including twenty-one bills of indictments went immediately to the senate and Mr. Hobby was notified to take the place made vacant by Mr. Ferguson until the senate could pass on the charges. The senate will begin hearing evidence or arguing the case next Wednesday and it is expected that a speedy trial will be given Mr. Ferguson. As it requires a two-thirds majority to convict, or sustain the house, there is considerable speculation as to the result of the senate action.

Following are some of the charges as filed by the house:

Misapplication of \$5,600 of state funds; placing of Canyon City normal insurance in the Temple State bank without interest; owing Temple State bank more than the law allows and transferring \$75,000 temporarily to a Houston bank to cover up this fact; telling the legislature he did not

owe the Temple State bank, when he did in fact owe the bank more than \$8,000; depositing \$60,000 of the collections of the secretary of state's office in the Temple State bank, and procuring the deposit of \$250,000 of these funds in the American National bank of Austin, to the credit of the Temple State bank; seeking to have the chairman of the state highway commission to deposit its collections in the Temple State bank; telling the house of representatives he was not indebted to the Temple State bank when in fact he was in debt to it more than the law allows; declining to tell the house the source of loans aggregating \$156,500; misapplying more than \$3,000 belonging to the adjutant general's department; refusing to return to the state treasury the so-called "chicken-salad" money; encouraging violation of the banking laws, despite his oath to enforce the laws; vetoing the university appropriation bill; using undue influence to control the university regents, and seeking to remove regents who did not agree with him; employing epithets with respects to members of the university faculty; which he failed to justify, and which, if false, constitute criminal libel; remitting a bail bond forfeiture of \$5,000 to Wilbur P. Allen, university regent,

with an improper motive; improperly conducting himself toward the courts, failing to send another nominee to the senate for labor commissioner when Frank Swor failed to qualify.

### WIFE OF PROMINENT YOUNG FARMER BURNS TO DEATH

News of the burning to death of Mrs. J. T. Elms was received in Ballinger early Saturday morning. Mrs. Elms lost her life when her home near Wingate was destroyed by fire about twelve o'clock Friday night. The remains were brought to Ballinger in an auto Saturday and shipped on the afternoon train to Killeen where they will be laid to rest.

According to information received here the awful tragedy occurred when Mr. and Mrs. Elms were awakened by the fire burning through the ceiling over their heads in a south room of the house where they were sleeping. It is presumed that the fire originated on the opposite side of the house from where Mr. and Mrs. Elms were sleeping, and originated from some unknown cause.

When they were aroused by the fire Mr. Elms rushed to a phone in the room and notified neighbors, while Mrs. Elms jumped up and wrapping herself in a quilt attempted to leave the burning building. In her attempt to get out she went through the bath room, and the roof falling in trapped her in this room and burned her to death.

As soon as Mr. Elms had summoned help by phone he made his way out of the house, thinking his wife had left the burning building. By the time he had discovered that she had not escaped, a number of neighbors had arrived and it was with a struggle that they prevented Mr. Elms from returning to the building to attempt to rescue his wife, which rescue was an impossibility at that time.

After the fire had burned out, the remains were recovered from the ruins of the building and carried to a neighbors and later prepared for burial and brought to Ballinger.

Mr. Elms is one of the most prominent and successful young farmers in the Wingate country. He and his young wife had improved a good farm and built a nice home and were active in social and church life in their neighborhood. The many friends of the man will join The Ledger in sympathy for the great tragedy that has befallen him.

## First Drafted Army to Be Men Not Head of Families

### INSTRUCTIONS RECEIVED FOR MOBILIZATION HERE

The Local Exemption Board are in receipt of detailed instructions for mobilizing the drafted men at Ballinger and starting them on their way to the training camp. The exact date for entraining has not been announced, but is expected to be on Sept. 5th. There is little red tape about this part of the work, and all that the drafted men will have to do will be to obey orders.

Briefly this is the plan: The men called for service will receive two more notices. The local board will notify them when the district board has passed on their appeals, this notice will inform them whether the district board rejected their appeal and certified them back to the local board as being subject to call for duty, and if certified the man so certified will be instructed to hold himself in readiness to respond to the call.

The second and last notice will be mobilization orders. This notice will instruct him when to report to headquarters at Ballinger, and the law provides that all men called for mobilization must be here within twelve hours at the least of time for entraining, and all who report within twenty-four hours of time of entraining will be kept here at the expense of the government, board and lodging being provided for the men drafted until the time for entraining.

Prof. James and Harold Tucker have been appointed to take charge of the men after they have been enrolled by the exemption board, and to assist in transferring them to the training camp. It is expected that a special train will be made up at San Angelo to carry

WASHINGTON, Aug. 25.—President Wilson addressed a letter to Secretary of War Baker today greatly modifying the draft rules for making up the army under the selective draft. Mr. Wilson declared that the first draft made on the citizens for this army should be made up of men who

are not "heads of families." To make the change it will be necessary for the exemption boards to certify single men first and men who are not heads of families. However, the local boards have no authority to take any action in making changes until instructions are issued through the provost marshal's department.

Texas State Letter

Washington, Aug. 25.—Loving mothers, sweethearts and kind friends must not load drafted men with a lot of clothes and comforts when they start to camp September 5th, Provost Marshal General Crowder has ruled.

The 206,100 boys entraining for cantonments will be allowed to take very little. Trunks are absolutely taboo. Suit cases and hand bags will be frowned upon.

The War Department prefers that each man bring only necessary toilet articles and one change of linen and underclothing, done up in a neat, small bundle.

This is because strict attention will be given the military appearance of the boys from the moment they report at headquarters of their local board.

The department wishes it understood, however, that it is necessary that the boys bring the articles mentioned as it is that they bring nothing more.

Members of each man's local board will inspect his kit just before he entrains, rejecting everything that has no place therein and returning the surplus articles to his relatives.

"These men," said the draft official here today, "are not going on a vacation trip. They are going to study the business of war. They will be supplied with all necessary clothing and equipment when they get to camp."

According to the regulations all any man can take is a tooth brush, a piece of soap, collapsible drinking cup, a towel, a few handkerchiefs, an extra shirt and collar, a suit of underwear, and a pair of socks.

Dallas, Tex., Aug. 25.—Wanted, men to go to France—with the 117th Supply Train Division of the Texas National Guards.

The Division is expecting orders to entrain for France at any time via Camp Mills. Men from 18 to 21 years, inclusive, and from 31 to 45 years, inclusive, who have some knowledge of automobiles, either as drivers or mechanics, and who want to see immediate service in France are wanted.

Austin, Tex., Aug. 25.—Bills have been introduced in both houses providing for the licensing and regulation of emigrant agents, placing same under the supervision of the Commissioner of Labor Statistics, and providing that they shall not charge more than \$2.00 for each person they place in employment beyond the borders of the state. Each such agent shall pay \$250 for license and make a bond of \$500. They must have three affidavits of good moral character. Where a merchant fails to receive employment, no charge shall be made.

Fort Worth, Tex., Aug. 25.—Governor Jas. E. Ferguson will be the leading speaker on the program for the Nineteenth Convention of the Brotherhood of Railway Carmen, which will be held here from September 11 to 19, inclusive.

Snyder, Tex., Aug. 25.—An association of Seurry county farmers has been formed here to cooperate in purchasing seed wheat. The local banks have offered to finance the undertaking and plans are under way for planting an unusually large acreage of wheat.

**MEXICANS SLACKERS IN BALLINGER JAIL**

Pablo Rodriguez is in jail here and will be transferred to the federal authorities at San Angelo within the next few hours on charge of failing to register. Sheriff Perkins arrested Rodriguez Saturday morning at his home in Mexican quarters in the eastern part of the city. There was quite a commotion when the officer called and took charge of the Mexican. His wife became prostrated with grief, his sister fainted and there was a "taking-on" that alarmed the neighborhood.

Rodriguez said he was only seventeen years old, and was not subject to register. Other members of the family, his mother-in-law and evidence furnished by other Mexicans showed the man to be twenty-three years old and his appearance is against him. He filled out a registration card, but contended that he was only seventeen, and would give no other age.

Sheriff Perkins also arrested and placed in jail Saturday two other young Mexicans, who claim as their home Coleman, and who also claim to be too young to fight for their country, or at least to fight for the protection of the country that is protecting them. We failed to get the names of the Coleman Mexicans, who seem to be here today and some where else tomorrow. They claim to be only twenty years old, but they appear to be away up in twenty-odd. An investigation is being made in Coleman and it is probable the two will go to San Angelo for trial in federal court also.

**FERGUSON DISHES OUT MANY PARDONS**

AUSTIN, Tex., Aug. 24.—Governor Ferguson today while the house was engaged in drawing articles of impeachment, against him, was busily engaged in his office granting pardons. It is known at least nineteen pardons were granted today and rumors have it that a larger number than that were issued out of the governor's office today. Thirty-nine pardons are said to have been granted yesterday. Since June it is reported that approximately four hundred pardons have been granted by the governor. As fast as the pardons were granted yesterday and today they were sent into the state department, where proclamations were drawn. They were then returned to the governor for his signature. All records for the issuance of pardons with the exception of the customary Christmas pardons, have been broken within the past thirty-six hours. It was said on good authority here today that Monroe McKelvey of Temple was one of those pardoned as named above. His brother, A. T. McKelvey of Temple, received the pardon here shortly after noon Thursday, it was stated, and left immediately for Huntsville with it.
