## OFFERS AID TO SHERIFF MILLER

Judge A. K. Doss returned home Saturday from Brownwood, where he had been in a conference with other counsel representing Sheriff Bob Miller, of Concho county, who will be arraigned for trial on a charge of killing Tom Benge, Concho county stockman, when court convenes in Brownwood on December 5th. The case was transferred from Paint Rock to Brownwood by Judge Woodward. In speaking of the coming trial, and the visit of the attorneys to Brownwood, the Bulletin says:

"Walter C. Woodward of Coleman, one of the attorneys representing Sheriff Bob Miller, of Concho county, who is to be tried here December 5th on charge of venue from the Concho county district court, was here today with his client and Judge A. K. Doss, of Ballinger, who also represents Mr. Miller. They came here for a conference with Judge Will J. Scott, of this city, a third member of Sheriff Miller's counsel. Mr. Miller will be tried on a charge of murder in connection with the killing of Tom Benge, Concho county ranchman, a few weeks ago.

"When asked this morning about the Miller case, Mr. Woodward said, 'It would not be proper for me to say anything about the facts in the case, as the facts will be fully developed and will completely clear Mr. Miller of any wrong.' Mr. Woodward, however, said that in addition to being sheriff of Concho county, Mr. Miller was a former Texas ranger with Captain Fox of Brownwood and is widely known throughout the western and southwestern portions of the state.

"In years past, Sheriff Miller was an intimate friend and worked with William S. Hart of movie fame, on a ranch in Arizona, and has recently received a letter from Hart offering any assistance he can give," Mr. Woodward said.

"The Miller trial is expected to attract to Brownwood a large number of Concho and Runtels county people who are interested in the case."

### AMBASSADORIAL RANK GIVEN U. S. DELEGATES

WASHINGTON, Oct. 31.—The rank of ambassador was given today to the American delegates to the forthcoming conference of limitation of armaments and far eastern questions.

The announcement was made by Under Secretary of State Fletcher, who explained that the four representatives were given ambassadorial rank to sit in the conference on an equality with the delegates of other invited powers. They will outrank ambassadors credited to foreign capitals.

With the formal opening of the disarmament conference less than two weeks in the future, preliminary preparations for the meeting swung into the final stage today.

### SWEETWATER LOSES HIGH SCHOOL BUILDING

SWEETWATER, Oct. 31.—The Sweetwater High School building was almost destroyed by fire, which is supposed to have started in the laboratory, about six o'clock Friday afternoon. The fire department with both engines running three streams of water held the fire in the upper part of the east room of the building for quite awhile when it finally broke out in the other rooms and left nothing but the walls standing down to the auditorium and lower floors. This part of the building and library were saved.

The loss is estimated at thirty to thirty-five thousand dollars, with insurance for thirty-two thousand five hundred. This is the greatest loss by fire ever suffered in Sweetwater.

## MAKING FIGHT ON BONUS BILL

WASHINGTON, Oct. 31.—While the American Legion in convention in Kansas City is passing resolutions criticizing congress for blocking the soldier compensation act, the fight against the bonus bill was opened in the senate today. The Republican fight on the Reed amendment to the tax revision bill providing revenue for taking care of the proposed four-fold bonus measure, was opened today by Senator New of Indiana, who raised the point that the amendment was unconstitutional.

## SEEKS BOND FOR MEX. PRISONERS

Judge W. E. Taylor, of San Angelo, was here Monday seeking the release of Louis and Juan Fitchett, two Mexicans who are in the Ballinger jail charged with assault and attempt to murder. The two prisoners were recently tried at San Angelo three times on the above charge, the jury in each trial failing to agree, and the court transferred the cases to Ballinger, and fixed the bonds at \$1500 in each case. The Mexicans were out on bond when arraigned for trial and Judge Taylor stated that he had arranged the bond and his clients would be released.

The two Mexicans are charged with shooting Jack Burns, a night watchman, as they fled from a building which they are alleged to have been robbing when the officer appeared on the scene. The question of identity is involved in the trial, and on this hangs the guilt or innocence of the two men. They introduced evidence to prove an alibi, claiming that they were with other parties when the shooting took place, while Burns is positive that the Fitchett brothers are the two men who shot him. Burns formerly lived in Ballinger.

### "COKE" GETTING BACK NORMAL

He says he may be back here in a short time or he may be gone a year. It all depends on how the tide turns for him. Naturally his friends look for him back in time to plant milo maize.

## STOP UNIONS BY INJUNCTION

INDIANAPOLIS, Oct. 31.—An injunction directed towards stopping the United Mine Workers of America, in their efforts to unionize the Williamson coal fields in West Virginia, was issued today by the United States district court here. The stop order was granted on the grounds that the union was seeking to restrain trade.

## AMERICAN LEGION SAYS HE WAS FIRED ILLEGALLY

KANSAS CITY, Oct. 31.—Nothing is closer to the heart of President Harding than to make relief for the incapacitated war veterans absolutely complete; no man will go further than the president of the United States to minister to the true welfare of those who have been in the service and their dependents, Vice-President Coolidge told the national convention of the American Legion here today.

"He will never sacrifice you for his own welfare. He will sacrifice himself for your welfare," said Mr. Coolidge. Mr. Coolidge added that he knew of no present service that could be performed for those who served in the world war more important than to reduce "the great drain upon the resources of the people."

KANSAS CITY, Oct. 31.—The big American Legion went into action here today, launching an offensive against the program of the tacticians, and said it would require three full days to make the drive.

As the zero hour approached the big convention hall sector was choked with thousands of restless veterans eager for the word to be given to "go over the top."

Watching the drive closely are General Armando Diaz, of Italy; General Baron Jacques, of Belgium; and Vice-President Calvin Coolidge, representing President Warren G. Harding. One of the features of the morning session was the appearance of Mr. Coolidge, who addressed the convention.

The efforts of the Legion to combat unemployment in America, as effects of unemployment on former service men, and suggestions for remedies, were set forth in the annual report of Adjutant Lemuel Bolles.

The Legionnaires are taking Kansas City by storm, and they are getting everything they want in the way of entertainment. Some interesting meetings of service men who fought side by side in France have already been noted, the "buddies" meeting for the first time since the smokes of battle cleared away.

Prolonged cheers greeted Commander Emery's charge that congress had been forced to bow to the will of the chief executive in the matter of delaying legislation on the soldier compensation act, or bonus bill.

John L. Berry, of Tennessee, speaking as an official representative of the American Federation of Labor, told the convention that the federation stood shoulder to shoulder with the service men's organization in loyalty to American ideals and government opposition to the "sovietization" of the United States, and direct action in settling industrial disputes.

AUSTIN, Oct. 31.—When the board of control of the Gatesville juvenile training school met at two o'clock this afternoon to hear argument of attorneys in the inquiry growing out of the recent death of an inmate of the institution, Gov. Neff appeared in person before the board to make recommendations. It had been announced earlier in the day by the governor's secretary, Mr. Walthall, that Mr. Neff would appear before the board.

ST. LOUIS, Oct. 31.—George White, on his arrival here today for the Democratic national committee meeting tomorrow, denied the reports to the effect that he would resign the chairmanship. Mr. White said that he knew nothing definite of the character of the business to come before the committee meeting.

**GLOOMY OUTLOOK FOR POULTRY FIFTY PEOPLE JOIN CHURCHES**

"It is the first time since I have been in the produce business," said E. A. Jeanes Monday, "that there was not a market for poultry." Mr. Jeanes made this statement when a Ledger reporter asked him what the outlook for poultry output was this season. The local dealer stated that his firm was offering ten cents for hens a few days ago, but was not able to turn them at any price, and got out of the market for a few days.

The bad poultry market is attributed to several causes. Cold storage plants are full of poultry. This is an under-consumption, and the decline in other meats has also affected the poultry consumption. The consumption of poultry has dropped off, and at the same time the production has increased. There is an immense poultry crop on hand, and until people begin to buy poultry for their fall dinners, the market will probably lag.

"I expect the turkey market to open up in a few days, and I believe that the price will open around fifteen cents," said Mr. Jeanes. He stated that nobody was selling turkeys yet, and there was no demand for them. He did not anticipate heavy turkey movement for the Thanksgiving season as there is already a large supply on hand of frozen turkey.

Jeanes & Co. operate a dressing plant here and have been shipping dressed turkeys in car lots for the past several seasons, and will operate again this season as soon as the market opens, and they can find an outlet for the Runnels county birds.

Mr. Jeanes stated that there was a good demand for fresh eggs, and the fresh eggs were bringing a good price, but cold storage eggs were going slow. He stated that the supply of cold storage eggs was larger than ever known before.

While poultry has declined, feed has also come down, and most of the poultry growers are in a position to take care of their stock until the market improves, and it is not believed that many will sacrifice their poultry on a low market.

After a number of others who have given their names for membership in the Presbyterian and Methodist churches have been received, the total members received as a result of the revival which closed at the Methodist church Sunday night, will be more than fifty, and the other churches of the city will probably receive members as a result of the revival.

Forty-two were received into the two churches at the special service held for that purpose Saturday night, and the pastors, Rev. Simpson and Rev. Kunze, took it turn about in conducting the solemn and impressive reception ceremonies. The candidates for membership formed a row extending across the front of the large auditorium of the Methodist church and doubled back half way from each side. It was an impressive service.

Dr. R. M. Hall left early Monday morning for his home at Longview, after closing one of the most successful revivals ever held in this city. He completed four years of evangelistic work with the revival here, and goes to Longview to accept the pastorate of the Presbyterian church at that place. His family had already preceded him from Houston, where they have been making home, to Longview.

No public subscription was called for to compensate Dr. Hall for his faithful work in the revival here, but at the Sunday morning and Sunday evening services a free will offering was made and after the collection plates had been passed and the offering taken a sum amounting to \$460 was in hand to pay the expenses of the meeting. No collections for expenses were taken through the week, only the Sunday collection being taken, and this is considered an unusual collection for a private free will offering.

The revival closed Sunday night with a crowd which packed the house, quite a number standing through the service, while some were turned away on account of being unable to get seats. The attendance was good at every service, and with the exception of one or two nights, the large auditorium of the Methodist church was filled, and the Sunday school rooms filled on several occasions.

In addition to the large number of converts and additions to the two churches, the congregations of the two churches, as well as the spiritual interest of other churches, profited greatly as a result of the soul stirring messages delivered by Dr. Hall. The earnest and able preaching of Dr. Hall, the ideal weather, the large and attentive audiences, and the splendid singing, with nothing to conflict with the revival, made it one of the most successful ever held in this city.

**100 MILES OF HIGHWAY ARE CONTRACTED FOR**

AUSTIN, Oct. 29.—The award at Midland, Texas, of the contract for constructing 100 miles of the Bankhead highway, reaching across four counties and involving the expenditure of nearly \$1,000,000, was the largest letting in this federal district and one of the largest in the United States, according to a statement from the state highway department.

The completion of this project will go a long way toward developing the resources of West Texas, the statement said, and in the near future the highway department hopes to complete the remaining links in the Bankhead highway, connecting Texarkana with El Paso.

The project consists of constructing highway No. 1 through Howard, Martin, Midland and Ector counties. The type is to be an 8 inch gravel surface 16 feet wide on a 24 foot roadbed with standard reinforced concrete structures throughout. Gravel is provided at a 25 acre pit owned jointly by the counties at Big Spring.

With the award of this project following the recent awards in Reeves, Jeff Davis and Hudspeth counties and the work under way

in El Paso county, West Texas now has 200 miles under construction and 15 more miles soon to be let in El Paso county.

**TO MAKE TEST SHULTZ WELL**

The Texas-Meers Oil Company well on the W. O. Shultz ranch Southeast of Ballinger is being cleaned out preparatory to going on a pump to test it for its producing value.

The well was shot for the second time Saturday when eighty quarts of nitro-glycerine was touched off in twenty-six feet of sand at a depth of 1390 feet.

The first shot was placed in the well last Tuesday, and following the blow-out gas flowed at an estimated push of 1,000,000 cubic feet daily, and a good showing of oil was made. It is believed that the well will pump at least fifty barrels of oil per day, and if it does the field will be rapidly opened, as the oil is of a high-grade, and found at that depth can be produced at a good profit.

This well is located about four miles West of Millersview. It is known as Shultz No. 3, as two former tests were made in the same neighborhood, both of which offered such encouragement as to cause the drilling of the third well. The well is only a few miles South of the Russell field in this county, and on the opposite side of the river, which indicates that the oil field extends South from the big field further North of here, and sooner or later another big field will be discovered.
