The Commissioner's Court desires to call attention to the fact that at a recent session of the legislature a law was passed which provides that where delinquent taxes are paid before Jan-uary 1, 1933, no interest or penwill be charged, regardless of the number of years they

have been delinquent. We feel that many who owe taxes do not know of this law nor bow much they could save owes \$52.05 taxes it can be paid in full, if paid during 1931, for \$52.05. If he owed \$52.05 taxes for the year of 1930 and did not pay it before January 1, 1933 he would be compelled to pay \$61.80 or \$9.75 interestand penalty: if he owed \$52 05 for the year 1928 and did not pay it before Jan-uary 1, 1933 it wou'd cost him \$69.92 or 17.67 interest and pen-alty; if he owed \$52.05 taxes for the year 1925 and did not pay it before January 1, 1933, it would cost him \$80.42 or \$28 37 interest and penalty. Delinquent taxes for various years and amounts would increase proportionately if not paid before January 1. 1983. Handreds of people took the advantage of a sim ple took the advantage of a sim-ilar law in the latter part of 1931 and paid their taxes and many are doing so now. This partic-ular law will not be in effect after December 31, 1932. The Commissioner's Court will not have, nor has it ever had, the power to remit interest and penalty on State and County taxes. we agent it our duty to call at-tention to the above mentioned law. 
