Runnels county carried off first money in the agricultural exhibits at the San Angelo Fair. The awards were made Wednesday.

D. F. Eaton and J. M. Pyburn are at home from the fair, where they spent a day or two arranging the booth and making the display of the Runnels county products. Stuart L. Williams and others who assisted in arranging the display, returned from San Angelo earlier in the week.

Mr. Eaton stated that the San Angelo Fair was proving a success, notwithstanding the threatening weather, and that the attendance was good. The Runnels county exhibit is attracting much attention. Maverick is at the fair with a community exhibit, which is also attracting much attention.

MANY MOTOR TO SAN ANGELO FAIR

Despite the threatening weather and chilly drizzle which fell Wednesday night, a large crowd loaded out early Thursday morning for San Angelo, where they went to represent Ballinger in Ballinger Day at the San Angelo Fair. The cars were decorated with Ballinger pennants, and delegations from Rowena and Miles were expected to join the Ballinger crowd and stage a Runnels county parade after arriving in the Tom Green county town.

Reports from San Angelo state that the weather has interfered to some extent with the program, but large crowds have flocked to that city for the fair and despite the threatening weather the fair is being made a success.

Thursday was the feature day, horse racing having been made the drawing card for the day. It is estimated that about twenty-five cars went from Ballinger.

PERSHING FACES HIS OLD FORCES

(By Associated Press)
NEW ORLEANS, Oct. 19.—General John J. Pershing, commander-in-chief of the American Expeditionary Forces, again today acknowledge tribute of the forces he led in France when he appeared as chief speaker at the national convention of the American Legion in this city. The appearance of General Pershing shared in chief interest with politics in connection with the selection of a new national commander for the Legion.

The interstate hospitalization committee produced a conservative report. The report avoided further condemnation of Brigadier General Sawyer, notorious head of the federal hospitalization board. The report will approve the solving of the controversy over the government's treatment of the sick and disabled veterans on the terms Gen. Sawyer agreed to.

The Auxiliary delegate from Virginia declared that the woman's organization was behind the Legion in its fight for the adjusted compensation.

Removal of General Sawyer, President Harding's personal physician, was demanded by a vote of 601 to 375. Gen. Sawyer is charged with blocking the Legion's hospitalization program.

BALLINGER BOY TO GIVE RADIO CONCERT TONIGHT

The radio concert to be broadcast by the Dallas News tonight will include selections by David Guion, according to a letter from Mr. Guion to his sister, Mrs. E. A. Giesecke of this city, and also according to the program announced by the News.

Mr. Guion will play his own piano compositions and Mrs. Brewster will sing songs written to music by the young Ballinger composer. Those who have receiving sets can tune in on the News wave length tonight and hear the concert which will begin about eleven o'clock. The late hour is due to the fact that other numbers on the program are scheduled for the fore part of the evening, and also because better service can be had at the later hour.

G. P. Teague will keep open shop and operate his loud speaker for the benefit of the friends of Mr. Guion, and he states that he will receive other programs from different points over the United States during the early hours of the season.

CLEVELAND, Oct. 19.—Rear Admiral W. S. Sims, in an address here today, declared that the United States must either improve the marine naval service or scrap the whole outfit.

Admiral Sims said that the efforts to build up an efficient navy have failed because of public opinion failing to support the naval program. He said that the nation must have an efficient merchant marine to support the navy because the two are interdependent.

MAYFIELD ON STAND IN POLITICAL SUIT

A NEW PARTY RULES

(By Associated Press)
LONDON, Oct. 19.—The coalition government of Premier David Lloyd George resigned this afternoon, and conservatives will be called on to form a new cabinet.

LONDON, Oct. 19.—The Lloyd George coalition wing received a death blow at the hands of the conservative party today. The conservative members of the House of Commons and the government ministers voted to appeal to the country as a conservative party.

This move creates the greatest political confusion and uncertainty the country has known in many years. The next move to be made is the resignation of the government leaders in the House of Commons; and Austen Chamberlain, and his associates, Lord Balfour and Lord Birkenhead, will leave the cabinet. It is expected that Premier Lloyd George will then present his resignation to the king and advise his majesty to summon a conservative leader to form a new government.

RETURNS HERE AFTER 44 YEARS

One of the distinguished visitors to the Nazarene Assembly in session in this city is Rev. P. N. Adkins, of Amarillo, who returns to Runnels county after absence of forty-four years. Rev. Adkins is getting up in years, but is healthy and hearty, and he recalls with interest some of the activities in this country almost a half century ago. He remembers quite a number of the old timers who lived at Runnels City before Ballinger was staked off, and mentions L. F. Gressett, Judge C. H. Willingham, and several others who have drifted away from Ballinger since this city drafted on the old county site for its population.

Rev. Adkins located in Brownwood in 1878, and operated a freight line from that city to Fort Concho long before Ballinger was dreamed of. He says that at that time the road crossed the Colorado river at Walthal, four or five miles below where Ballinger is now located, and that Walthal was the only settlement between Coleman and Ft. Concho.

"I was born in Tennessee," said Rev. Adkins, "and I always wanted to come West, and when I started I came as far as civilization would let me." Rev. Adkins says that he has seen as many as 500 antelopes in one bunch on the prairies around where Ballinger is now located, or at least the drove was so large that he estimated that at least that many of the prairie goats were in the bunch, and they were thick everywhere. He said that they were so plentiful that it was no trouble to have fresh meat whenever the freighters wanted it.

Rev. Adkins built two houses at Old Runnels and engaged in the hardware and furniture business with S. M. Davis in 1884. He built the first I. O. O. F. hall in the county, which was at Old Runnels. He was converted and baptized there. For many years he has been living in the Plains country, having enter-

CORNICANA, Oct. 19.—Earle B. Mayfield resumed the witness stand today in the litigation which seeks to prevent his name from going on the official ballots for the general election. He was questioned about twenty minutes and excused for the present. It was said that he would probably be recalled. The questions asked Mr. Mayfield concerned bills for Mayfield headquarters in a hotel at Dallas. The plaintiffs alleged that the bill remains unpaid.

Defense attorneys asked Mayfield to identify a letter to Mike McNamara at Graham; and who signed for the registered letter. Mayfield said that his name was placed on the receipt by another person.

Reading depositions before the jury began today. One deposition by McNamara said that McNamara collected \$200 and sent it to Mayfield by registered letter. The deposition said that Mayfield had requested McNamara to collect the money.

A deposition by J. H. Davis, of Sulphur Springs, said that Davis received \$245 from Atticus Webb, superintendent of the Anti-Saloon League of Texas, and from Morris Mayfield and from Mayfield headquarters.

Rev. Atticus Webb's deposition telling of the activities of the Anti-Saloon League was read. It denied that Mayfield had paid, or agreed to pay money to the league during last July, August, or September, for any purposes. Reading certified copies of Mayfield's returns then began by the plaintiff attorneys.

The Kelly Cottage has been closed for the last few weeks and during that time it has undergone complete renovation, the house being repapered throughout, and the interior made practically new and put in first class condition for Mrs. Nash. She will move to the new place in time to serve all her boarders by the first of November.

Mrs. Nash has been operating a boarding house at her home place on Eighth Street for several years and a good portion of the time she has been crowded. By serving good meals and giving good service she has built up a trade which prompts her to seek larger quarters, and she will no doubt have a full house.

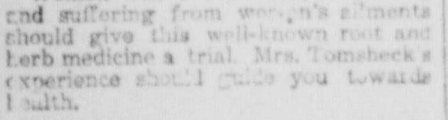

AUTO RACES AND FOOT BALL AT THE 1922 COTTON PALACE

COMMUNITY CHORUS AT TEXAS COTTON PALACE

Waco, Texas.—A series of community concerts are to be given at the Texas Cotton Palace Exposition, at Waco, each Sunday afternoon and evening, commencing on October 22. The concerts will be directed by Prof. Chas. H. Keep, for some time director of music at Baylor University.

Three concerts will be given each afternoon and three each evening, each lasting approximately one hour. There will be numbers of a nature to appeal to all who love music. The afternoon concerts will be composed of choral selections from the standard oratorios, including Handel's "Messiah" Hadyn's "Creation" and Gounod's "Gallia." There will also be operatic choruses from Tanhauser, Lohengrin, and Faust. Some of Waco's favorite singers will be brought in as soloists. It is hoped that the chorus will number close to a hundred soloists. At the final concert, it is planned to sing Gounod's "Holy City," one of the most beautiful of modern cantatas. For this performance the chorus will be increased to one hundred and fifty voices. There will also be an orchestra or from twenty to twenty-five pieces to play accompaniments at all concerts.

SEEK SOLDIERS FOR PREEMPTION

Jim Cook, a pioneer Western cowboy, is in Ballinger going over territory where he worked cattle almost a half century ago. Mr. Cook says that he followed the trail from Matagorda Bay to the Canadian Northwest long before Ballinger was born, and he remembers many of the early cattle "rustlers" in this country.

Mr. Cook left here many years ago, and has been living in Arizona most of the time since. He still wears his boots and spurs, and is more at home in a saddle than anywhere else.

"I'm trying to interest a few hundred ex-service men to go with me into the Colorado valley in Arizona," said Mr. Cook "and homestead some of as fine land as there is in the United States. There are thousands of acres of it which the cattlemen have been holding for years, and which the government will grant to ex-service men under the homestead act."

Mr. Cook intimates that it might be necessary for some of the boys to live over the days of Argonne Forest, St. Mihiel, and other places where the shells left their mark, but he declared that with the prospect of the big irrigation project being put over in Arizona, it was the opportune time for the ex-service men to do some profitable homesteading.

Mr. Cook stated that he had been promoting the scheme in the Panhandle of Texas and Oklahoma and had about sixteen hundred men listed to join him in the undertaking, and that he only dropped by Ballinger to see the old country where he worked cattle almost a half century ago.

1922. Operating revenues for the 1921 period totaled \$108,000,000 and in 1922, \$87,766,000. The decrease for operating revenues was 17.61 per cent and for operating expenses, 19.38 per cent. Net revenues to the operating lines to Aug., 1922, was \$15,881,000, and to August 1921, \$16,940,000, a decrease of slightly over \$1,000,000 or 6.25. All items of operating revenues as well as operating expenses show a decrease for the period.

TEXAS RAILROADS SHOW DECREASED REVENUES

AUSTIN, Oct. 18.—Although net revenues to Texas railroads during the first seven months of the present year decreased slightly over a million dollars as compared with revenues for the same period last year, an examination of the report on railroad finances just issued by the Texas Railroad Commission shows that operating expenses for the two periods decreased two per cent more than operating revenues.

Operating revenues decreased over \$22,000,000 from \$125,000,000 in 1921, to \$103,000,000 in

MAYFIELD ON STAND IN POLITICAL SUIT

A NEW PARTY RULES

(By Associated Press)
LONDON, Oct. 19.—The coalition government of Premier David Lloyd George resigned this afternoon, and conservatives will be called on to form a new cabinet.

LONDON, Oct. 19.—The Lloyd George coalition wing received a death blow at the hands of the conservative party today. The conservative members of the House of Commons and the government ministers voted to appeal to the country as a conservative party.

This move creates the greatest political confusion and uncertainty the country has known in many years. The next move to be made is the resignation of the government leaders in the House of Commons; and Austen Chamberlain, and his associates, Lord Balfour and Lord Birkenhead, will leave the cabinet. It is expected that Premier Lloyd George will then present his resignation to the king and advise his majesty to summon a conservative leader to form a new government.

RETURNS HERE AFTER 44 YEARS

One of the distinguished visitors to the Nazarene Assembly in session in this city is Rev. P. N. Adkins, of Amarillo, who returns to Runnels county after absence of forty-four years. Rev. Adkins is getting up in years, but is healthy and hearty, and he recalls with interest some of the activities in this country almost a half century ago. He remembers quite a number of the old timers who lived at Runnels City before Ballinger was staked off, and mentions L. F. Gressett, Judge C. H. Willingham, and several others who have drifted away from Ballinger since this city drafted on the old county site for its population.

Rev. Adkins located in Brownwood in 1878, and operated a freight line from that city to Fort Concho long before Ballinger was dreamed of. He says that at that time the road crossed the Colorado river at Walthal, four or five miles below where Ballinger is now located, and that Walthal was the only settlement between Coleman and Ft. Concho.

"I was born in Tennessee," said Rev. Adkins, "and I always wanted to come West, and when I started I came as far as civilization would let me." Rev. Adkins says that he has seen as many as 500 antelopes in one bunch on the prairies around where Ballinger is now located, or at least the drove was so large that he estimated that at least that many of the prairie goats were in the bunch, and they were thick every where. He said that they were so plentiful that it was no trouble to have fresh meat whenever the freighters wanted it.

Rev. Adkins built two houses at Old Runnels and engaged in the hardware and furniture business with S. M. Davis in 1884. He built the first I. O. O. F. hall in the county, which was at Old Runnels. He was converted and baptized there. For many years he has been living in the Plains country, having enter-

CORNICANA, Oct. 19.—Earle B. Mayfield resumed the witness stand today in the litigation which seeks to prevent his name from going on the official ballots for the general election. 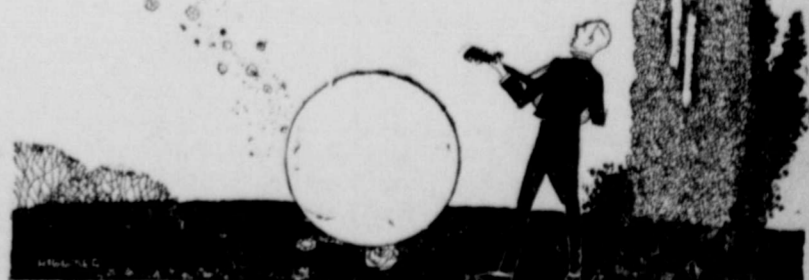

SEEK SOLDIERS FOR PREEMPTION

Jim Cook, a pioneer Western cowboy, is in Ballinger going over territory where he worked cattle almost a half century ago. Mr. Cook says that he followed the trail from Matagorda Bay to the Canadian Northwest long before Ballinger was born, and he remembers many of the early cattle "rustlers" in this country.

Mr. Cook left here many years ago, and has been living in Arizona most of the time since. He still wears his boots and spurs, and is more at home in a saddle than anywhere else.

"I'm trying to interest a few hundred ex-service men to go with me into the Colorado valley in Arizona," said Mr. Cook "and homestead some of as fine land as there is in the United States. There are thousands of acres of it which the cattlemen have been holding for years, and which the government will grant to ex-service men under the homestead act."

Mr. Cook intimated that it might be necessary for some of the boys to live over the days of Argonne Forest, St. Mihiel, and other places where the shells left their mark, but he declared that with the prospect of the big irrigation project being put over in Arizona, it was the opportune time for the ex-service men to do some profitable homesteading.

Mr. Cook stated that he had been promoting the scheme in the Panhandle of Texas and Oklahoma and had about sixteen hundred men listed to join him in the undertaking, and that he only dropped by Ballinger to see the old country where he worked cattle almost a half century ago.

TEXAS RAILROADS SHOW DECREASED REVENUES

AUSTIN, Oct. 18.—Although net revenues to Texas railroads during the first seven months of the present year decreased slightly over a million dollars as compared with revenues for the same period last year, an examination of the report on railroad finances just issued by the Texas Railroad Commission shows that operating expenses for the two periods decreased two per cent more than operating revenues.

Operating revenues decreased over \$22,000,000 from \$125,000,000 in 1921, to \$103,000,000 in

1922. Operating revenues for the 1921 period totaled \$108,000,000 and in 1922, \$87,766,000. The decrease for operating revenues was 17.61 per cent and for operating expenses, 19.38 per cent. Net revenues to the operating lines to Aug., 1922, was \$15,881,000, and to August 1921, \$16,940,000, a decrease of slightly over \$1,000,000 or 6.25. All items of operating revenues as well as operating expenses show a decrease for the period.
