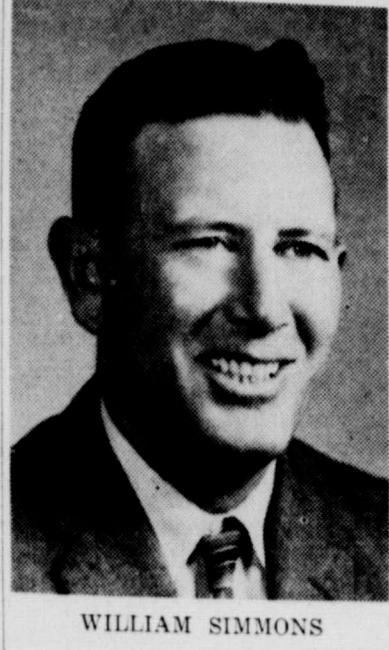
Mrs. W. S. J. Russell Honored Sunday on 95th Birthday

"STRAW VOTE" FOR PRECINCT 3 COMMISSIONER SET FOR SATURDAY

A "straw vote" will be held in Foard County Precinct No. 3 Saturday, August 31, to determine the Democratic nominee to be placed on the November ballot for the office of Commissioner, Precinct No. 3. The late C. N. (Sty) Barker had been nominated at the May primary as the nominee.

Two residents of Precinct 3, Billy Ray Dunn and Wilson Myers, have made application for the job and their names will appear on the "straw vote" ballot.

The vote will be held in the sheriff's office in the court house from 8 a. m. until 7 p. m.

The election will be conducted by Bob Thomas and Kenneth Halbert, precinct chairmen in the two voting boxes in Precinct No. 3.

Thomas and Halbert had two alternatives for determining the Democratic nominee: 1. they could appoint one of their own choosing or 2. they could have a straw vote to determine the choice of the residents of the precinct.

August 17 was the deadline for filing application to be listed on the ballot.

Although the straw vote has no legal sanction; it will assist the precinct chairmen in making their selection.

Sections of the Margaret community received about a half inch of rain Tuesday afternoon.

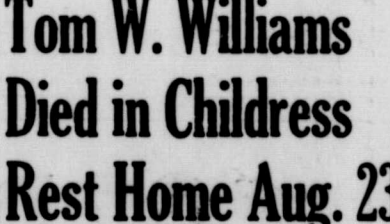

Austin, Tex. — Traditionally Austin has been the headquarters site for Texas campaigns of presidential candidates. But George Wallace's official campaign headquarters (American Independent Party) now is located 49 miles to the south, in New Braunfels.

It was moved from the capital city to within 30 minutes' drive of the office of the party's state chairman, Bard Logan of San Antonio. This move is significant—especially to those 600,000 Texans who are expected to vote for Wallace in November.

When the state executive committee of the American Party decided to replace Miss Jane Sumner of Austin with Jack Zengler of New Braunfels; named Sam Rains of Austin as treasurer, replacing Mrs. Margaret Bacon of Austin; and removed Mrs. Jewell Lemons of San Antonio from the committee, charges of "Birch-ism" were hurled. Miss Sumner ran for Congress on the Republican ticket in 1966 and Mrs. Bacon had served as secretary to Liberal Democrat Franklin Spears of San Antonio during Spears' 1966 bid for State Attorney General.

"It's not the Birch people that are causing the trouble," Chairman Logan says. "It's the anti-Birch people. They were all looking for Birchers when they were getting signatures to get Wallace on the ballot. Now that the job has been done, they seem to want to fight."

Logan said he didn't think the internecine battle would harm Wallace's Texas campaign, and Mrs. Bacon said she still intends to work for votes for Alabama's former governor.

Wallace will be in the state on Sept. 16 to speak at a \$25-a-plate fund-raising dinner in Dallas on the eve of the American party's Sept. 17 state convention here. He's also scheduled to speak to

the convention. **GUBERNATORIAL CAMPAIGNS HEAT UP** — Lt. Gov. Preston Smith's announcement that he would not go to the National Convention in Chicago because he would rather use that time to get better acquainted with delegates to the State Democratic Convention, to be held in Austin Sept. 17, came as something of a surprise.

But it's not the first time Smith instinctively has steered clear of battles within the party—as the Chicago scene was sure to be. He has gained some widespread and rather unexpected support from liberal Texas Democrats because he refused to go with Gov. John Connally, then Atty. Gen. Waggoner Carr and Speaker Ben Barnes to head off a migrant workers' march to Austin two years ago.

Smith, however, says he is serious about wanting to meet and talk to state convention delegates because he wants to command the convention. The September state convention is known as the "governor's convention." It will be interesting to see who wins control—the man who is governor now or the man who is the Democratic nominee.

There's no doubt among Republicans that the star of their state convention in Fort Worth on Sept. 17 will be GOP gubernatorial candidate Paul Eggers. Eggers is running a hard race against Smith.

CONSTITUTIONAL REVISION RECOMMENDATIONS — While Texas Democrats are taking a stormy role in nominating a presidential candidate in Chicago, a potentially historic event will be unfolding on the home front.

In a three-day Austin meeting this week, State Constitutional Revision Commission is wrapping up its final recommendations for a new Texas constitution. Sub-committees completed their

year-long studies last month. Fireworks were anticipated on these proposals:

- Four year terms for governors and all other statewide officials who now have two year terms (Recommendation would prohibit direct succession to a second term by the governor).

- Constitutional change that would also give the governor power to remove and replace appointees to boards and commissions.

- A requirement that state senate closed-door sessions on appointments by the governor be abolished.

- Authority for the legislature to instruct courts as to how they will handle appeals from state administrative agency actions.

- Provisions for county home rule and optional plans for consolidation of political subdivisions and functions within a county.

- Appointment of Supreme Court and Court of Criminal Appeals judges by the governor from a nominating commission slate of three.

- Easier access to courts for taxpayers protesting assessments. Recommendations agreed on by the revision commission must go to the legislature next year. Legislature then can submit all or any part of the recommendations to the voters—or reject them entirely.

Aside from its recommendations of minor controversial nature, commission has made a good-faith effort to tighten and streamline the constitution and chop out long-recognized dead wood.

WILDLIFE PLANS — Parks and Wildlife Commission adopted a \$17.5 million operating budget for the next fiscal year. Commission will ask the 1969 Legislature to appropriate money to reopen the fish and water-exchange pass between Corpus Christi Bay and the Gulf across Mustang Island.

Commission also set Texas duck season for Dec. 14-Jan. 1. Daily bag limit was set at four and possession limit at eight. Goose season will be Oct. 20-Jan. 12 with daily bag and possession limit of five.

Studies of the ecology of prairie chickens and ways to increase their population—perhaps enough to hunt them someday—have been authorized by the Commission for the year beginning Sept. 1.

TIDELANDS ARGUMENT AGAIN—U. S. Supreme Court has granted Atty. Gen. Crawford C. Martin an Oct. 14 requested hearing on location of Texas shoreline or the point from which Texas measures its submerged land boundaries.

Waterfowl Hunting Seasons Are Set

The Texas Parks and Wildlife Commission in a special meeting Tuesday set the waterfowl seasons and bag limits for the 1968-69 season.

The duck and coot seasons begin one-half hour before sunset each day through Jan. 12. Daily bag limit is four and not include more than two ducks, one canvasback or one head; and two mallards.

Possession limit on ducks is eight and may not include more than four wood ducks and four mallards. The daily bag limit on coots is 10 with a possession limit of 20.

The hunting season for geese and brant will begin one-half hour before sunrise Oct. 30 and continue each day through Jan. 12 with a possession limit of five.

In that portion of Texas west of U. S. Highway 81, bag and possession limit will include more of the following species than: one Ross's goose in the alternative one white-fronted goose or one white-bellied goose and the possession limit more than one Ross's goose in the alternative not more than two Canada geese or one Canada goose and one white-fronted.

Students Should Notify S. S. of Any Change in Status

School will be starting soon, and young people receiving social security benefits based on full-time attendance are reminded to notify their social security office if there will be any change in their student status.

Edwin Draughon, manager of the Vernon social security office, stated that benefits may be paid to the unmarried child of a retired, deceased or disabled worker if the child is between 18 and 22 and a full-time student at an accredited school, college or vocational institution.

Students continue to receive their checks during breaks such as the summer vacation period, as long as the break is not longer than 4 months and the student has indicated a firm intent to continue schooling when the break ends, Mr. Draughon said.

If the student's intent to resume school changes in any way or if his attendance will be less

than full time, he should notify his social security office immediately. In this way, he can avoid receiving any incorrect payments, which would have to be refunded.

For further information regarding their current or potential benefits under social security, students are advised to visit or write the Vernon social security office at 1728 Fannin Street or call Linden 2-9346.

In some parts of Europe, lamb is served traditionally on St. Bartholomew's Day, August 24. Mrs. Gwendolyn Clyatt, extension server, says supplies of lamb and veal will be increasing seasonally although this year's supplies are less than a year ago.

Game Arrests Up Over Last Year's

Arrests for game, fish and water safety violations in July totaled 1,332, a 3.9 per cent increase over the 1,282 citations issued in July, 1967.

The most numerous arrests were made for water safety violations. Of the 631 total, 375 citations were for failure to have a Coast guard approved life saving device for each person in the boat. There were 112 citations for operating a motor board without registration on board.

Fishing violations totaled 614 with 574 of these being fishing without a license.

Hunting violations numbered 69 with the most numerous being for discharging a firearm on a public road, hunting without a license, killing or possession of deer in closed season, and hunting at night.

There were 18 commercial fishing violations.

Fines and court costs accrued to the state were \$19,820.92.

A Tax Audit

If your tax return is selected for audit, there is no reason for panic—on the other hand, there is no reason for you to be enraged or feel "picked on." Internal Revenue audits several million returns each year after the computer has corrected the math and taken umbrage at a number of careless errors. The Internal Revenue agent is a well-trained, professional employee. A part of his training is to be fair. He has the same responsibility for seeing that you get extra deductions that you missed as he does for seeing that the government gets all the tax due from you. A large part of the tax audits result in the taxpayer verifying his questioned items and receiving no change in his tax liability. About 7 per cent of those audited receive a refund, due to the Internal Revenue agent finding additional tax credits or deductions.

So—gather your records, review your return with the agent in a business-like manner. If you don't agree with his findings, exercise your appeal rights.

Tips Count as Income for Social Security

Do you depend on tips to boost your earnings? These cash tips can also mean higher social security benefits for you and your family, but only if you report them.

Since social security benefits to you and your family are based on your earnings, the higher your reported earnings, the higher your future benefits. For some workers, the amount of their social security benefits could be almost doubled if social security credit can be given for the amount of their tips.

If you receive cash tips of \$20 or more in a month while working for one employer, these tips can be counted with your other earnings for social security. The procedure is simple; just give your employer a written record of your cash tips by the 10th of the month following the month when you received them. And make this report to your employer on time; a late report can mean that you will be liable for the delinquent taxes as well as penalties and interest that may be assessed by the Internal Revenue Service.

If wages due you will not cover the amount of the social security tax on those tips, give your employer the tax money along with the report of your tips. Your employer will include the tips on the report he makes to the Internal Revenue Service every quarter, and will send in the social security tax.

The best way to keep track of your tips is to write them down daily, and your social security office has a special booklet No. 5635 especially for this purpose. The social security office is located at 1728 Fannin Street in Vernon.

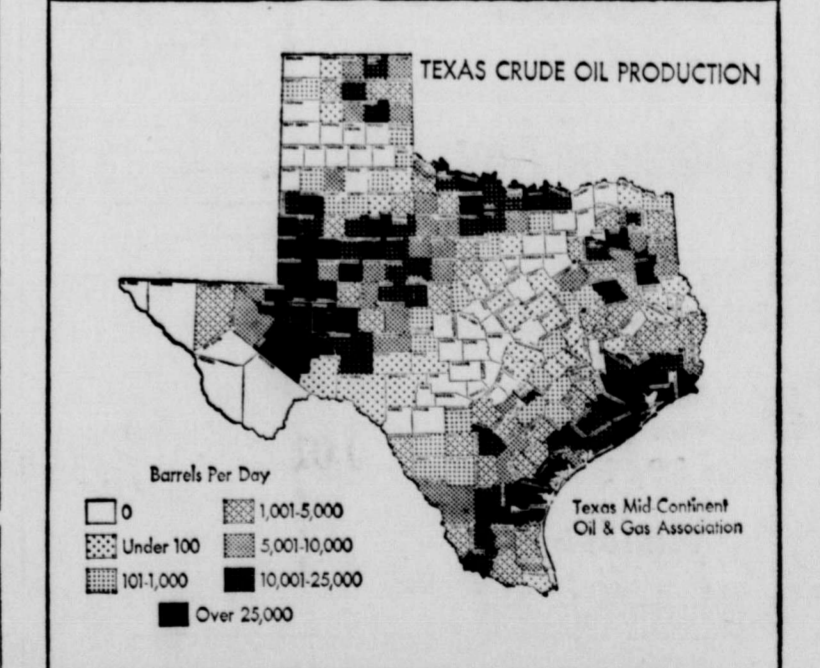

Declaration of Estimated Tax

Individual taxpayers who previously filed declarations of estimated federal income tax for 1968 must now revise their estimates to reflect the new surcharge tax recently enacted into law, Ellis Campbell, Jr., IRS District Director for Northern Texas, said this week. He also reminded taxpayers to file Form 1040 ES, declaration of estimated tax, if their federal income tax for 1968 will exceed their withholding by \$40 or more.

Mr. Campbell said a new 1040 ES worksheet is now being developed to aid taxpayers in computing the amount of revised estimated tax. It will be mailed to taxpayers at the time they are billed for their third quarter installment due September 15. The worksheet will also be available

at IRS offices around the first of September.

The new tax law imposes a 10 per cent annual surcharge tax retroactive to April 1 on individual tax returns. This means, Mr. Campbell said, that most taxpayers who file on a calendar year basis will be required to pay a 7 1/2 per cent surcharge on federal income tax covering income received during 1968.

Taxpayers who previously based their 1968 estimate on tax paid during 1967 can no longer use this method after Sept. 15, Mr. Campbell said. The law now requires individuals to use "anticipated income" as the basis for computing estimated tax.

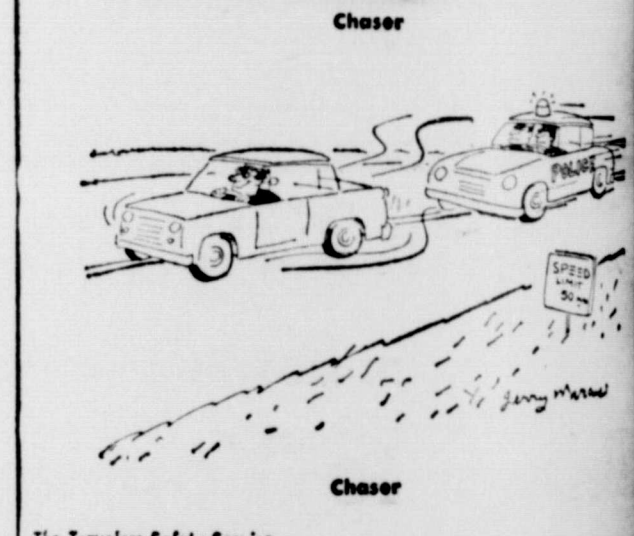
A new Form 1040FY will be sent to fiscal year taxpayers in time to file and pay the surcharge

tax by the due date. Mr. Campbell said. Form 1040FY will be available at IRS offices August.

Lawn Mowing Is Important

It is best to remove more than one-fourth to one-third of leaf surface at any one time when mowing the lawn, says E. J. Janne, extension horticulturist. Removing large amounts of leaf surface will reduce the plant's ability to produce food and can seriously weaken it. 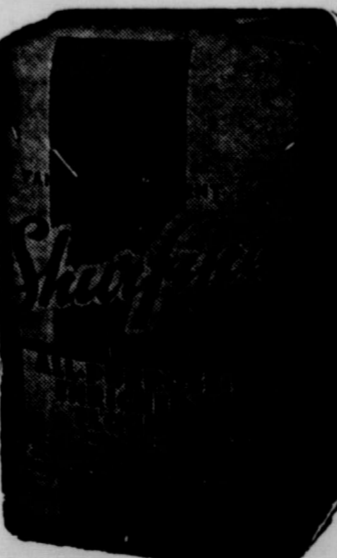
