Burleson Files For Re-Election

Congressman Omar Burleson, who represents the 17th District of Texas in the United States House of Representatives, has announced for re-election. He has filed for a place on the ballot in the Democratic Primary Election on May 4, 1974.

By action of the Texas Legislature, which was required by law to redistrict the State following the 1970 census, and subsequent court action, Lynn County is now a part of the 17th Congressional District.

Burleson was elected to the 80th Congress from the 17th District and has been re-elected to each succeeding Congress. He is a member of the Ways and Means Committee, considered to be the most powerful and prestigious in the House.

The Early Heritage Club of Tahoka have planned a Bake Sale for Saturday, January 19, at Parker Pharmacy. Everyone is urged to come and buy some of these goodies and at the same time help the local club.

76% Of State And County Taxes Paid

Over 76 percent of State and County Taxes have been paid since October 1, 1973 through December 31, 1973. This is above collections for the same length of time last year.

1973 tax payments made through January will not be charged a penalty. However a penalty will be applied to all tax payments made after January 31, 1974.

VEHICLE REGISTRATION

Lynn County residents may begin registering their vehicles on February 1, 1974.

Registration slips mailed to each vehicle owner from the highway department, will be all that is needed in order to register your vehicles.

If you have not received the registration slips from the highway

department, titles and 1973 license receipts will be needed in order to register vehicles.

VOTER REGISTRATION

Lynn County residents who registered in 1972 or 1973 will not be required to register in 1974 in order to vote.

Any one that has moved from one voting precinct, to another precinct, must have their registrations changed to their new address, five days prior to an election, before being eligible to vote in the new precinct. The necessary forms may be obtained at the county tax office to make a change of address.

All persons including eighteen years of age must register thirty days prior to an election in order to vote in any election.

Cotton Harvest Nearing Completion

The South Plains cotton harvest is now virtually complete, according to Paul R. Dickson, in charge of the Lubbock Cotton Classing Office of the U.S.D.A. However, ginning, sampling and classing continue because of the volume of cotton remaining in trailers and in ricks.

Samples from 2,203,000 bales had been classed at the Lubbock, Brownfield, Lamesa and Levelland offices through Friday, January 11th.

Personnel at the four offices tested and classed samples from 150,000 bales during the week ending the 11th.

Quality of cotton continued excellent and this crop continues to be one of the highest quality crops ever produced on the South Plains.

Grades 31 and 41 continued the predominant grades at Lubbock, making up 71 percent of all classed. Grade 31 made up 17 percent, Grade 41, 54 percent, Grade 32, 12 percent and Grade 42, 9 percent.

Staples continued predominantly 30 to 32. Sixty-three percent had staple lengths of 31 and shorter and the remaining thirty-seven percent stapled 32 and longer.

Micronaire readings also continued excellent. Seventy-eight percent of all cotton tested at Lubbock had micronaire readings in the premium range of 3.5 to 4.9, 6 percent was in the very high range of 5.3 and above.

The Agricultural Marketing Service of the U.S.D.A. reported slow trading on the Lubbock market the past week. Prices were \$5.00 to \$10.00 per bale lower. Demand continued strongest for cotton with staple lengths of 31

and longer but was strong for cotton with staple lengths of 29 and 30. Prices ranged from 3000 points over the Government Loan for short staple cotton up to 4600 points over the loan for long staple cotton. Typical lots were bringing an average of 40 cents per pound over the loan and were selling in the price range of 55 to 65 cents per pound.

Average prices paid for the most predominant qualities in the 3.5 to 4.9 premium micronaire range were: Grade 31, Staple 30-53.65 cents per pound, Grade 31, Staple 31-60.40, Grade 31, Staple 32 - 64.40, Grade 41, Staple 30-52.70, Grade 41, Staple 31-59.25 and Grade 41, Staple 32-62.95.

Cottonseed prices were steady and farmers received \$95 to \$110 per ton.

"Heavy" Nelson Asks Re-Election

L.K. (Heavy) Nelson announces he is a candidate for re-election as County Commissioner, Precinct 4.

He says in his statement: "I sincerely appreciate all past favors and the trust you voters have placed in me in the past. If you see fit to elect me your commissioner for another term, I will do my best to conduct the affairs of our precinct and county in a sound and business-like manner, to work for improvement of our roads, to deal fairly with everyone, and to render the best service that I possibly can. I will deeply appreciate your support and vote."

Mr. Nelson has been a resident of Lynn County most of his life and of Precinct 4 for more than thirty years.

The Lynn County Highway Department finished placing the 55 mile per hour speed limit signs January 15, and the new speed limit will take effect Sunday, January 20 in Lynn County and most part of the state except where prevailing signs have not been changed. This is one of the first energy crisis measures that will take effect.

Most service stations in Tahoka have been cut anywhere from 10 percent to 20 percent making a real energy shortage in Tahoka with most stations in Tahoka limiting a 10 gallon sale to most customers, with gas prices rising from 8 to 9 cents per gallon.

Taking a random survey, the Lynn County News found that Chancy and Son Service Station had been cut 16 percent overall with a 30 percent cut in fuel in January. According to Bill Chancy, gas prices have risen more since May than they have in the last 26 years. Bill said that he used to sell two gallons of gas and buy a gallon of milk and now it takes seven gallons. His gas prices have risen 9 cents per gallon and he is limiting customers to 10 gallons.

Chestnut Mobil Service said his gas is up at least 9 cents per gallon with a cut anywhere from 10 percent to 20 percent de-

pending on what happens the next day with all customers limited to 10 gallons.

Jolly Texaco said they have been receiving 89 percent of what they sold last year but weren't sure what would happen in the next few days. They are giving fill-ups, but can only sell so many gallons per day, then close up for that day. Their prices are up 9 percent also.

Ruby Renfro at Renfro Conoco says that the biggest fuel hike is in propane with propane tripling from last March. Last March they were selling propane at 11½ cents per gallon and are now having to sell it at 33 cents per gallon. They are also giving fillups on gas but limiting their sales a day to so many gallons and then closing up. Their gas is also up around 9 cents per gallon.

H.B. McCord said that they were limited on Phillips gas to 5 percent below what they sold in 1972 with gas prices up 8 to 9 cents per gallon. Their propane is also up to 33 cents per gallon.

All service stations were not checked but it looks like this gives a good indication of a real energy shortage in Tahoka and Lynn County, with local stations not making any more profit on the gas than usual.

Board Orders Trustee Election

The Tahoka I.S.D. Board of Education met Thursday, January 10, for its regular monthly meeting and ordered the annual Trustee Election for Saturday, April 6, 1974, to be held, at a site to be determined, during the hours of 8:00 a.m. to 7:00 p.m. The terms of Maurice Huffaker, Othell Meeks and Kenneth Turner expire. Candidates may file at the office of Mrs. Peggy Elliott, in the Fenton Building, through March 6. Absentee voting will begin at Mrs. Elliott's office March 18, and extend through April 2.

In other actions the Board extended the contract of the superintendent through June 30, 1977 and approved the employment of two new teachers. Miss Betsy Trapp, a December graduate of West Texas State University was employed to teach in the fifth grade, replacing Mrs. Garland Thornton, who has moved to Sweetwater with her family. Also employed was Mrs. Marilyn Brown, of Lubbock, who will teach Spanish and English in the High School. Mrs. Brown is a graduate of Texas Tech. She has taught previously in the Lubbock Schools.

Various reports concerning the operation of the schools were heard. Current enrollment

figures were 1,172, up from 1,120 at a comparable time in 1973. Twenty-six new 5-year-olds have begun the kindergarten program at mid-term as a result of provisions of the 63rd Legislature.

Superintendent Harold Reynolds was in Austin for the annual Mid-Winter Conference for Texas School Administrators and was not present for the meeting. Members attending were: Dan Curry, President; Robert Warren, Vice President; Othell Meeks, Secretary; J.D. Atwell, Maurice Huffaker, Dayton Parker and Kenneth Turner. Also attending was Mrs. Peggy Elliott, Director of Business Affairs.

Thomas Brothers On Dean's List

BILL GRIFFIN SAYS



Livestock owners and animal agriculturists from throughout Texas and several Latin American countries are expected to participate in the first Texas Animal Agriculture Conference, January 21-24 at Texas A&M University.

The conference will open with the Latin American Animal Ag-

riculture Symposium January 21. It will be followed by five short courses on beef cattle, swine, dairy cattle, horses, forages and pastures on Tuesday and Wednesday. The final day will feature a cattlemen's tour.

Conference sessions will be in the J. Earl Rudder Center on the Texas A&M campus.

Dr. Jack K. Williams, president of the Texas A&M University System, will welcome participants at 9 a.m. Tuesday in the Center's Auditorium. Dr. L.S. "Bill" Pope, associate dean of agriculture, will discuss "New Horizons for Texas Animal Agriculture."

Featured speaker for the general session Wednesday will be Dr. John A. Hopkin, head of A&M's Department of Agricultural Economics and Rural Sociology, who will discuss "The World Agriculture Outlook."

For the beef cattle short course, major speakers will include Dr. J.N. Wiltbank, widely recognized authority in the field of beef cattle reproduction, who is joining the Texas A&M staff; Dr. Robert Totusek, Oklahoma State University animal science professor; Dr. M.B. Wise, Animal Science Department head at Virginia Polytechnic Institute; Craig Ludwig of the American Hereford Association; Clarence Burch, Oklahoma Angus breeder, and others.

The swine short course will include discussions by such noted speakers as Dr. M.R. Wilson, College of Veterinary Medicine, University of Guelph, Ontario, Canada; Dr. James Bailey, Extension veterinarian from South Dakota; Dr. L.L. Christian of Iowa State University; and Dr. T.D. Tanksley, Dr. Howard Heshby and others of Texas A&M, who will discuss research findings.

Two of the country's leading equine scientists, Dr. John P. Baker of the University of Kentucky and Dr. R.G. Loy, a consultant from Phoenix, Arizona, will discuss nutrition and reproduction during the horse produc-

tion short course. Speakers also will include Dr. William C. McMullan and Dr. T.L. Bullard of the Large Animal Clinic, College of Veterinary Medicine, Texas A&M; Extension specialists and others.

Addressing joint meetings of the dairy and pasture short course groups will be Dr. M.E. McCullough, professor and head of the Experiment Station at the University of Georgia; Jack Carpenter, manager, Tufts Holstein Farms, Dallas; and Dr. J.M. Hellman, manager and resident veterinarian, Barnes Jersey Farm, Bryan.

Featured speakers for the dairy short course also will be Dr. Joe Gray Peeples of the Town and Country Animal Clinic at Plainview; S.R. Donaho, Jr., of Floresville, operator of Donaho-Holstein Farms; Paul Koonsman, a dairy service specialist from Lubbock; Bobby Traweck of the Cow-Creek Farm, Dublin; and others.

For the pasture short course, major speakers also will include Aaron Baxter, agronomist for Texas Power and Light Co., Dallas; Wells Burton, Longview farmer and forage producer; Dr. E.C. Holt, Texas Agricultural Experiment Station professor in forages; and Dr. E.C. Bashaw, geneticist for forage grasses at Texas A&M.

The livestock and grass tour January 24 is planned for Latin American visitors.

Soil Insect Control Studied

Scientists in nine states and a province in Canada are combining forces to devise new strategies for controlling soil insects that cost farmers and homeowners millions of dollars each year.

Goal of the four-year regional research project is to find ways to manage soil insects without extensive use of pesticides.

At the present time, pesticides are the only weapons available and many of these are being banned. In addition, pests are developing resistance to the chemicals being used.

In the Mid-West, research will be concentrated on corn rootworms, a major pest. The cooperative project also will cover cotton and other major crops.

The Environmental Protection Agency has contributed \$300,000 and USDA's Cooperative State Research Service another \$185,000 to support the research.

They Like That Corn
About 80 percent of the 5.4 billion bushels of corn produced in the U.S. last year was fed directly to livestock.

Mormons Started Irrigation
First irrigation of crops in the U.S. was begun by the Mormons in Utah back in 1847.

SOIL CONSERVATION NEWS

A new conservation farming technique saved an estimated 1.8 million gallons of tractor fuel in Texas this year, reports an official of the U.S. Soil Conservation Service.

Edward E. Thomas, state conservationist for SCS in Temple, said minimum tillage farming systems eliminated an average of five tractor trips per acre during 1973 on about 354,000 acres of cropland.

"A tractor burns about a gallon of fuel per acre for the average farming operation," Thomas said. "Eliminating five tractor trips per acre reduces fuel consumption by five gallons of gasoline or diesel per acre."

To haul 1.8 million gallons of fuel in railroad tank cars would require a train nearly two miles long.

Thomas predicted even greater fuel savings in the future as more farmers turn to the new system.

"The practice is still a long way from being perfected," Thomas admitted. "But we've come a long way in the last 3 years. If similar gains can be made in the next few years, conservation farmers will be able to make a major contribution in helping ease the energy crunch."

With minimum tillage, crops are planted directly into the stalks and leaves left over from the previous crop without prior land preparation. Herbicides are used to control weeds, cutting out several tractor trips over a field. Some farmers report minimum tillage saves as many as 10 to 12 tractor trips per crop. A statewide average is about half that amount.

The surface cover of dead leaves and stems greatly reduces wind erosion, dust storms, and air pollution. The practice is equally effective in preventing water erosion and sedimentation

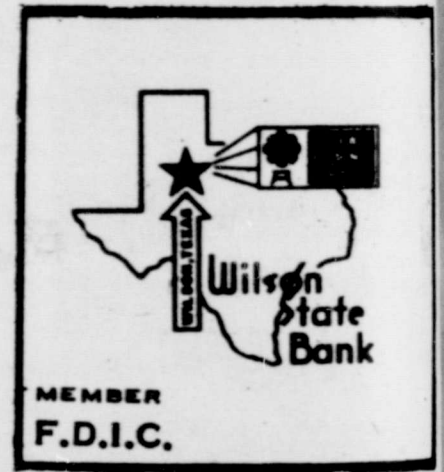
from cropland. Thomas said one of the big problems with minimum tillage is that surface-applied herbicides used to control weeds don't always work properly on all soils in Texas. He said better, more dependable herbicides adapted to mulch farming are needed.

Thomas credited the state's conservation farmers with helping develop minimum tillage farming systems.

"This practice has evolved by trial and error during the last few years," Thomas said. "SCS agronomists, researchers, chemical companies, conservation district leaders, and innovative farmers have all had a part in developing the measure. We only hope continued progress can be made in this field."

With 20 million acres of cropland in Texas, long-term fuel saving possibilities by improved methods of minimum tillage are huge, Thomas pointed out.

COTTON TALKS

FROM PLAINS COTTON GROWERS, INC.

Although there are still a lot of unknowns, general expectations are that U.S. cotton production in 1974-75 will be up to 14.5 or 15 million bales from the projected 13 million bales in 1973-74, according to Donald A. Johnson, Executive Vice President of Plains Cotton Growers, Inc., "but for a number of reasons, this does not necessarily foretell a corresponding de-

crease in cotton prices," he adds. "For one thing," he notes, "there is every indication that the demand for cotton, both foreign and domestic, is on the increase."

Exports of cotton from the U.S. in the 1974-75 marketing year are now forecast at around 6 million bales, and cotton consumption by domestic mills is being projected in some quarters as high as 8

million. If these figures are realized Johnson points out, even a 15 million bale crop would add only 1 million bales to the expected U.S. carryover on August 1, 1974 of 3.8 million. "And a 4.8 million bale carryover in this country is far from excessive."

Demand in the U.S. and abroad is getting a boost from the scarcity of petrochemical stocks for the production of synthetic fibers. Also there is a noticeable return of preference for the natural fiber among consumers. And of course the increase in demand for textiles of all constructions is also of benefit.

World cotton consumption made a significant advance during the past two years, rising by nearly 2.4 million bales, without the influence of synthetic fiber shortages. This is the best rate of increase of any two-year period since 1965-66 and compares with an annual growth rate of only 570,000 bales during the previous five years.

With competing fibers having problems in meeting demand owing to petrochemical allocations, and with consumer preference for cotton continuing strong, another healthy increase in cotton consumption may be expected in 1974-75 Johnson believes.

It should also be kept in mind that the "general expectations" of a 14.5 or 15 million bale crop in the U.S. for 1974-75 is an "expectation" and nothing more, he says.

On the High Plains for example, which this year at 2.7 million bales will account for over 20 percent of the nation's output, a 1974-75 increase becomes more unlikely with each day that passes without bringing badly needed moisture, and a sizeable decrease is a distinct possibility. One-third of the area's cotton acreage, or more, is grown without the benefit of irrigation and normally does not produce good yields unless there is a reasonable amount of underground moisture at planting time. While 1973 underground moisture was excellent, it is almost nonexistent at this point of 1974 and long-term weather records offer little hope that it will be replaced by planting time in May. At least another fourth of the High Plains cotton acreage has only

light irrigation water, and is therefore partially dependent on rainfall.

"Without wishing to be pessimistic," Johnson says, "given present conditions it is only reasonable to assume that, areawide, High Plains yields in 1974 may be well below the estimated 482 pounds per acre for this year. And if High Plains production should drop significantly, a U.S. crop of 15 million bales in 1974-75 would hinge largely on major increases in other areas of production."

Federal Land Bank News

Mr. Jay Dee House, Manager of the Federal Land Bank Association of Tahoka, announced today that the Federal Land Bank of Houston closed during the year 1973, \$254,130,000 in loans, the largest volume of loans closed in the Bank's 58-year history. The previous record high for loans closed in a single year was in 1972 when the Bank closed more than \$164,000,000 in loans.

The increased demand for long-term credit is attributed to an increase in number of sales of farm and ranch properties. An increase in farm commodity prices has prompted some farmers and ranchers to expand their operations in the past year; however, the energy crisis and other shortages may slow down this expansion in 1974. He predicted that the demand for long-term credit would continue at a high level in 1974.

The Federal Land Bank of Houston makes farm and ranch real estate loans throughout Texas and on December 31 had more than 838 million dollars in loans outstanding to over 35 thousand farmers and ranchers. The Federal Land Bank Association of Tahoka makes and services loans in Lynn, Garza and a part of Borden Counties. Officers and directors of the association are Fred McGinty, President; Avery Moore, Jr., Vice President; L.A. Forsythe, Joe D. Unfred and J.D. McCampbell.



Outsiders In Schoolyards

Eddie, a high school dropout, liked to hang around his old alma mater, getting into various kinds of mischief. One day he was picked up by police on a charge of "loitering on school grounds."

To Eddie, this was foul play. After all, wasn't the schoolyard a public place—free for all?

But the court found him guilty as charged. As one judge put it: "Public school premises are not free to any and everyone, like a public street or public park. Public school premises are dedicated to the use of persons eligible to attend the schools, their officers, teachers, and employees."

A number of communities, leery of troublemakers, have passed special anti-loitering laws placing schoolyards off limits to those having no legitimate business there. And most courts have upheld the validity of these laws.



On the other hand, courts have also taken a tolerant view of what is "legitimate business." One case involved a 17-year-old boy, arrested after dark on the playground of a junior high school. At a court hearing, he explained that he had been waiting to take his younger sister home from a class party.

The judge decided this came under the heading of legitimate business, and tossed the case out of court.

Furthermore, an anti-loitering law must not exceed constitutional limits. In another case, an ordinance forbade loitering within 250 feet of any school—with no exceptions.

But this law, when challenged in court, was held to be unconstitutional. The court thought it was unfair to punish someone simply for relaxing in the vicinity of a school. Lawmakers had no authority, said the court, "to denounce mere inaction as a crime," adding:

"The majority of mankind spend a goodly part of their waking hours in idling the time away. The ordinance is an unreasonable restraint upon personal liberty."

Cotton Research Pays Off

The idea of breeding plants that are resistant to diseases developed from research on cotton wilt disease in the early 1900's.

Two Cotton Crops A Year Being Sought

Growing two cotton crops a year instead of just one is the goal of research under way in Missouri.

Plant breeders already have developed some new short-season varieties that could be grown during the interval between normal crops, reports the National Cotton Council.

While further testing is required before the varieties are ready for release, scientists hope they'll be perfected within a year or two. The new varieties produce short, coarse fibers which could be used in disposable clothing.

Other scientists involved in the project are working on cultural practices and harvesting machines to handle the new type cotton.

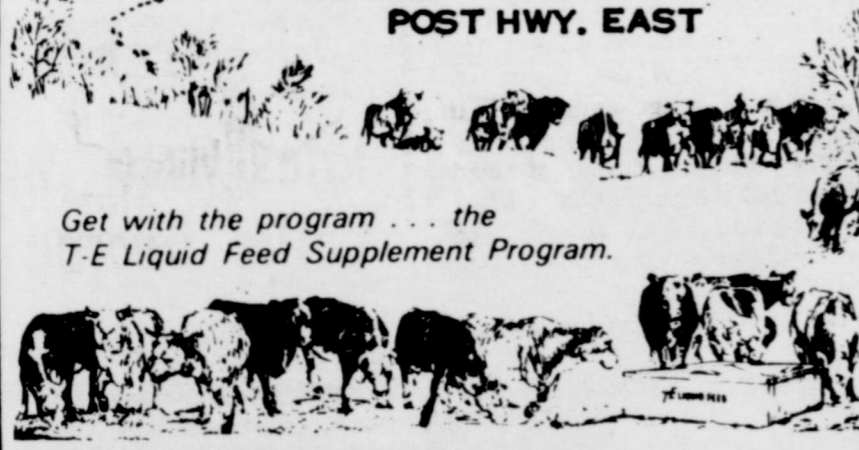

The winners in the boys' division (see brackets) were: Frenship - First; Tahoka--Second; New Home--Third; Slaton--Consolation.

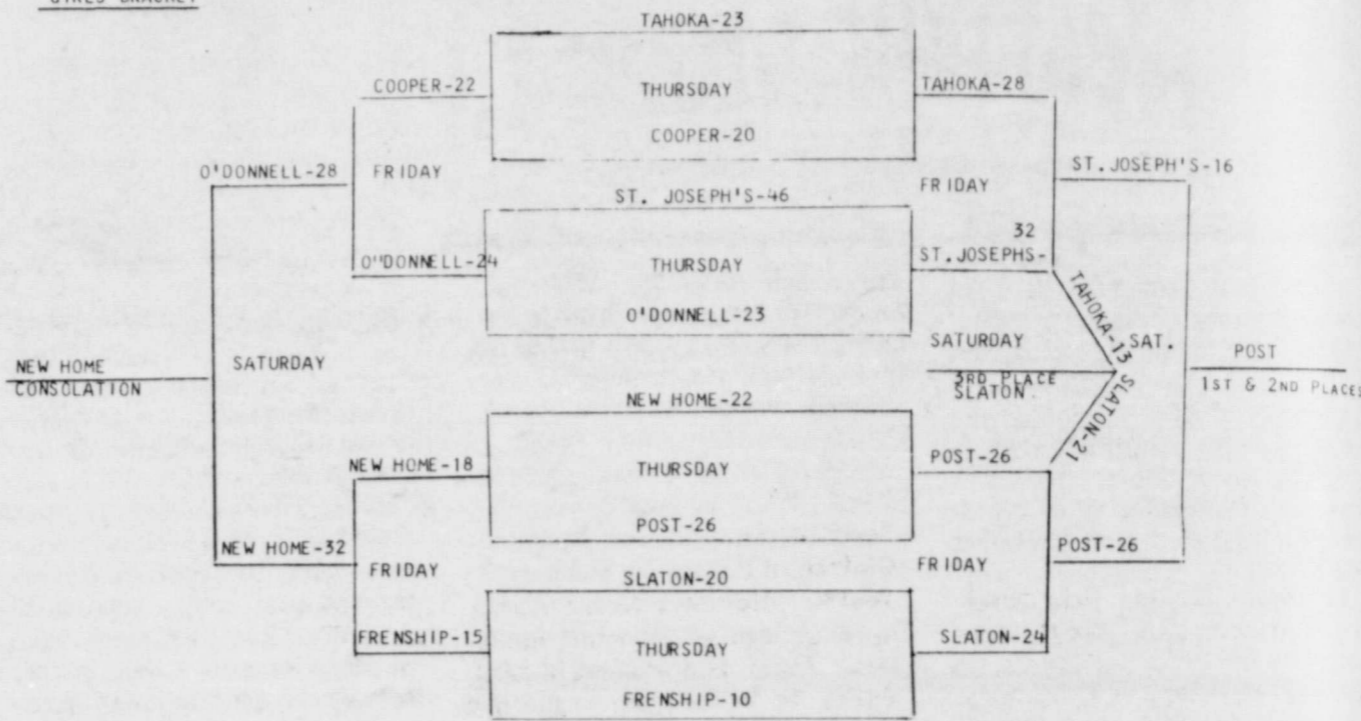
The winners in the girls' division (see brackets) were: Post--First; St. Joseph's--Second; Slaton--Third; New Home--Consolation.

Considerable effort was put forth by the administration and coaching staff of the Tahoka Schools to make the basketball tournament a success.

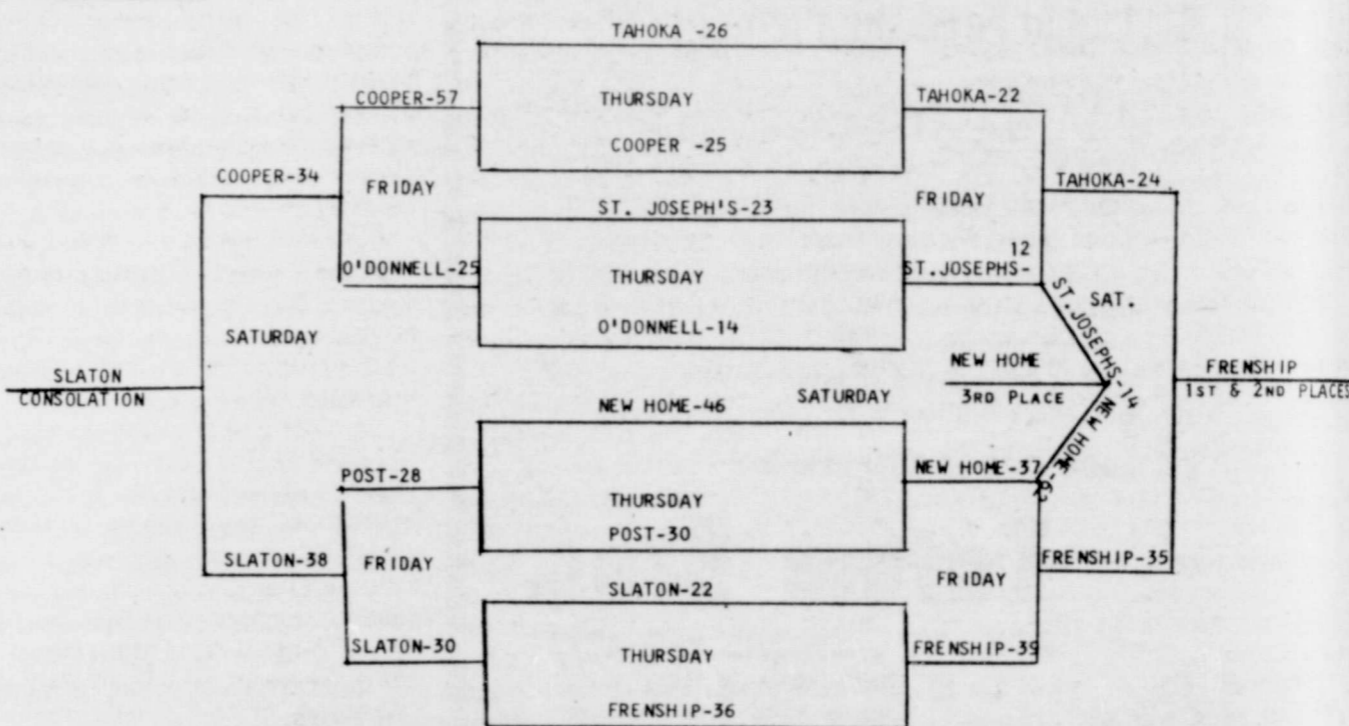

Carolyn Haley Says...

I had an inquiry about electronic cooking and thought some more of you may have the same questions.

What is electronic cooking? Cooking in an electronic oven is done with microwave energy. Microwaves are a type of high frequency radio energy which can produce heat in food. It is referred to as electronic energy.

When electronic energy comes in contact with a substance it is either reflected, goes through, or is absorbed. Only when the energy is absorbed is heat produced. The energy is reflected from metal, thus it bounces away from the walls of the oven and the metal oven door, and they don't get hot. It goes through substances such as air, paper, glass china, pottery and plastics. But electronic energy is absorbed and produces heat when it comes in contact with food. Thus, electronic energy passes through paper, glass, pottery, and plastic cooking utensils, but heat is produced when the energy comes in contact with the food.

Electronic energy causes instant heat in food from all sides, up to a depth of about 2 1/2 inches. Then the heat continues through the food by heat conduction. Because instant heat is produced in food, cooking is extremely fast. You cook with time instead of temperature, in minutes instead of hours.

The absence of heat eliminates the need for use of hot pads.

There is no danger of a burn from the microwaves, since the range will not operate until the door is closed and the timer switch turned on.

Food may be cooked and served in the same utensil, thus eliminating washing pots and pans.

Because cooking time is a fraction of that required in ordinary methods, energy consumption is lower.

Cooking with extreme speed retains the natural moisture and flavor of foods. Certain important food elements which are ordinarily destroyed by long cooking are preserved by the speed of electronic cooking.

Ease of cleaning is another desirable feature. Foods that spatter can be easily wiped off with a damp cloth, because spattering does not burn onto a cool wall.

Are you thinking about purchasing an electronic range? Might be something you would want to add to your kitchen.

RECIPE OF THE WEEK

Pork Chop Spanish Rice

- 5 pork chops, 1/2 inch thick
- 2 tablespoons shortening
- 1 teaspoon salt
- 1 teaspoon monosodium glutamate
- 1/2 teaspoon chili powder
- Dash pepper
- 3/4 cup uncooked long-grain rice
- 1/2 cup chopped onion
- 1/4 cup chopped green pepper
- 1 1-pound 12 ounce can (3 1/2 cups) tomatoes
- 5 green pepper rings
- 1/2 cup shredded sharp process American cheese

Trim excess fat from chops. Slowly brown chops in melted shortening about 15 to 20 minutes; drain off excess fat.

Combine salt, monosodium glutamate, chili powder, and pepper; sprinkle over meat. Add rice, onion, and chopped green pepper. Pour tomatoes over. Cover and cook over low heat, 35 minutes, stirring occasionally. Add green pepper rings and cook 5 minutes longer, or till rice and meat are tender. Sprinkle with cheese. Serves 5.

Space Spinoff Could Boost Honey Supply

Applying space technology to the beehive could increase the nation's dwindling supply of honey.

A massive steam sterilizer originally designed to assure germ-free equipment in spaceships has been successfully used by entomologists to control bee diseases.

The unit was adapted to treat beehive equipment by dispensing controlled amounts of ethylene oxide, a gas frequently used to sterilize hospital equipment. Earlier lab tests had showed the gas' potential effectiveness in controlling bee diseases, and use of the big unit proved it commercially feasible.

Besides sterilizing hives against bee disease, the treatment also destroys eggs of the wax moth—a pest that causes enormous losses in bees and honey each year.

Researchers report the treatment is far more economical than the standard remedy of burning infected hive equipment.

Like many agricultural crops, honey is in short supply worldwide because of adverse weather combined with increased consumer demand.

U.S. production of honey amounted to 215 million pounds in 1972 compared with 242 million in 1965.

Phebe K. Club Met Tuesday

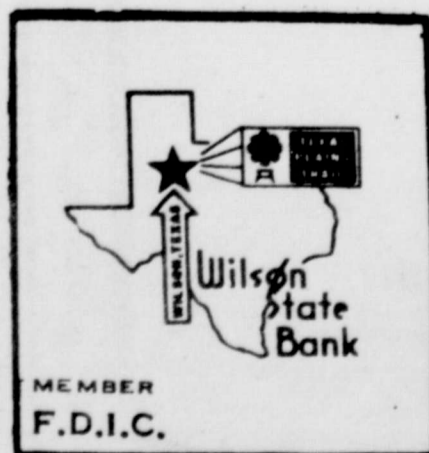

100,000 Bale Decline . . . Citrus Projection Unchanged . . . Milk Production Increases Slightly.

A 100,000-bale decline in Texas' 1973 cotton crop is noted in the Dec. 1 cotton crop estimate from the Texas Crop and Livestock Reporting Service. Even so, it is still the largest crop since 1961.

The Dec. 1 estimate is 4,700,000 bales; the 1961 crop turned out to be 4,754,000 bales.

Yield is expected to average 410 pounds of lint per acre compared with 408 pounds in 1972. Harvest acres are estimated at 5,500,000 compared with 5,000,000 acres in 1972.

Weather conditions on the High Plains have been excellent for harvest of the crop there. Some cotton has yet to be harvested in the Rio Grande Valley. Many farmers there have given up hope of salvaging the crop and are shredding stalks and plowing whenever field conditions permit. Some areas in the Blacklands were also continuing to have weather problems in harvesting.

Yield and production prospects on the High Plains have been and continue to be excellent. Grade staple and micronaire are considered unusually good.

The Nov. 1 cotton estimate was 4,800,000 bales for Texas.

CITRUS prospects in the Lower Rio Grande Valley continue unchanged from a month ago. The 1973-74 citrus crop for the state is now forecast at 20,500,000 boxes. This is seven per cent above the production of last season.

Grapefruit production is expected to total 12,500,000 boxes, six per cent above the 11,800,000 boxes produced last season. Early and mid-season oranges are forecast at 5,400,000 boxes, eight per cent above the 5,000,000 boxes produced last year.

Valencia oranges are forecast at 2,600,000 boxes, an increase of eight per cent over last year's 2,400,000 boxes.

Processing fruit increased during the month as processing plants started operating on a volume basis.

Trees remain in excellent condition and soil moisture is adequate.

Nationwide, a record crop of 68,000,000 boxes of grapefruit is expected for the 1973-74 season.

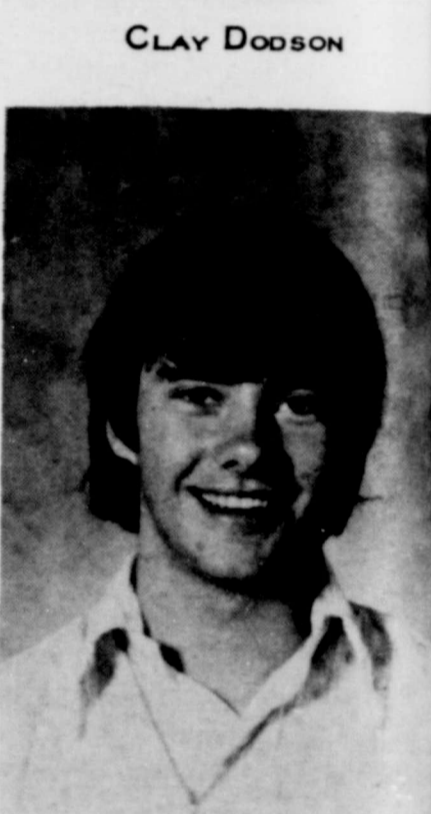


