





BATTLE AT ANTLERS. THE NEWS IN BRIEF.

LOCKE'S RESIDENCE RIDDLED WITH HAPPENINGS FROM VARIOUS PARTS BULLETS BY THE MILITIA.

Five of the Locke Men Return the Fire. Incidents Reduced From: Columns to Fifteen Hundred Shots Exchanged. Five People Injured and Many Narrow Escapes-Great Excitement.

PARIS Tex., March 29.-The Choctaw in a nude condition in a closet in the feud has resulted in blood. A sharp shows up at Martinsville, Ind. place at Antlers at 2:30 yesterday ev ing and for 30 minutes a storm of leaden hail fell about the town.

At that hour 78 militiamen suddenly debauched from the woods into and charged down upon the residence of Dick Locke, the leader of the national party and opened fire upon it.

got into his house when the fusilade him. upon it began. Locke, with five men, returned the fire from the upper story. Fully 1500 shots were fired and every window was shot out and the walls flew far and wide and terror and consternation prevailed throughout the little town.

Everybody was uneasy. No one knew who was safe, with four score half drunken infuriated Indians, armed to the teeth with the smell of blood in their nostrils. Minutes seemed hours Loss, \$40,000. and every heart went out to Locke's cooped up in their home, which was being riddled with Winchester balls.

In Locke's house three men were found wounded. Mak Hill was shot through the shoulder, wound painful, but not necessarily dangerous. John Worcester and Solomon Homer, shot in head, serious wounds. Of the militia Solomon Battiste was shot through the arm and in the side, mortally wounded. Three others had flesh wounds. Locke's little daughter had her hair burned as by a bullet, as she was going up stairs with her mother's baby in her arms. A ball passed through Locke's hat and his son's arm was grazed. It is said that his children were shot as they endeav-engaging in a wrestling match. ored to go from the residence to a cabin in the yard.


