### FEED CATTLE ON PLAINS

#### BURNETT BROS. COMPLETE A SUCCESSFUL TEST

Baby Beef Direct from Texas Ranch Sells Here at \$7.80 —Kafir and Maize in a 380 Ton Silo.

Breeding was the only business of cattlemen on the Plains country of Texas until a few years ago. Recently feed production has increased there, and now the stockmen of the plains district are beginning to finish beef animals for immediate slaughter. That this can be done successfully is the conclusion of Burnett brothers of Terry county, Texas. They marketed here this week 120 head of 463 pound steers and heifers, coming yearlings, at \$7.80, the top for that class.

"This experience" said John Barnett, one of the brothers, in reporting the sale, "has led us to decide to finish as well as raise high grade cattle. Our top sale here marks the end of an experiment with us. It was mighty satisfactory, proving to us that we can make money finishing stock on our cheap land. Our land ranges from \$5 to \$15 per acre in value. We can get an abundance of water at a depth of 50 feet, and have a climate of sunshine and no mud, two very essential factors in cattle feed

ing. We can raise kafir corn and milo maize, splendid feeds for fattening cattle.

"Last year we built a silo of 380 ton capacity, and filled it with kafir corn and milo maize, then we ground milo maize which we mixed with the silage, and it was on this ration that these baby beeves were fattened. There is no better feed. In no place in corn belt can lands of that price be found that will produce such crops, and raise cattle of this class."

The Burnetts are young men, located on the high plains, 25 miles from the nearest railroad point.—Kansas City Drover's Journal.

### Terry a Health Resort

Dr. Treadaway says this is the healthiest country he ever saw. That there is little practice here outside of accidents, appendicitis and such like, is easily explained when he informs one that he has seen but one case of typhoid since he has been here, fourteen months, and that one passed through from New Mexico. He has not had but one serious case of pneumonia in that time, and seven or eight mild ones would cover the whole list. This is even more wonderful when one takes into consideration that his practice not only covers Terry, but he is sometimes called into the neighboring counties of Hockley, Gaines and Yoakum.

In comparing the relative healthiness of this and the country from which he hails, he said he had from twenty to forty cases typhoid every summer and almost that many cases of pneumonia in the winter, and the population little greater and divided among several physicians.

But Dr. Treadaway is not dissatisfied with old Terry, as he says he is making a living, and that he has reached that age in which he requires more rest. "No," said he, laughing in his big hearty style, "the people of Terry county don't need much medicine; this rarified ozone keeps them hearty."

Will McPhaul and wife and Miss Shelburn from N.M., spent Saturday night at the hotel. Miss Shelburn went on to Lubbock, Monday.

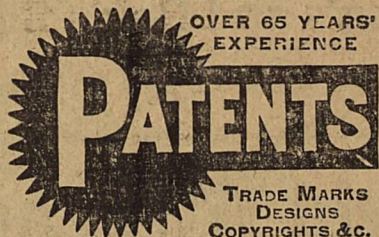
Geo. Black moved the little office building on the west side of the square out to his house Monday, and will join it to his residence.
