
BIG RAIN



Every worker connected with the Victory Liberty Loan Campaign will receive a medal made from captured German canon. The medal will be the size of a fifty cent peice, will have a reproduction of the Treasury Department on one side and a certification on the other that the owner has participated in the Loan. A space will be left for engraving the name of the recipient.






