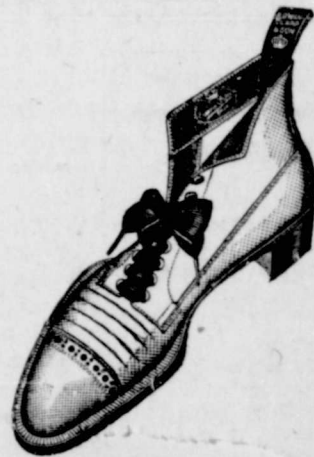

Will Enfore Law.

The city marshall has been instructed to begin the rigid enforcement of the city ordinance relating to crowding around passenger trains at the station. Complaints are being made by the railroad authorities and the traveling people that the gatherings at the station are so great, especially at the night trains, that the train can not be unloaded of passengers and baggage and that passengers can not reach the cars without serious inconvenience. This condition must be remedied, and the marshall has instructions to enforce the ordinance and make no exceptions. It has been talked by some that the ordinance was invalid, but the council believes it is perfectly sound and will have it enforced beginning with Nov. 1, or know the reason why it is not enforced.

While Sheriff Landry of Beaumont was out trying his race horse on the track at Driving Park last Saturday she dropped dead.

Howard Goodman, aged 24 years, while working at the Jacksonville oil mill Saturday night, was caught in the belting and instantly killed.

Saturday afternoon Hugh Clark, a young man employed at a market at Port Arthur, had three of his fingers badly mangled in a sausage mill.

The body of Thomas J. Simpson, of Redding, Cal., who dropped dead in the M. K. & T. passenger station at Dallas Wednesday evening, was shipped to his home.

At Jacksonville, Texas, an aged negro woman, left alone in her cabin, fell asleep and toppled into the fireplace Saturday. When the family returned they found her a charred corpse.

At Waco Saturday evening a restaurant keeper struck a negro over the head with a shotgun, bending the barrel like a rainbow, but doing the negro no harm.

Harry T. Warner, managing editor of the Houston Post, was seriously wounded by the accidental discharge of his gun while on a hunting trip near Alvin Sunday.

During the electric storm last Thursday night at Yoakum, lightning struck a barn owned by Woodward & Davis, setting it on fire, totally destroying it and a fine horse valued at \$1,000 was burned to death.

Near Corsicana while out hunting last Saturday, Westworth Collins aged 15 years, accidentally shot and killed himself. He was crossing a small stream on a log when he slipped and the gun was discharged shooting him through the head killing him instantly.

E. C. Haines, about 65 years of age, from Mills Point, fell off of a trestle while attempting to get out of the way of a street car Thursday afternoon at Oak Cliff, Dallas. He fell fifteen feet to the ground, with no other injuries except some bruises of the head and body.

I believe that alcohol to a certain degree demoralizes those who make it, those who sell it and those who drink it. All we have to do is to think of the wrecks upon either bank of the stream of death—of suicides, of the insanity, of the poverty, of the ignorance, of the distress, of little children tugging at the faded dresses of weeping and despairing wives, asking for bread; of the men of genius it has wrecked; of the millions who have struggled with imaginary serpents produced by the devilish thing. And when you think of the jails, of the almshouses, of the prisons, and scaffolds, upon either bank, of the river of death I do not wonder that every thoughtful man is turned to the stuff called the 'Bouvier' at Cleme

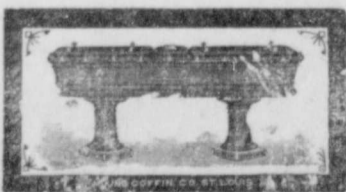

Obituary.

Gone to rest, one of the best men in
Goldthwaite. Grandpa Geeslin, that
noble Christian, has left this earthly
home and gone to his home in glory.
B. F. Geeslin was born in the State
of Mississippi, March 15, 1822, where
he lived until the year 1856. On the
15th day of June, 1851, he was united
in marriage to Miss Mary F. Levens,
with whom he lived until his Lord
called him home. In 1861, when he
settled in the States broke out, like a
true southern man, he left his loving
wife and children and went to defend
his Southern home and when the war
was over and the cause he loved was
lost, he came home and from then to
the day of his death he was true to
his native land.

At the age of 7 years he professed
the religion of Jesus Christ and at
once joined the C. P. church, in
which church he lived up to the time
of his death. In the year 1865 he
moved his family from the State of
Mississippi to the State of Arkansas,
where he remained for about three
years. About the year 1869 he left Ar-
kansas and came to Texas and settled
in Johnson county, near Aiyarado.
He remained there until about the
year 1873, when he again moved from
Johnson county, Texas, to Hamilton
county, Texas, and settled near Cen-
ter City. Here for many years he
lived and did his part to build the
community, both in church and state.
After his children were grown and
married he broke up house keeping
and made his home with his son B. F.
Geeslin, jr.

Grandpa Geeslin had been a mem-
ber of the church near 80 years. It
would be impossible to tell in words
or try to picture on the mental can-
vass of the mind, the power and in-
fluence for good that was felt by all
who came in contact with this strong
Christian man. While for years he
had the appearance of a frail man in
the body, yet when you saw him on
his knees, with his mind and heart
fixed on God, in his plain but earnest
way pleading the promises of God,
he became a power. To know him
was to love him. To hear him pray
or talk was but to know that he lived
close to God every day. He stood
with his prayers and his money ever
ready to help the church he loved.

For some months Grandpa Geeslin's
health had been failing fast, it
was plain to all that he would not be
with us long. On the 18th day of
October he was taken very ill and
not until the 20th was he able to
speak or make any of his wishes
known. On Tuesday the 20th there
was some little hope for a few hours
that he might revive again, but alas!
his earthly work was done and his
blessed Lord would call him home.
On the evening of the 22nd without a
struggle this noble Christian soldier
went home to glory.

He had born to him eight child-
ren. Four of them preceded him to
the glory world and four remained to
comfort him in his declining years.
He leaves his aged companion, now
seventy odd years of age, who for
near 57 years has walked with him
over the rugged path of life, even
down to the last hours of his life,
with the tenderness that only a lov-

twenty-seven grand children and
four great grand children, and one
sister in the State of Mississippi to
mourn for him. His friends cannot
be numbered, for every one loved
Grandpa Geeslin. In his death his

and his church in Goldthwaite its
brightest Christian member, one who
was always at his post with his pres-

ence, prayers and money. May his
children and grandchildren try to
emulate the noble Christian life he
lived before them, and left for them

Indianapolis, Ind.
Oct. 29, 1908

To the Editor and Friends:

The weather has been very
pretty up to the present time. It
is cloudy and cold today, very
dry, it being six weeks since a
rain has fallen. I like the city of
Indianapolis, as the people in
general are nice, polite and so-
cial with me. I am proud to say I
am getting along nicely, in care
of Dr. Berj. F. Bye, while I
haven't made complete recov-
ery yet, but have the utmost
confidence in same.

I shall attempt to give a brief
description of the Soldiers and
Sailors Monument. It is located
in the main business part of the
city, The balcony is 228 1/2 feet
from the ground, it is reached by
an electric elevator or by stair-
way consisting of 32 flights, 324
steps. After reaching the balcony
visitors look over a beautiful pan-
orama of Indianapolis. It is a de-
lightful view. Below the balcony
is a bronze astragal bearing the
dates 1861, 1865. On the four sides
of the shaft illuminated by elec-
tricity. Midway the monument
is a second bronze astragal rep-
resenting the army. On the east
and west side of the monument
are two of the largest groups
that have ever been carved out
of stone, the one on the east
representing war the other peace.
On the south are two heroic stat-
ues, each out of a huge block of
stone, one represents Infantry,
the other an ideal Cavalry Scout.
On the north front are the Artillery
and Navy representatives, same
as on the south. On the east
and west sides of the terrace
are magnificent cascades over
which flow 7,000 gallons of water
per minute. The many incande-
scent lamps make it the most
beautifully lighted spot in the
city.

letter will close for this time.
