The Eagle has never ceased to believe that excursions and frequent visits of business men and commercial organizations to the communities within the trade territory of a town help wonderfully in a business way. The better plan is as good when applied to the people of a county as it is applied to the town or the country. The interests of the people of a county are the same in many respects and there is no reason for any division socially or in a business way. As individuals are interested in their personal welfare, but on a broader plain they are all interested in the welfare of the entire citizenship of their county or community. Business men who make frequent visits to the rural communities and to the farms have a better idea of the conditions and a better acquaintance with the farmers, stockmen and other residents of the country, while the citizens of the outlying communities are in a like manner benefitted by the more intimate acquaintance with their neighbors of the towns. Trade excursions are beneficial to everybody connected with them.

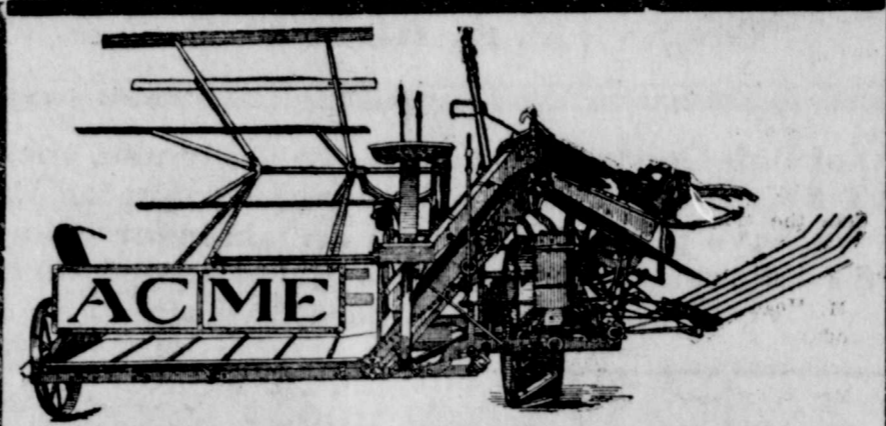

A FATAL ACCIDENT

Mr. Geo. W. Simpson, a well known farmer of the South Bennett community, was thrown from his buggy Tuesday afternoon and suffered injuries which caused his death Wednesday afternoon. He was en route home from Goldthwaite when his horse became frightened at an automobile standing by the roadside and ran away, throwing him from the buggy and one of the wheels passing over his body. He was carried home and given medical attention at once and it was not thought he was seriously hurt, but the following day evidences of internal injuries developed and he died about twenty-four hours after the accident.

Mr. Simpson was a pioneer of this section and was one of the best fixed farmers in the county, being possessed of a large amount of land and other property. In early days he lived a short distance south of this city's location, but later moved to the South Bennett community, where he continued to reside until the time of his death. He was a native of Virginia and a member of the Christian church. He leaves a wife and a number of children, besides many friends to mourn his loss. His remains were laid to rest in the cemetery in his home community Thursday afternoon and the service was attended by a large gathering of his neighbors and other friends.

MRS WILLIS DEAD

Mrs. P. T. Willis died at 4 o'clock Thursday morning in Comanche, where she had been for medical treatment for some time, and her remains were interred in the cemetery at Priddy Thursday afternoon at 4 o'clock.

Mrs. Willis had been in ill health for a long time and had been given the best medical attention obtainable without avail. Her condition was known to be serious, but only those of her immediate family and a few closely associated with them knew that she was so critically ill until the announcement came that she was dead. Her death caused sadness for all who knew her, for she was held in loving esteem by a large number of friends in her home community and elsewhere. She lived in the Priddy community for a long time, her family having been pioneers of this section. She will be missed greatly by her community and her friends, but most of all will she be missed by the kind and loving husband and children.

All who know of the sad bereavement of this good family sincerely sympathize with them.

A COUNTY CAMPAIGN

To the Citizens of Mills County:

Perhaps you have noticed our itinerary for the third week of April. This was planned in co-operation with Judge Dalton, who will form an important member of this party, being himself anxious to visit the schools. As was stated in the county papers, we expect several other prominent speakers to join this party.

Now that this campaign be made an entire success, I wish to ask the co-operation of every farmer and every business man to assist in this movement. The purpose of the campaign is to effect if possible, in the various communities, local organizations in dairying, hog raising, poultry raising and marketing among the adults; and agricultural clubs, animal husbandry clubs and egg circles among the boys and girls of each community.

I hope that each individual feels the necessity and value of this action in Mills county. We insist on diversification, the home garden, etc. that supplies for each family may be produced, so far as possible, within his own enclosure. Now if this plan is successfully carried out by every family it is evident that not only will the cotton acreage be reduced but a surplus of other products must of necessity follow; the problem therefore confronting us, is "How can we dispose of this surplus to our advantage? The only intelligent way of meeting this situation is thru the means of an organization. We realize the fact that there are many difficulties to overcome in this movement, and that it will take the combined efforts of our most staunch citizenship to meet the exigencies of the situation, but shall we stand inactive because of some lack of harmony on the part of past experiences in organized efforts? or listen to the oft repeated statement that "farmers will not stick," and pass up the proposition, while other portions of Texas are already profiting wonderfully, as a result of this movement.

I am pleased to inform you that the Federal Department, the State Department of agriculture and the A. & M. college, with all their forces are using every available means to accomplish this purpose. It is therefore possible that any organization in Mills county having for its purpose the marketing of its products, to join in this movement and receive the assistance of these various forces.

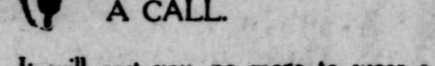

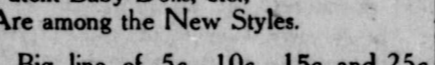

An explosion in the cooling plant of large packery in Kansas City Monday caused a financial loss of \$750,000.

A federal statute forbids the showing of the films of the Willard-Johnson fight in the picture shows, of this country and Postmaster General Bursleson has forbidden the pictures being sent through the mails.

A bank in Washington City has brought legal proceedings against the secretary of the treasury and the comptroller of the currency, charging that these officials have endeavored to ruin its business. It is asked that an injunction be granted restraining the officials from their alleged illegal acts.

Considerable criticism of the Pullman Palace car company is being indulged in because of the testimony of a number of porters before the Industrial Relations commission. The testimony showed that the porters are dependent for their living upon the "tips" they get from passengers and that the "tips" often amount to three times the amount received from the company as a salary.

The first report made by the employment bureau of the federal government, which is formed by the cooperation of the department of labor, the agricultural department and the postoffice department, shows a very favorable condition and seems to prove that such an undertaking will be of vast benefit to the nation. The greatest good so far accomplished is the removing of unemployed from the cities to the agricultural districts, but a much larger scope is possible as the people realize the benefits to be derived by cooperating with the government departments in the undertaking.

The Ballinger Ledger gives an account of an accidental killing in that section a few days ago when a farmer was shot and killed by a member of a party of hunters and the party who did the shooting perhaps did not know of the accident. The man killed was Wilbur Bishop and the report says: "Bishop was plowing in his field 12 miles south of Odessa, when the bullet from a high powered gun in the hands of one of the hunters struck him in the neck. When found the unfortunate man had fallen from his plow seat and his team was dragging him around in the field, and it is supposed that the accident occurred an hour and half before the young man had been found, and it was some time before it was known how he came to be shot. The bullet struck the man in the neck and he was paralyzed from his head down, but remained conscious up to a short time before his death."

The "trade at home" campaign inaugurated by the Temple Telegram is receiving the united support of the press of the state and many of the business men of Temple and other communities have given assurance of their hearty approval of the movement. There never has been a reason for the patronage given the mail order houses other than the fact that liberal advertising has brought their goods to the attention of the public and created a desire for such articles of merchandise. The prices named by the foreign dealers scarcely enter into the consideration, since it has been often proved that local merchants almost invariably sell merchandise at as low a price as the mail order houses. Most of the goods ordered from the catalog houses are ordered because the descriptive advertisements have created a desire for just such articles, notwithstanding the local merchants might have supplied the same articles had the purchaser been appraised of the fact. The liberality of Goldthwaite merchants in advertising accounts in a large measure for the small amount of business secured by the mail order houses from this territory and much of the prosperity in this section is attributable to the same fact.

Seven thousand dollars for postage. That is the amount a big mail order house recently sent to Texas to pay postage on several car loads of catalogues shipped to big railroad centers in the State for distribution. More than 200 of these catalogues, quoting prices on articles and making all sorts of big sounding claims, came to Bartlett and were delivered by the route carriers. They do not offer to exchange goods for the farmers' produce—eggs, butter, etc., and they don't trust a penny's worth but make their customers pay cash before they even see the goods. If anything is wrong with the goods or they do not suit, they will not exchange them. These big outside houses pay no taxes into the county or city treasury with which our schools, churches, roads and bridges are built. Neither do they contribute one cent to help our poor and sick. Why not patronize your neighbors and friends?—Bartlett Tribune.

Many Texas newspapers are organizing against the mail order evil. The newspapers have always fought the mail order system, and they always will fight it. The people expect them to fight it; but to win the fight the newspapers must have the business people of the country as their allies. The mail order business will ruin any community, and to stop it there must be developed co-operation between the buyers and sellers of the community. It is distinctly a local problem, for local business interests to meet—Bronwood Bulletin.

The Nicaraguan revolution has been attracting some attention, but with the wars of so much greater proportion a "tempest in a teapot" is about all this revolution amounts to in the estimation of the general public.

BADER ARRESTED

Man Charged With Killing Lometa Constable Now in Jail,

W. F. Bader, the man charged with killing Constable J. J. Connell at Lometa last Thursday morning, was arrested in Ballinger Saturday morning by a number of officers who had trailed him to that place. Sheriff Burnett of Mills county, Sheriff Mace of Lampasas, Sheriff Miller of San Saba, the sheriff of Runnels county, Mr. J. N. Weatherby of this city and others were in the posse in pursuit of the fugitive when he was located and arrested.

Bader reached Ballinger Saturday morning about 2 o'clock on a freight train, which he boarded at Brownwood. The first information that he was in that locality was given by a brakeman on the train. Officers were on the lookout for him there, believing that he would go to his wife's home. When the officers reached the rooming house conducted by Mrs. Bader they made a thorough search without avail. After making other investigations they returned to the place and discovered a "scuttle hole" in the ceiling. An investigation showed that the man was hidden in the ceiling and believing that he could not escape except by the way of the opening through which he had entered they secured a quantity of sulphur, which they proposed to use in making a smoke to force him to come out. Before the smoke was started, however, it was discovered that there was an opening in the roof through which the man had crawled and made his escape, by jumping from the top of the building, which was a double story, onto a single story building adjoining and then descending to the ground. He was bare footed and the officers had no trouble in trailing him to a place where he secured shoes, but there the trail was lost. In a short time, however, he was found in the business part of town and made no resistance, although he had a gun in

his pocket, with four cartridges in it.

Much credit is due the vigilant officers who continued the search for the man until they captured him and to none can more credit be given than to our own good sheriff, Mr. Burnett, who entered the search at the beginning and was there at the ending, sharing in the difficulties, dangers and hardships.

Bader was carried to Lampasas on Sunday night's train to be placed in jail to await legal proceedings.

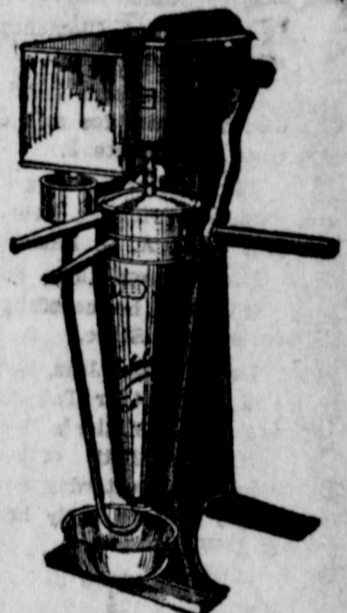
