FROM WASHINGTON.

A WASHINGTON dispatch, May 2d, says: At the Indian bureau there is a belief that the Indian troubles in Arizona are over for the present. The officers of the bureau say the band of Indians which did all the mischief numbered 400 all told; they were making their way into Mexico, and will probably get into that country before the troops ean catch them.

THE rules were suspended in the House and bills were passed for the erection of public buildings at Detroit, Michigan, \$600,-900; Jackson, Tennessee, \$10,000; at Denver, Colorado, \$300,000; at Greensboro, North Carolina, \$50,000; at Council Bluffs, Iowa, \$100,000; at Lynchburg, Virginia, \$100,000; at Peoria, Illinois, \$22,500. The above sums represent the maximum cost of the buildings when constructed.

TRE EAST.

A SPECIAL from Reading, Pa., May 1st, says: Two burglars who attempted to blow open the safe of the Orvisburg shoe factory. were captured in a hotel at Strausstown by three officers. While the latter were preparing for a return, the burglars drew two revolvers, ordered the officers to throw up their hands, and then leaped into the officers' carriage and drove off.

THIRTY coal miners were arrested at Alpsville, Pennsylvania, by a Sheriff's posse recently, on a charge of conspiracy. These men were strikers, it is alleged, and intimidated men who were engaged to take their places. They were required to furnish bail to the amount of \$1,000 each.

In the Cambridge Probate Court it was decided that the erasures and interlineations in Longfellow's will are of no effect. The decision is based on the ground that a will cannot be altered except by codicil, and this deprives each of the children of the testator's brother of \$1,000 and his brother Stephen or \$5,000. The will was admitted to probate. E. Longfellow is administrator.

ASSASSINATION IN IRELAND. Lord Cavendish, Secretary for Ireland.

and Under Secretary Burke Stabbed

to Death in Dublin. Lord Frederick Cavendish, the new Secretary for Ireland, and Thomas Henry Burke, Under Secretary, were both assassinated while walking together in Phœnix Park. Dublin, on the evening of the 6th. Particulars of the terrible affair are as follows: Lord Cavendish had taken the oath of office at the Castle at 1 p. m., and remained there until 6 o'clock, engaged in business. At that hour he drove to the Secretary's house for dinner, after partaking of which he and Mr. Burke went together for a stroll through the park. Accounts of the actual assault are meager and somewhat conflicting, although the affair took place in broad daylight, at an hour when the park is ordinarily thronged with visitors. One statement is that four men drove up in a car, two of whom jumped down and made a precipitate onslaught upon the two men, who were of course totally unprepared for the attack. The victims struggled hard for life, and in the struggle became separated, their bodies being found ten paces apart. The assassins had fled, and there was no apparent clew to their identity. The locality bore evidences of a most determined struggle, and the ground was saturated with blood. The bodies of both of the victims were punctured with wounds from a knife or dagger, presenting a most piteous spectacle. The watches and other valuables upon their persons were not taken, showing that robbery was not the incentive to the

The greatest excitement prevailed throughout Dublin as well as the whole Kingdom as soon as the event became known, and the apparent want of motive for the crime, so hideous both in its conception and execution, rendered many incredulous, even after the news had been fully corroborated. Leading representatives of the Irish cause were loudest in their denunciaation of the crime, which could only prove injurious to the cause.

It was generally conceded that the act would work incalculable injury to the policy of conciliation which had been inaugurated under Gladstone, and might result in the downfall of the Ministry. While Burke, as Under Secretary to Foster, had doubtless given offense to many, Lord Cavendish was supposed to have the best wishes of all.

Mr. Forster believes that the assassins attacked Lord Cavendish in order to show the Government that, although it might make terms with Parnell, it was not possible to conciliate the Fenjans.

IRISH AFFAIRS.

Mr. Gladstone's Recent Change of Policy Toward Ireland-Secretary Forster's Resignation-Great Rejoicing in Ireland.

LONDON, May 2. In the Lords, this evening, Earl Granville, Secretary of State for Foreign Affairs, announced the resignation of W. E. Forster, Chief Secretary for Ireland, and the intention of the Government to release the three imprisoned members of Parliament. Granville explained that Earl Cowper had not resigned the Lord Lieutenancy on account of any difference with the Government in regard to policy. He confirmed the report that Lord Carlingford would temporarily take the Presidency of the Council during Earl Spencer's absence in Ire-and. Earl Granville stated that a reconsideration of the prisoners' cases would not extend to the case of Michael Davitt.

Mr. Gladstone, in the Commons, made an an-nouncement similar to that of Earl Granville in the House of Lords. Mr. Gladstone stated that a large number of other "suspects" would be released, and the Government, in-stead of renewing the Coercion act, would introduce measures remedying the administra-tion of justice in Ireland. He said instructions had already been sent to Ireland for the release of the three imprisoned members of Parliament, and that the lists of "suspects' were being carefully considered with a view to the release of all except those who were ar-rested on suspicion of having been personally concerned in outrages. These releases would on the Government's sole responsibility. Mr. Gladstone stated that Mr. Forster had resigned because he was not willing to share this responsibility. The measure which the Government will introduce remedying the ad-

ministration of justice in Ireland deals with the protection of life and property.

Speaking with reference to the Cocroion act, Mr. Giadstone made a special reservation that If peace and security should be jeopardized by the action of the secret societies the Government would consider it its duty to propose counteracting measures. He declared the Government did not think the Coercion act failed, as it had served an important purpose in a great crisis. He warmly praised the manner in which Mr. Forster had performed his duties, and expressed regret at his retirement. Mr. Gladstone declared that none of the measures announced in the Queen's speech at the opening of the session, except the resolutions in regard to the rules of parliamentary proced-ure, would be allowed to stand in the way of measures which the Government would introduce for restoring peace and order in Ire-

Replying to a question by Mr. Joseph Cowen, the Home Secretary said Michael Davitt had een released for the same reasons as those for which the suspects had been released. No conditions were attached to his release, except those attached to his previous liberation. Mr. Gladstone announced that the charges of

treasonable practices against Parnell would be withdrawn. Mr. Forster stated the reasons of his withdrawal from the office of Secretary for Ireland. He said he could not agree to release the suspects unless he got from them a public promise cease opposing the execution of the law. As he could not obtain that, he could not remain in office. He would have released the suspects if Ireland had been quiet, or if the Government had had full powers, but he could not agree to an unconditional surrender. He admitted that the condition of Ireland was better than in January, but it was still so bad that he wanted the Government to let the rules of procedure wait until a fresh act securing punishment for outrages had been passed. The Coercion act, he said, had broken up the League, or put it under petticoats, and rents were being better paid; but he feared that an unconditional release would undo all the good effects of the act.

Mr. Forster, in justifying the arrest of Parnell, said Parnell, if he had been allowed, would have become the uncrowned King of Ireland. Mr. Forster declared the proceedings of the imprisoned members had been far more dangerous than the individual incitements to outrage.

After defending the arrests, Mr. Forster said if all England could not govern Parnell, let the Government acknowledge he is the greatest power in Ireland. But he believed neither such admission nor any weakening concessions were necessary. Better even hidous secret societies than paying blackmail to lawbreakers.

Mr. Parnell denied that the question of release of himself and others was due to any condition as to their future action, though he said he had stated verbally and in writing that he believed the settlement of the arrears would have an enormous effect in restoring law and order; and that if such a settlement should be made, he would be able to take such steps as would have a material effect in diminishing the number of outrages.



THE MARION EXPLOSION.

CHARLESTON, S. C., April 23. Full particulars are received here to-day of the terrible explosion of the steamer Marion yesterday, on the Wateree River, with an ex-cursion party of ladies and gentlemen on board at the time. The Marion was employed by the Government in removing obstructions from the river, and for some time past had been running up and down the stream, and the officers and crew had become well acquainted and popular with the people living upon the river-

During the past week a number of young ladies and gentlemen living in the upper end of Richland County decided to organize an excursion party for a trip down the river, and sent a committee to the Captain of the Marion with the request that he would grant them the use of the steamer, with which request be courteously complied. The party took the steamer yesterday morning at nine o'clock, there being twe hy-three ladies and twelve gentlemen, and they started off with glad anticipations of the pleasure of the day. Besides the excursion party, the crew numbered

ten persons, making the steamer's load of liv-ing freight forty-five. At eleven o'clock, when the steamer was in midstream, the boiler-exploded with a fearful noise. At the time the entire excursion party was on the deck, and all of them in the immediate vicinity of the engine-room. The scene, when the smoke of the explosion died away, was fearful, and beggared description. For one moment the dense cloud of escaped steam hung over the debris, and men and women were senseless and bleeding upon the torn deck. Others had been thrown into the hold, and others still were buried under broken planks. The steamer was at first almost thrown over on her side, but she righted herself. Such of the male passengers and crew as had not been disabled went manfully to work to save the wounded and helpless women. The steamer was headed for shore, and, before she could sink, was run into shallow water. The force of the explosion blew off the entire upper deck. Many of the passengers were thrown into the water, but many more fell back on the deck, some being seriously hurt and others only slightly bruised. The Captain and crew did brave work in saving the lives of the unfortunates. and but for their prompt action the victims of the disaster would have been trebied. The saddest feature of the explosion was the

absolute extermination of a whole family, the Misses Henry, four sisters, who were among the most loved and popular young ladies in Richland County. They had been standing on the deck directly over the boiler, and the ex-plosion spent its full force upon them. The youngest, Miss Alice, was killed instantly. Miss Minnie, the oldest, was thrown a great distance into the air, and fell into the water. She was one of the first picked up, and died in fifteen minutes. The third, Miss Jane, was picked up in the end of the hold, nearly every bone in her body broken. She lived long enough to murmur "Thanks" to the young gentleman who lifted her mangled body. The fourth, a lovely brunette of eighteen, was so scalded as to be almost unrecognizable. Mr. Arnold Stiles, a middle-aged gentleman, one of Arnold stines, a inducated gentleman, one of the organizers of the excursion, was killed, his arms being torn from the body. John Jacobs and Hiram Tiller, two colored boat hands standing in the rear part of the steamer, were killed, it is supposed, by falling timbers. Colonel James Dushelles and Mr. Lawrence Adamson, who were standing near the Misses Henry, were also killed. Three other young ladies were also lost. One of them was to have been married next Friday. was to have been married next Friday.

The number of persons killed or fatally wounded will reach twelve. The extent of the injuries of many others cannot be definitely fixed yet. The town of Columbus was the nearest point at which succor could be gotten, and the presence there of one of the crew created the wildest excitement, and a relief expedition was at once organized.

The Coroner's Jury this evening rendered a verdict of accidental death, and exempted the officers of the boat from blame.

Lynched.

Several recent horrible outrages in different parts of the country upon the persons of little girls have been summarily avenged by the citat once effectually disposing of the perpetra-tors of the terrible crimes. A St. Paul (Minn.) telegram of the 2sth ult. gives the following account of the lynching affair at Minneapolis: The excitement in Minneapolis over the outrage perpetrated upon little Nina Spear by a tramp yesterday afternoon increased, without any appearance of concerted action, until about midnight, when squads of men began to assemble on the street corners and gradually converged down Third street and Washington avenue in the direction of the county jail.

There was no sound heard except the tramp of feet, and the attempt, so far as it succeeded, was conducted with remarkable discretion. The Vigilance Committee, now numbering about sixty persons, proceeded without noise by sundry routes to the county jail, which they reached shortly before 1:30. There was a noiseless consultation, and, headed by picked men, they marched to the door of the turnkey's room and demanded entrance, which was refused by demanded entrance, which was refused by Sheriff Eustis in person. The demand was re-peated and refused. A few brawny shoulders were placed to the door, and it gave way with a crash. The Sheriff still resisted, but was taken in custody by the mob, disguised with handkerchiefs, and was forced into submision in the corridor leading to the cell-room. Then commenced a search for the prisoner, rom cell to cell, by a dim light, but up to two o'clock without result. The committee made various demands upon the Sheriff to give up the prisoner, but he stoutly refused. About three o'clock access was obtained to the third tier of cells, where the prisoner was ordered to be confined. Two men suspected of being the one looked for were taken out. A hurried investigation resulted in the partial identification of one, giving his name as Cromley, who was found in cell No. 3 on the third tier. He showed the utmost nerve while he was being questioned by the vigilants, making no effort to conceal his face, and glibly answering the questions which were put to him. It was exactly 3:10 when he was brought into the corridor, and, escorted by the entire company of vig lants, the prisoner was marched to the house of Mr. Spear, where were gathered several ladies who had seen him before the commission of the act. No sooner was he presented than all the ladies declared positively that he was the culprit, the agonized mother exclaiming: "It is the man! was going on in one room, the victim of the outrage lay dying in an adjoining room.

The positive identification of the villain by the ladies was the signal for action, and, without noise or any demonstration, the prisoner was taken to a large oak tree on the southeast corner of the block diagonally across from the high school. The noose was prepared, one of the members of the committee climbing up and placing the rope over the limb. While this was in progress of performance the prisoner was asked if he had anything to say, and, without the least sign of fear, he replied that his name was Tim Cromley, and that he was from Boston, and had been here four months. When he was asked how he came to perpetrate the crime of which he was guilty, he denied it, but afterwards confessed, and said it was done while he was drunk. His hands were thereupon tied behind him. The rope was then put over his neck and carefully adjusted under his right ear, and at 3:57, with his hat and boots on, he was swing into eternity, the vigilants giving a long pull and streng pull which brought the wretch dangling in the air. The rope was then securely tied to the trunk of the tree. The remains were left dangling in the air, where crowds inspected them, as the news spread rapidly over the city to the early risers.

KANSAS STATE NEWS

SMALL-POX is reported in the village of Stanley, about ten miles east of Olathe, on the Leavenworth, Lawrence & Galveston Railroad. The type is very malignant. People are dying rapidly, and the town is being depopulated, as the citizens are badly frightened and are leaving daily.

A SPECIAL from Topeka, May 1st, says: Great excitement was created here this afternoon over the shooting of a colored man. Samuel Easly and George Vinegar were standing on the corner of Monroe and Second streets, quarreling over \$2 that one had borrowed from the other and refused to pay back. Easly is a big man, while Vinegar is only a boy. Easiy jumped on to Vinegar and began to slap him around, whereupon Vinegar drew a revolver and fired. The bullet entered Easly's groin, inflicting a very dangerous and possibly fatal wound. By this time a large crowd had gathered at the scene of the tragedy, but no one made an effort to prevent it. After the shooting the boy ran away, and had gone a long ways before the thought of capturing him occurred to the bystanders. When the police arrived and started on the pursuit, they were joined by at least 100 men and boys. The chase lasted an hour or more, but Vinegar finally made his escape, and is still at large. The victim was placed in a wagon and carried to Dr. Vanilla's office, where his wounds were dressed.

A PARTY named Wm. H. Cody was arrested for robbery at Atchison, and is in jail to await the action of the District Court. When searched bunches of keys, two revolvers, scissors, nippers and other burglarious tools were found on him. He also had a diary, containing the names of Ella and William Weaver, Ottawa, Ill.; a note for \$150, payable to J. R. McAlpine, Clarinda, Iowa; a receipt given to Wm. H. Weaver, for \$35, signed by H. L. Hosack, Ottawa, Ill., as well as other such papers. The evidence is sufficient to show that he is the leading spirit of that gang of operators who have tried to flood Kansas and Missouri with forged and raised checks and drafts. He is remarkably cool, and claims relations with Wm. F. Cody, the actor and scout.

CAPT. WILLIAM H. ANDERSON, one of the best known young men in Leavenworth, and ranking high in social circles, has absconded, being behind in his account with his employers, and leaving board and other bills scattered around promiscuously. Anderson went to Leavenworth about four years ago from St. Louis, and has since been a clerk in several leading dry goods houses, his latest employer being Frank Scott, for whom he has collected and salted down quite a sum of money, estimated at from \$250 up to much larger proportions. Anderson was very popular, for a long time belonged to the Metropolitan Guards, a military organization of leading society young men, was captain of the Barry Cadets, a juvenile organization, named for a prominent minister of the city, was leader of the Episcopal Church choir, ranked high in office in the Knights of Pythias, and though not conceded to be an intellectual phenomenon, was considered straight, and had the entree to the best society. Two years ago, however, his popularity began to wane, and he commenced to drink heavily, and re-

cently has been perfectly reckless. Barnes, who for many years has been connected with the Fort Scott & Kansas City and Lawrence & Southern roads, has been appointed General Superintendent, and will have full control of the operating department.


