### Several Important Changes

There are evidences of progress and prosperity on every hand in Goldthwaite and the statement that Goldthwaite is one of the best towns on the map is being fully vindicated. Not only do these evidences appear in the business part of town but throughout the com munity and the surrounding country.

One of the largest buildings ever erected in this city is being juilt by the E. T. Fairman Hardware and Furniture company and is nearing completion. The building opens on Third street, but will be connected with the company's main building on Fisher street by means of an overhead pas sage crossing the alley at the rear of the main store. This new building covers a space 40 x160 and is two stories in height. It will have a brick front and will be an imposing building. A garage for the company's ambulance, trucks and other motor vehicles will be built on the west of the big building and will be conveniently arranged and add to the place.

The Fairman Company is having a plate glass front built in their store fronting on Fisher freet and some important and attractive improvements have been made on the interior of the store, such as the building of an office in the rear of the room, where a large fireproof vault has already been prepared. When these improvements are completed the company's heavy stock, including furniture and stoves will be moved to the new building at the rear and one of the main buildings on Fisher street will be vacated and after the interior arrangements of the vacated building have been completed it will be occupied by the Texas-Louisiana Power Co. as an office and display room for the various household necessities handled by that company. Other improvements are being made about town, including the re-building of the Sullivan store building on the north side of the square, recently damaged by fire. Mr. Sullivan will have a plate glass front built in and make it quite an attractive place. When the building is completed it will be occupied by Mrs. Addie Smith-Bodkin and Miss Myrtle Harrison with their millinery stoc. Kelly Saylor's Chevrolet Motor Co. has contracted for the erection of a concrete building 36x120 on the lot adjoining the Saylor hotel on the north, and between the hotel and the Keese marble yard. When this building is completed it will be used for a garage and work shop by the Motor Co. and the first floor of the hotel building, from the Fisher street entrance to the sample room, will be arranged for a display room and office for the Chevrolet Motor Company. This will make one of the finest automobile show rooms in this part of Texas and will be a credit to the town. J. J. Saylor, owner of the hotel property, has already contracted to erect the new building and make the changes necesfor the Chevrolet company ings ready for occupancy by Sept. 1.

UNJUST DELAY

The Texas Legislature by resolution requests the Texas delegation in congress to employ every effort to obtain from the federal government reimbursement to Texas farmers for \$115-000 yet remaining of the undischarged cost of the operation of the 1918-20 pink boll worm quarantine of the State and Federal Governments. The state has already paid its share of the expense, amounting to \$439,000, in adcordance with the agreement with the federal authorities.
