now to bring the horses and cattle to the beginning of winter in good order. The eason is too far advanced for turning horses out at night. If horses are caught out in a heavy cold rain, they should be ruched dry and blanketed as soon as they reach home. The product of the dairy should be increased in every possible way; this requires the best feed and plenty of pure water, and frequent carding of the animals to keep them. neat and clean. Young stock should not suffer from the cold and wet. A rough shed in the pasture is a useful protection until it is time to take the young animals to the barn or stable. A cheap temporary shelter is shown in fig. 2. Two crotched posts, eight feet long, are set firmly in the ground, and cons-nected at the top by a cross pole—this bears the end of the poles which makes the top and rear of the shelter. The ends are boarded up. Long wool sheep are easily chilled by cold rain, and should be kept from getting wet through the this suscen. Shoep should be kept 2. Now, if the catarrh was due to the inhalation of cold air, both nostrils would suffer; but it is not so, for as each side of the body is supplied by its distinct set of nerves, so only that side is affected through which the reflex disturbance has been transmitted. The modus operand is the following: The draught of cold air acting, we will suppose, on the back of the head, conveys through the sympathetic nerve, which ramifies on the scalp, a shock to the nervous center from which these nerve fibres proceed; but we must understand that this nerve but we must understand that this nerve center sends its filaments to other por-tions of the body, and so the shock which this center neceives by one set of nerves is reflected by another set to some surface quite remote from that pri-marks meted mere and up the more marily acted upon, and in this way a temporary paralysis of the nerves sup-plying the blood yessels of the mucous nembrane of the nose is brought about. In consequence these vessels become dilated and engorged, and, the shock which has brought about this congestion con-tinuing, disturbs the equilbrium of the blood supply, and so an inflammatory condition is set up. When this exists the blood vessels are enormously dis-tended; consequently an excess of blood passes through the part, the little cells which

being thus excited and working much more rapidly than when in health. In this way the enormous discharge of mucous which accompanies a cold in the

head is accounted for. Another effect of this irritation of the mucous membrane is sneezing, which is an effort of nature to restore the equilibrium of the nervous center by another kind of reflex action. Sneezing in cathus enable it to reassert its proper con-trol over the blood supply to the part; indeed it will be found that the effects of being exposed to a draught of cold air are often completely destroyed by a succession of sneezes. Of course nature does not always immediately succeed in these efforts, but when she does not the shock from which the nervous center cuffers gradually passes away, and the blood vessels again come under the control of the little nerves which regulate their caliber, and so the catarrh disappears in a few hours, or at most in a few days. Painting in Oil on White Holly Wood.

Should any one desire to make a few household ornaments which are neat delicate and not costly (even provided you have just a slight fondness for paint. ings,) purchase a few feet of white holly wood one-eight of an inch in thickness; vandyke brown, flake white, chrome yeilow, crimson lake, permanent blue; also one fine oil paint brush, Saw out of the holly wood a frame about an inch and a half wide all around, sawing out an opening large enough for a pnoto graph, and round all the corners. Sandpaper the wood thoroughly after the frame is finished. Now commence to trace a vine around the trame, then trace leaves and flowers using a sharp pointed pencil for tracing. Perhaps you have a pattern of a vine in one of your magazines, if so you can trace it off on white tissue paper and transfer to the wood by using tracing paper. Mix a little chrome yellow and Prussian blue together and, after adding a very little turpentine, proceed to paint all the leaves. Mix a little brown with green, making an olive green, and with it shade the leaves after cleansing the brush thoroughly with turpentine; trace the leaves with light lines of brown, also the branches of the vine. After the leaves are finished mix a little permanent blue and flake white and paint the fiowers and buds. Use a little flake white to shade the flowers after they are painted blue. Vine the whole vine with Van

Dyke brown. Should you prefer, you can use crimson lake instead of blue for flowers; always be sure and was the brush well in turpentine before using for another color. A number of fancy articles can be

made from white holly wood and painted. Small clusters of flowers and landscapes can be painted on panels of holly wood.
