MOZART'S SPIRIT HOME.

of Sardou's Supernatural Experime

Many Years Ago, Whitehall Review.

Sardou was at one time an ardent be liever in spiritualism, and I have often heard him repeat the following incident: His familiar spirit was that of Beau-marchais—naturally enough—and on one occasion the author of "Les Pattes de Mouche" asked his invisible friend in what part of infinite space dwelt the spirit of the great Mozart—Sardou's favorite of the great Mozart—Sardou's favorite composer. "Take a pencil," replied Beaumarchais. Sardou obeyed, and began, under the influence of the author of "Marriage of Figaro," to draw shapes and lines on the paper before him. Suddenly he came to the end of the paper. What was to be done? Go to the boulevard St. Michael, such and such a number," rapped Beaumarchais; "you will find there the paper you need." Sardou jumped into a cab. and was at the given jumped into a cab, and was at the given address in the twinkling of an eye, but address in the twinkling of an eye, but alas! to his disappointment there was nothing like a stationer's shop to be found in the house indicated by the defunct Beaumarchais. On his return home he again put himself in communication with the deceiful spirit. "Return," rapped the invisible tyrant, la conjugally. Back work Saydon and after conically. Back went Sardou, and after making many inquiries he found that there did live a wholesale paper merchant in the house indicated by the spirit. To buy the necessary quantity of paper return home and seat himself paper, return home and seat himself once more, pencil in hand, was but the work of a few minutes, and then, oh wonder of wonders!—he began involuntarily, and without any impulse of his own, to draw the most extraordinary and fantastic palaces, without doors and of an unknown style of architecture. It was there the spirit of Mozart dwelt! The drawing was so extraordinary and so marvelously well done that Sardou was anxious to have it engraved, but no engraver in Paris could be found who would undertake it, so complex and subtle were the lines, and in such grand chaos of confusion, although forming an artistic unity. The spirit of Beaumarchais rapped Sardou out of his dilemma by instructing him to begin the sketch over again, but this time on lithographic paper. Sardou did the work within the space of a few minutes, and it is this marvelous lithograph, known as "La Maison de Mozart," which the brother of the author of "Dora"—the well known bookseller in Brusselssells to a few privileged amateurs. It seems almost a pity that the spirit of Beaumarchais was not a Sardou when he

ties, over-dressed and over-jeweled; the paint on their lips, eyes and faces, together with that gauzy veil of affectation, cannot conceal the true coarseness of their nature; they are waited for by cavaliers, old and young, who smoke in their presence without even the show of an apology. So they drift away. Here and there you will also see a plainly dressed form shrinking from the eye-glass stare of privileged rudeness, and stealing away through winding alleys to the safeguard of a poor mother's arms,or the sanctity, it may be, of a sick sister's garret. Such are the light and shade of ballet life! Broughams are in waiting, bright and glittering like their owners; groups of young men come out and make for their various Clubs - hey are the histrionic blossoms of the present dream. Some promise well, and will reach, in time, a healthy full bloom, while some are as weeds, choking up the flowers, and fit only to be plucked up and thrown away. They are well enough in modern plays, but blank verse won't fit in with tea-cup-and-saucer chatter; so that when they come across Shakespeare they either convert him into a Charles Mathews kind of patter, or intone him as if they had been brought up to the Church, the clerical style of elocution being the most popular. Now and again you may find an actor among them who has learned his business, but he only seems, in such a crowd, like a spectre of the past that has lost its way looking for the kindred spirits of his arts. The actresses, as a rule, are like forced hot-house flowers, very baautiful to look at, and would be perfect if they could only be endowed with a touch of nature. While standing here you have seen broughams and cabs flit away with their painted burdens. Now look at that heap of rags and read the history of another misspent life, over there, crouching beneath the dim light of that lamp. This stage entrance has a wierd power over her. In the day-light she shuns it: but at night, no matter how rough, or wheresoever else she may wander, her limping feet are sure to bring her here. She speaks to no one, but simply watches that door. Why? She was once one of the attractions there -a beauty-flame, with all kinds of moths circling around. An actress? No, but one of those mockeries thrust before the public, able to understand a few lines of jingle, and look beautiful, but with only brain enough to know when they are well dressed, and hate children. She had her conveyance, the brightest of its kind, a dressing-room fitted up especially for her, and crowds of unwholesome parasites hovering about her. Now,look at her; even her scare-crow rags, foul as they are, seem ready to desert her. Her eyes are bleared, and her face all prema-
