

School Superintendent LeRoy Beard of Star this week offered an important suggestion to be applied during the Army-Air Force maneuvers, Exercise Longhorn. He urged that parents, children and drivers of vehicles use the utmost caution during the next few weeks so that in Mills County injuries from military traffic may be avoided.

Drivers of school buses and of motor cars and pickups should be especially careful, Mr. Beard said, and he urged that parents caution their children not to play along roadways during the maneuver period. Children waiting for school buses or leaving them on the way to their homes after school should keep a sharp eye on military traffic.

For their part, military authorities have issued strict orders to all drivers of military vehicles to watch for children, to observe State laws regarding the operation of school buses and to avoid interference with normal civilian military travel on the roads and highways. But, beginning with next week, there will be more and more congestion on the roads and highways in this area and, as Mr. Beard pointed out, care and caution during the period of the maneuvers can and will avoid heartache and sorrow.

#### MANEUVER TIME IS ALMOST HERE

We were a luncheon guest of the First Armored Division following an impressive Review at Fort Hood last Saturday and as we listened to what was said by some of America's outstanding military leaders we thought the remarks would make a good editorial.

Lieutenant General William M. Hoge, commanding the Fourth Army, expressed gratitude to farmers, ranchers and civilians generally in the maneuver area. He pointed out that nearly 98 per cent of the land needed for Exercise Longhorn has been provided through civilian cooperation at no cost to the government.

In that connection, military authorities are using three types of signs to delineate maneuver territory for the troops. A red sign will warn soldiers not to use private areas, such as yards of ranchers who have donated the use of their land for maneuver use. White signs will warn troops that land has been donated for Exercise Longhorn but such signs also mean that soldiers must use the greatest of care so as to respect private property in the performance of their duties.

Cream colored signs will mark areas in which land owners have NOT cooperated with Exercise Longhorn. Those cream colored signs, of which there are and will be very few in Mills County, mean that land owners have not signed maneuver permits. Land posted with cream colored signs will be excluded from the maneuver area.

Major General Bruce C. Clarke, who commands the First Armored Division and who is the Commanding General at Fort Hood, has set up 28 fence repair units. In announcing the efforts that have been made, General Clarke recalled the poem, "Mending Walls," by Robert Frost. It contains the line, "good fences make good neighbors." That is why a fence repair crew has been attached to every battalion in the First Armored Division. Those crews, which have been especially trained, are being reenforced by 40 additional squads that are capable of repairing fences.

There were some other important points that were brought out by Generals Hoge and Clarke last Saturday. They included:

1 - In Exercise Longhorn air power will participate to a greater extent than in any previous maneuver. That means, as General Hoge pointed out, that both ground and air power will be tested in the maneuvers.

2 - Next to war itself, the maneuvers provide the best opportunity for testing the results of training and staff planning. Accordingly, during the next few weeks, events of great significance to the security of our country will be transpiring right here in Mills County.

3 - As General Clarke emphasized, cooperation has made Exercise Longhorn possible. All of us are part of the maneuver and Mills County citizens can be proud of the manner in which most of them have responded to a call from their country.

The military authorities concerned have asked us to express their gratitude and appreciation to those Eagle readers who have done and who will continue to do their part.

The economy coalition in the House was very much in evidence as the supplemental appropriation bill was dissected and amended in a number of respects. I offered one amendment to prohibit the employment of nearly 400 additional Federal employees, and for other purposes. It was adopted and alone will save many millions of dollars during the years to come. The initial cut provided by the one amendment amounted to \$1,390,000.

The wetback bill was cleared by the conference committee to which it had been referred to iron out differences between the House and Senate. The compromise version was promptly adopted and was sent to the President. It is a vast improvement over many of the proposals advanced by the Ad-

ministration, and is considered a fairly good bill in most re-

Meanwhile, the farm labor crisis continues and the present processing agreement with Mexico to expire in early May. A new agreement is to be negotiated in Mexico City soon, to enable Mexican workers to be recruited to work in areas on this side of the Rio Grande where there is found to be a shortage of domestic help. The trouble has been that the agreements have been so weighted down with red tape and unworkable provisions, that the program has had the effect of encouraging wetbacks to come
