Next Thursday, March 5, is the last day on which candi- for teachers' meeting. dates may file for the school trustee election and have their names printed on the official ballots. Filing deadline is 30 days before the election which is scheduled for Saturday. April 4.

Two trustees are to be elected to the board from Goldthwaite, Star, Priddy and Mullin school districts. Three members will be elected to the county school board, one from each of precincts one, two and four.

Candidates must file with County Judge Cecil Egger. Names may be placed on the official ballot by the candidate signing up in person or by petition signed by five regularly qualified voters of the respec tive district.

Candidates nominated by petition also must sign the affidavit for candidate for public office in the office of the county judge 30 days before the election in order for the named
