

PROPOSED CONSTITI-TIONAL AMENDMENT TO BE VOTED ON AT AN ELECTION TO BE HELD ON NOVEMBER 2, 1965. Heret shall be self-enacting and appropriations heretofore made in the General Approp-riations Bill for the biennium ending August 31, 1967, for ELECTION TO BE HELD ON NOVEMBER 2, 1965. HOUSE JOINT RESOLU-TION NO. 8 proposing an Amendment to Section 24, Article III and Section 17 of Article IV of the Constitu-tion of the State of Texas, to allow an annual salary in an amount to be fixed by the Legislature for the Lieuten-ant Governor and Speaker of the House of Representatives shall not be invalid because of the anticipatory nature of the legislation. "In addition to the per diem the Members of each House shall be entitled to mileage in going to and returning from the seat of Government, which mileage shall not exceed Two D ollars and Fifty Cents
