Mr. Barnett came to Goldthbeen active in community and the city was in the process of going into the Electric business in competition with the Com-

munity Public Service Company, which had been operating here for some time.

The city at the time had two regular employees and a night watchman. There was one cityowned vehicle and the trash collection was done on a contract basis. The city had about 300 water customers.

The new electric distribution system was completed in October 1941, while the city adveravailable on September 19, 1941. During the first few months the new system picked up 300 electric customers out of approxi-

Under the leadership of Mr. Barnett the city purchased the Community Public Service Company property in Goldthwaite in 1945 and took over the rest of the electric customers available at that time.

An interesting note regarding this transaction was that Mr. Barnett had been manager of this same property for the CPS Company and had lived in Goldthwaite from July 1928 until November 1930.
