

Notices of individual farm acreage allotments and yields for the 1969 upland cotton crop have been mailed to farmers in Mills County. Any questions about the allotments should be taken up immediately with the county ASC committee.

Ballots and instructions for voting were mailed on November 29th to each eligible producer. The ballots may be returned to the ASCS county office in person-during the period December 2 through December 6. The law requires a favorable vote by at least two-thirds of the growers voting in order to keep marketing quotas in effect. Since a referendum on peanuts is also being held in the same county, growers are cauproper envelopes.

Generally, those eligible to vote are all producers who shared in the 1968 cotton crop or its proceeds. Questions about eligibility to vote should be referred to the county ASCS office.

If the vote is favorable, quotas will apply to the 1969 upland cotton crop, with penalties on any excess cotton produced; loans and price support pagments will be available to growers who plant within their allotment. Cocktail Clubs Proposed new rules for drinking clubs were shelled in public hearing by 11 bistro operators who urged different categories of regulations for a wide vari-

ety of establishments catering to the cocktail trade. Texas Liquor Control Board

took the issue under advisement and will hand down its ruling at an early date. Meanwhile, its proposed requirement that payment for mixed drinks be made in cash and strict definition of club "guests" remains

under court attack. Witnesses at hearing in the state capitol made these principal suggestions.

• That rules be geared to types of operations in 1,335 clubs over the state (344 of which are in dry areas). • That record-keeping re-

quirements be kept as simple as possible • That they be punished on-

ly for "knowing" violations.

"There are obviously several kinds of private clubs, all trying to operate under one broad definition. Comprehensive regulations might include clear-cut definitions of the various kinds or classes of clubs. This would, of course, involve a classification system" testified Royce Chaney of Dallas, representing the Texas Lone Star Chapter Club Managers Association of

America Other club operators suggested separation on lines of nonprofit and strictly - business clubs-or those which have relatively static membership and the rapid-turnover clubs such as those in motels and hotels.







WANTED BY THE FBI



JOHN WILLIAM CLOUSER

John William Clouser, a Florida mental hospital escapee, who has vowed not to be taken alive, is one of the FBI's "Ten Most Wanted Fugitives."

On the night of April 2, 1964, Clouser and three other inmates escaped from the Florida State Hospital in Chattahoochee and reportedly forced two hospital employees to drive them to the Columbus, Georgia, area. The hostages were robbed but released unharmed. A Federal warrant issued at Montgomery, Alabama, on April 9, 1964, charges Clouser with transporting a stolen car from Georgia to Alabama, where the stolen car was recovered abandone

A former police officer, Clouser was admitted to the Florida State Hospital in February, 1964, after being adjudged mentally insane. He was then facing numerous criminal charges and had earlier been convicted of participating in the robbery, kidnapping and beating of two theater managers. His conviction was appealed, however, due to a state error, and he was released and granted a new trial.

He is a white American, born at Chicago, Illinois, on March 29 1932. He is 5'9" tall, weighs from 165 to 180 pounds and has blond hair, blue eyes, a stocky build and ruddy complexion. He is tattooed with a panther on his right shoulder and a heart plerced with an arrow on his left shoulder.

He is described as a sadist who would not hesitate to beat a victim to death, is an expert pistol shot, exercises and lifts weights regularly and is proficient in Judo and Karate. Consider him extremely dangerous.
